IFTDO is the most multinational, multicultural Training and Development organization in the world with a truly diverse Board of Directors leading the organization. Our members form a highly diverse network of human resource management and development organizations globally, linking HR professionals in HR societies, corporations, universities, consultancies, government organizations and enterprises. IFTDO currently represents more than 500,000 professionals in over 30 countries.

IFTDO has an elected Executive Board, consisting of President, President Elect, Past President, Chair, Chair Elect, Treasurer and 14 members from different countries, and an Executive Secretary. One Board member acts as Representative to UN. IFTDO's vision is to be a unique and effective resource to the HRD profession working GLOBALLY for the betterment of life. IFTDO has as its fundamental and driving mission, to promote the concept of HRD as an effective tool, across all sectors of society, in order to increase personal and organizational effectiveness.

IFTDO has observer status with ECOSOC, United Nations.

IFTDO is a signatory to the Global Compact and fully committed to its objectives and principles and UN Sustainable Development Goals.

The activities of IFTDO are mainly in the field of human resources development which is the key to implementation of Global Compact programme by the companies. It is their human resources who have to be involved by companies in undertaking activities in furtherance of UN Goals. IFTDO's activities are related to Sustainable Goal 8;

Goal 8: Promote inclusive and sustainable economic growth, employment and decent work for all

For persons to have quality jobs, it is necessary that they possess requisite skills. Thus developing 'Skills for Employability' is an important area which will have a close bearing on achievement of this Goal. Similarly, training and development are needed at all levels for those employed as well as to be employed.

This is an area with which International Federation of Training and Development Organisations (IFTDO) is closely connected as it focuses on human resource development throughout the world.

The main activities of IFTDO during last 2 years have been as follows:

World Conferences:

47th IFTDO World Conference was successfully organised by Full Member, Dubai Police Academy at Dubai on March 20-22, 2018, on the Theme- 'The Future is Today- Creating Happiness at Work Place'. It was held under the patronage of H.H.Sheikh Hamdan Bin Mohammad Bin Rashid Al Maktoum, Crown Prince of Dubai. The grand Opening Ceremony of the Conference was held in Dubai Police Academy on March 20 at 7 pm, followed by a Gala Dinner. The Conference sessions were held at the Westin Hotel on 21st and 22nd from 9 am to 2 pm. There were 2 sessions on each day, with a total of 15 keynote speakers. In addition, 2 workshops were conducted. The IFTDO Global HRD Awards were presented on March 21, 476 delegates (including about 100 international) from 22 countries participated. The Exhibition had 16 booths.

The 48th IFTDO World Conference was organised by the Full Member Origin Group at Sarajevo, Bosnia & Herzegovina, on June 24-26, 2019 on the theme "Human Resource Development (HRD) in the Digital Transformation Era-Empowering Future Leaders". The theme was sub-divided into 4 elements, namely, Digitisation, Leadership, Talent Development and Creativity. There were 22 speakers of international standard and over 200 delegates from 35 countries. There were 10 Exhibitors stalls. On 23rd June, there was a Mayor's Reception and dinner at the City Hall for the Board Members and Speakers. On 24th June, there 3 parallel Workshops were held, followed by Opening Ceremony in the evening at 7 pm where IFTDO Awards were also given. A cultural evening and gala dinner were organised on June 25, for all delegates at a resort.

1. IFTDO Global HRD Awards:

- (i) IFTDO Global HRD Awards 2018- Awards were given in 2 categories: (1). Best HRD Practice, (2). Research Excellence. IFTDO received 29 entries from 12 countries, which were considered by an international Panel of Judges headed by Prof. Abdel Bari Durra (Jordan), with Dr. Helmi Sallam (Egypt), Dr Sunil Gupta (UAE) and Dr Rick Holden (UK) as members. Two entries got Category Winner awards and 12 received a Certificate of Merit. The Awards were presented on March 22, 2018 during the 47th IFTDO World Conference.
- (ii) IFTDO Global HRD Awards 2019- Awards were given in 2 Categories- 1 -Best HRD Practice Awards, and 2 - Research Excellence. 32 entries were received from 11 countries, The international Panel of Judges consisted of Prof Abdel Bari Durra (Jordan), Dr. Helmi Sallam (Egypt), Dr. Sunil Gupta (UAE), Dr. Rick Holden (U.K.) and Dr. Bart Tkaczyk (USA). 2 Entreis got Category winner awards and 13 received Certificate of Merit. The Awards were presented on June 25, 2019 during the 48th IFTDO World Conference.
- Publications: IFTDO has been publishing Newsletters every year. In addition, an International Journal of HRD Practice, Policy and Research has been published twice a year (jointly with University Forum of HRD, UK. Four issues were published during this period.
