ISIZIBA Community Based Organizations of South Africa guided by the United Nations Global Compact suggested activities, engaged the following “**Local businesses**” **ISUZU**, **Continental Tyres**, **VWSA**, and **FORD** Motor Company, from **Port Elizabeth** Nelson Mandela Bay Municipality **NMBM**, and unfortunately none of them bothered even to acknowledge such correspondence, or attempt to reply.

Prior the new dispensation of the **New Dawn, pre-1994**, the new democratic government of former President **Nelson Rolihlahla Mandela**, in **1984**, the then government feeling the pain of sanctions, and to please the international community, passed legislation for Previously Disadvantaged Individuals (**PDIs**) to allow them to register their own **Small Businesses**, established their own Small Businesses Development Corporation **SBDC** for financing and built business stalls for (**PDIs**).

The then South African “Business Machines” corporates formed a “**Business Equipment Association**” for skills transfer and business development for (**PDIs**).

We/I am/are the product of **SBDC** and “**Business Equipment Association**” through Chamdor-in-service-Training Centre, Luipaardsvlei, Krugersdorp, Gauteng, and an Electronic Technician for Cash Registers supply, installation and backup services.

In **1984/85** registered “**African Cash Registers CC**, in **1986** visited **Zimbabwe** Agricultural Show for Trade and Culture Mission Exchange, in **1987** established close cooperation with **Germany OMRON** Cash Registers for importing **OMRON** Cash Registers, and by **1991** was conducting business Consulting in **Namibia**.

ISIZIBA constituency continue to be invited by the local Global Compact Network South Africa, unfortunately because of the long distance difference between where we are from **Port Elizabeth** and **Johannesburg**, we have not been able to attend due to limited resources and lack of support for Civil Society thereof, from the poor area of **Port Elizabeth**, ravaged by poverty, resulting from high rate of unemployment.

We/I have encouraged, for proximity to Local Global Compact events and activities, to form local Metropolitan Global Compact Network Nelson Mandela Bay **NMB**, but unfortunately have not received any support for such an initiative.

ISIZIBA constituency has been proactive for the advancement of the local Global Compact Network in **Port Elizabeth, NMBM**, taken such initiative and engaged Global Compact Network Germany who in-turn sensitised the local Global Compact Network South Africa of the approach, and consequently received conversation call from the local office and advised to stop displaying Logo of local Global Compact Network South Africa on letter of our correspondence.

We/I continue to communicate and convince functionaries, either public and/or private for rights based programmes approach of complementary rights bearers' for Constitutional Public Participation to practice Public Diplomacy for Civil Society “Alliances” Outreach through Stakeholders Engagement Workshops, on International Agreement for Civil Society monitoring rule involvement.

We/I encourage the local Global Compact Network South Africa to take a lesson and learn to practice what local Global Compact Network China has done in establishing and working together in the strong relation established between China UN Resident Coordinator and the local Global Compact Network China, and desist the temptation of Colleague in one Agency and being a Board Member in another Agency and/or employee and simultaneously enjoy **NGO** Membership privileges.

We/I encourage the African Civil Society to take up centre stage in African parliaments, the same as enjoyed by **EU** Civil Society “Alliances” whose programmes are funded by the **EU**. The **EU** entered Economic Partnership Agreements **EPAs** between various African regions for sustainable development encourage and allow African Civil Society “Alliances” involvement on **EPAs** for **monitoring rule, participation, ownership, dialogue** and **accountability**.

ISIZIBA constituency joined **TOGETHER2030 NGO**, a global platform for effective and accountability on SDGs implementation; however, it is with regret to observe the unreceptive character of **South Africa NGOs** and African **NGOs** comparative to **NGOs** at grassroots level.

The **NGOs** activities' trend has become **Corporate NGOs** of High Level, politically connected and resourceful, recognized and preferred to the disadvantage of needy, undermined, and neglected **NGOs** at grassroots level.
