From May 2008 the Federation became a founding member of the Global Compact Network Hellas and is committed to integrating and promoting the 10 principles supported by that specific UN initiative which relate to human rights, workers' rights, environmental protection and methods for combating corruption.

The 10 principles we support are:-

Principle 1: Businesses should support and respect the protection of internationally proclaimed human rights

Principle 2: Businesses should make sure that they are not complicit in human rights abuses

Principle 3: Businesses should uphold the freedom of association and the effective recognition of the right to collective bargaining

Principle 4: Businesses should uphold the elimination of all forms of forced and compulsory labour

Principle 5: Businesses should uphold the effective abolition of child labour

Principle 6: Businesses should uphold the elimination of discrimination in respect of employment and occupation

Principle 7: Businesses should support a precautionary approach to environmental challenges

Principle 8: Businesses should undertake initiatives to promote greater environmental responsibility

Principle 9: Businesses should encourage the development and diffusion of environmentally friendly technologies

The Network of Social Solidarity and Assistance, known as "The Network" was founded in 2015 as a civil non-profit company. The Network was established in order to undertake actions supporting the needs of the society, and activities of Corporate Social Responsibility of its companies' members, with the mission of connecting the business community with organizations that provide social services, particularly to children and young people. Now, the Network supports more than 100 institutions and organizations.

The most important business organizations and federations in Thessaloniki joined forces and founded the Network. Those are: The Federation of Industries of Greece (SBE), the Thessaloniki Chamber of Commerce and Industry (EBETh), the Thessaloniki Chamber of Small and Medium Sized Industries (BETh), the Professional Chamber of Thessaloniki (EETh), the Greek Exporters Association (SEVE) and the Thessaloniki Traders' Association (ESTh).

The aims of the "Network"...

- To support individuals, groups, charities, organizations and other relevant bodies, by connecting them with the business community of Northern Greece.
- Promoting the connection between companies and socially-vulnerable groups.
- Promoting the concept of social awareness and responsibility, and social cohesion in our country.
- The Network mobilizes companies. It assesses, develops and promotes the tools for the implementation of the principles, both at national level and abroad.

The "Network" the period 2018-2019, amongst many other provided...

- The Network of Social Solidarity and Assistance and the participatory funding program Act4Greece are joining forces to meet the needs of soup kitchens in Thessaloniki and Northern Greece. The program will cover the needs of needy families in the greater Thessaloniki area and other cities in northern Greece.
- The Hellenic National Commission for UNESCO has announced that for 2018 the Network of Social Solidarity and Assistance as "best practice" for our country at the annual meeting of the UNESCO National Committees at the Organization's Headquarters in Paris.
- The Network cooperated with LIDL during Easter period, and through this action collected amount for the contribution to building small houses for the NGO "The Lighthouse of the World".
- > For Christmas and Easter holidays, food supplies were sent to various institutions.
- > Repairing and improving the buildings and facilities of several institutions.
- Were distributed among others items, computers, air conditioners, TV sets, DVDs, tablets, photocopiers, printers, washing machines, clothes dryers, dishwashers, ovens, fridges,



vacuum cleaners, ironing systems, physiotherapy layers, dollhouse and puppet theater, interactive paintings etc.

- The Network offer to General Hospital G.Papapnikolaou for the Department of Hematology Clinic «STORGI» with isothermal boxes, trolley with silicone handles to ensure the proper of food transport conditions for people suffering from benign hematological diseases
- The Network and TIF HELEXPO SA the National Exhibition Agency, had a great collaboration. They gave the opportunity to the children of the institutions of Northern Greece to participate to the theme park "Dinosaurs"
- The Network and the Trans Adriatic Pipeline, still have a great collaboration. They distributed among others items: 2 vehicles washing machines in the Municipalities of N. Zichni and N. Heraklion, special equipment for Sismanoglio Hospital of Komotini, a permanent access ramp SEATRAC, an ambulance to Kilkis Hospital etc.
