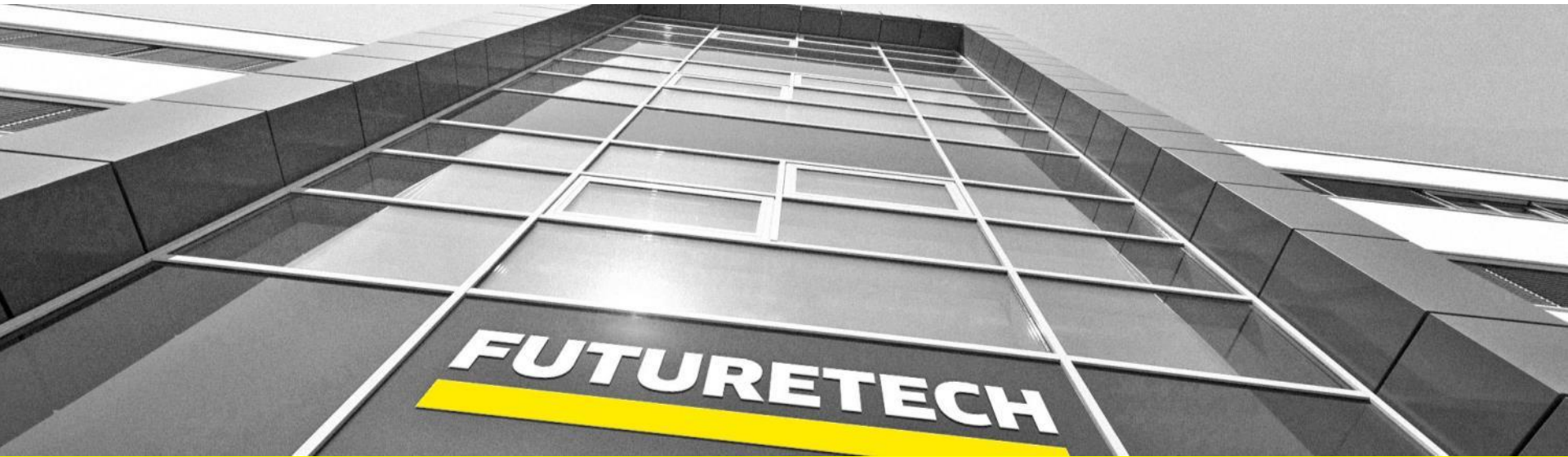

UN GLOBAL COMPACT'S PRINCIPLES

HUMAN RIGHTS

1. Businesses should support and respect the protection of internationally proclaimed human rights; and
2. Make sure they are not complicit in human rights abuses.

LABOUR

3. Businesses should uphold the freedom of association and the effective recognition of the right to collective bargaining;
4. The elimination of all forms of forced and compulsory labour;
5. The effective abolition of child labour; and
6. The elimination of discrimination in respect of employment and occupation.

ENVIRONMENT

7. Businesses should support a precautionary approach to environmental challenges;
8. Undertake initiatives to promote greater environmental responsibility; and
9. Encourage the development and diffusion of environmentally friendly technologies.

ANTI-CORRUPTION

10. Businesses should work against corruption in all its forms, including extortion and bribery.

Human Rights

- Review of the current Kärcher Futuretech Code of Conduct, modification if necessary, if so, information of public about the new version.
- Repeated information of staff how to report potential violations of human rights.
- Detailed Integrity Guideline of Kärcher Futuretech established and informed to staff.
- Guideline for the selection of sales partners established, also considering compliance aspects.



MEASUREMENT OF OUTCOMES

Human Rights

- Kärcher Futuretech's published Code of Conduct and Integrity Guideline always represents the latest findings and positions.
- Any potential violations of human rights experienced by the staff of Kärcher Futuretech can be reported and will be investigated thoroughly.
- A compliant behavior is mandatory for all sales partners.

Labour

- Continuous implementation of the Kärcher Futuretech Code of Ethics.
- The renewal of the certification “Beruf und Familie” (“Work and family”) for Kärcher Futuretech has been granted.



MEASUREMENT OF OUTCOMES

Labour

- Kärcher Futuretech do not tolerates any discrimination based on sex, age, race, nationality, disability, social origin or sexual leanings. Kärcher Futuretech advocates equal opportunity.
- Kärcher Fututech comdemns forced labour and physical punishment, threat and harassmt of employees.
- Condemnation of child labour and compliance with the statutory regulations pertaining to the minimum age of employees.
- Kärcher Futuretech is certified „Beruf und Familie“.

ACTIONS & MEASUREMENTS

DESCRIPTION OF ACTIONS & RELEVANT POLICIES

Environment

- Renewal of the ISO 14001 and ISO 50001 certification.
- Definition of environmental goals:
 - Setting up a new hazardous substances warehouse and adapting the hazardous substances register
 - Preparation of "Documentation of the Separate Collection Obligation for the Year 2019" for Kärcher Futuretech
 - Reduction of stock quantities of chemicals in the plant and production-related quantity ordering
 - Labelling of all new KFT systems and devices with energy consumption data
 - Development of ecofriendly products
 - EU regulations such as REACH or ROHS are taken into account while selecting parts and components
- Environmentally relevant norms are regularly reviewed.



MEASUREMENT OF OUTCOMES

Environment

- Kärcher Futuretech is among others ISO 14001 and ISO 50001 certified.
- The 2019 environmental goals have been achieved.
 - Documentation of the separate collection obligation according to the Commercial Waste Ordinance
 - Reduction of internal transport routes in relation to the number of goods movements (new small parts warehouse)
 - Increase of circulation water quantity and reduction of fresh water consumption
- Materials are choosed and used in an ecofriendly way.

Anti-Corruption

- The existing process to check the due diligence of our sales partners is repeatedly trained and strictly followed.
- Clearance of suppliers of Kärcher Futuretech is only possible after due diligence check and written confirmation by the suppliers to adhere to the Kärcher Code of Conduct.
- Detailed Integrity Guideline of Kärcher Futuretech established and informed to staff.
- Guideline for the selection of sales partners established, considering compliance aspects.



MEASUREMENT OF OUTCOMES

Anti-Corruption

- All sales partners have accepted the compliance standards of Kärcher Futuretech, including our anti-corruption policy.
- New sales partners are selected on the principles of the respective guideline.
- All suppliers of Kärcher Futuretech have accepted the Code of Conduct, including our anti-corruption policy.
- The staff of Kärcher Futuretech is sensitized and strictly follows the published guideline.
