#### Part II. Description of Actions.

2017 our NCOs joined the UN Global compact and actively proclaims at all sites participation the concept of Human Rights and the basic right to life. We actively work to ensure these rights and the observance of international legislation.

Every day, we identify children in need of care, involved in crime, gangs, communities containing depressive content, is dangerous for mental health of minors. We pass in the state structure information about the children involved in groups that promote racial hatred, fascism, suicide, ethnic strife and criminal way of life. We are making this information known to parents, who can resolve the issues on provision of the necessary assistance, free advice.

We do a lot of active work, participating in scientific conferences, workshops, draft laws in the Public Chamber of Russia, make their suggestions, make constructive criticism, conduct scientific and practical activities. Work with parents and teachers in schools and educational organizations.

We advise people and actively defend individual rights in the areas of: the right to life;

- the right to dignity;
- the right to safety;
- the right to liberty and security of person;
- the right to inviolability of private life, personal and family secret, protection of honour and good name;
- the right to privacy of correspondence, telephone conversations, postal, Telegraph and other messages;
- the right to become acquainted with documents and materials directly affecting his rights and freedoms;
- the right to inviolability of the home;
- the right to move freely and choose their place of residence;
- freedom of conscience and religion;
- freedom of thought and expression;
- the right to information.

#### Political rights:

- the right to information;
- the right to participate in managing state Affairs;
- right of appeals to state bodies.

#### Economic rights:

- freedom of labor, right to work in conditions meeting the requirements of safety and hygiene.

#### Social rights:

- the right to rest;
- the right to motherhood, childhood and fatherhood;
- the right to social security;
- the right to health protection and medical care;
- the right to favorable environment;
- the right to education.

#### Cultural rights:

- freedom of creativity and of teaching;
- the right to participate in cultural life; to use cultural institutions.

#### Part III. Measurement of Outcomes.

Our organization is an active fighter for human rights. At events we refer directly to the documents of the United Nations in the field of protection of human rights. We provide advice and assistance in the investigation of criminal cases for the dead children, advise the parents, in cases of involvement of state structures in private and personal life. During this period, we helped with those consultations and preparation of documents for the dead children in 63 cases. In cases of interference in the private lives of citizens, we have participated in resolving more than the 122 incidents.

Here are the most striking examples of our work in the field of protection of human rights (a detailed report by years on our site:

In October of 2018 we asked the school psychologist stating that seventeen-year-old schoolboy in Ryazan expresses the intention to die, and there is self-damaging behavior, the child cut his throat, and the school administration tries to hide this fact, accusing the parents. With our timely intervention the child was given psychiatric help. We helped the mother to write a letter to the investigation Committee. We got in touch with doctors of child psychiatry, organized the provision of child care. Teachers began to pursue a school principal to demand that she quit. We consulted the teacher, helped to prepare an appeal to the Prosecutor's office Supervisory Department for the observance of labor legislation. We appealed to the Ministry of education of the Ryazan region, the Commissioner for human rights in Ryazan region. We were invited to a meeting of all principals of the region where we talked about the danger of failure of timely action. At our insistence, the school conducted was the conversation about the inadmissibility of persecution of a teacher for her honesty. We turned to the media, drew attention to this situation. The result of our work: the child is alive and healthy, the parents of the child received the necessary assistance and advice, the teacher is, he is not prevented from carrying out his activities, the harassment and the bullying stopped. https://progorod62.ru/news/12790



November 20, 2018, on world children's day, the day of the adoption of the "Declaration of the rights of the child and Convention on the rights of the child", in the framework of the all-Russian action "Day of legal assistance to children" our organization initiated the seminar "Ensuring the safety of children, adolescents and young people in the online space." We appealed to the Commissioner for human rights in Ryazan N. Epyhina a proposal to hold this seminar. In the seminar held at the Academy of Federal service of execution of punishment participated by more than 300 people, of which 168 persons were directors of schools. S. Pestov made a report "The Digital world and the right to childhood", in which special attention is paid to children's rights and human rights.



18 April 2019 at the meeting of the "Bureau on coordination of fight against organized crime and other dangerous types of crimes on the territory of States – participants of the Commonwealth of Independent States" with the participation of

representatives of the Ministries of internal Affairs (police) of the States of Belarus, Kazakhstan, Azerbaijan, Armenia, Kyrgyzstan, Moldova, Tajikistan, Turkmenistan, to Moscow, at the University of the interior Ministry in its report on the state of cybercrime against children S. Pestov paid special attention to the compliance with power structures, Human Rights, international legal acts. Gave examples of articles of the Constitution, requiring law enforcement officers to respect human rights in all countries, the participants of the conference.
