As C@rma, we have started really looking at the Sustainable Development Goals since 2017.

- C@rma is part of the <u>Global Pro Bono network</u> which is one of the signatories of the <u>Impact2030 initiative</u>, aiming at promoting Pro Bono to support the SDG
- We have participated in a couple of initiatives led by the Global Compact Turkish Local network
- One of our activities is to gather together corporate professionals once every quarter
 and feature 6 Turkish Civil Organisations. That enables them to understand better the
 ecosystem of civil society in Turkey and to create dialogue between these two actors of
 the society. In March 2018, we featured UN Global Compact Turkiye, represented by xxx.
 She explained the Sustainable Development Goals and the role of UNGC to a crowd of
 20-50 participants participants.



• Another activity we have is to gather 20-30 senior executives of large companies (Board members, CEO) twice a year for an exclusive breakfast. We feature one very large NGO and one corporate firm explaining their Corporate Social Responsibility. In May 2018, Mustafa Seçkin, at that time chairman of UN Global Compact in Turkey, came to explain the Sustainable Development Goals and the role of UN Global Compact to around 30 CEO and Board members. They were very interested and some of them were not aware of the SD goals.

- In Jan 2019, Carma received funding under the EU Facility for Refugees in Turkey to support 50 disadvantaged women (Turkish and Syrian) to set up and run successfully a cooperative in the food sector in Istanbul. The cooperative will provide innovative, healthy and affordable food products and meals, produced sustainably while practicing social cooperative economics with and for women. This is a clear example of our support to SDG 8 decent work and economic growth.
- In July 2019, we (EKIP team) were one of the 20 initiatives that were entitled to
 participate in the three days Imece Support Program Bootcamp, which was the 3rd
 Support Program organized by imece within the scope of Reducing Inequalities. Imece, is
 a social innovation platform which brings people and institutions which lead the change
 together by generating innovative and sustainable solutions for social, ecological and
 cultural matters with the right resources. Their main focus was on SDG.



 We encouraged the Turkish Company Bebemoss (Sector 7 - Iza Ersahin) to register for the UN Global Compact. Since then, she has also regularly participated in activities from the network.
