1. <u>Legal Status & Registration</u>

In early 2014, IDCO was re-registered as a center of strategic studies, researches and development by the Palestinian Ministry of Information in Ramallah under license number 21/148/MA, with its mission to stimulate community's improvement and development as one of the most outstanding careers serving generations and their resources.

2. Background & Brief History

The idea of Improvement and Development for Communities Center (IDCO) was born in 2004 when an independent group of experts have decided to work together to provide an integrated solutions, studies and consultancies solving challenges facing the Palestinian communities and responding to their needs. They have been initiated as a civil society organization.

Working on the facts that "practice preceded theory" and "people have the right to participate in decisions that have an effect upon their well-being", IDCO has adopted a developmental framework taking into consideration, the variety in communities, the variety in needs and the variations in circumstances from place to place and time to time.

IDCO as an active participant in the United Nations Global Compact (UNGC) is working to generalize and achieve the principles of this compact through its programs and interventions.





3. Mission Statement

"Developed and pioneer communities with high capability to invest the human and natural resources in order to achieve sustainability"

Working on the vision, IDCO philosophy is adopting a multidevelopmental programs aiming at contribute in solving the community's challenges, especially, the challenges related to community development, sustainability, food security, health, advocacy and environment conservation. IDCO will seek to achieve these programs through the implementation of consultancies, studies, researches, activities and projects as well as to stimulate positive community's initiatives.

Actually, we in IDCO are prioritizing its interventions and projects for the 2017-2019 into four main categories (programs) which form the IDCO's endorsed strategy as follow:

- 1. Contribute to the promotion of community reconciliation and unity.
- 2. Strengthen capacities of the developmental sectors.
- 3. Effective participation in the community development issues specially for women and Youth.
- 4. Support the IDCO's Sustainable Role and Impacts.

4. Organizational Structure & Administrative Manuals:

IDCO is overseen by board of directors (executive board) consisting of 5 individuals from different backgrounds and expertise (2 females and 3 males); all are leaders in their field with success in the development and studies aspects as well as environment, health, education, development, and social responsibility sectors.

The IDCO staff consisting of 7 individuals (4 females & 3 Males), is formulated to give a complementary taskforce and activities; the group is capable to implement the selected topics in cooperation and using the resources and equipment of many other same-scope institutions in term of partnership and networking.

Furthermore IDCO's staff are capable to monitor, execute, and supervise various studies and projects with all different nature.

On the other hand, IDCO is using an auditing and standard financial systems and clear accounting policies. All IDCO's accounts are audited annually by external auditors which submitted to the concern bodies and authorities.

Furthermore and along the last five years, partnerships and letters of agreements have been signed with a lot of international donors to implement and perform successfully distinguished studies, researches, interventions and projects included capacity building, economic empowerment, families support programs and income generating projects, agricultural and water infrastructures schemes as well as community training.
