Trustees Report - Objectives, Activities and Performance

The Trustees present their report and accounts for the year ended 30th April, 2019. The accounts have been prepared in accordance with the accounting policies. The report takes account of the requirement for Trustees to report annually on public benefit and the Trustees have had regard to the objects of Sri Joydip Ashram Trust set out in Clause 6 of Sri Joydip Ashram Trust Deed in accordance to Indian Trust Act 1882.

Structure, Governance and Management

The Trust ("the Charity") is an unincorporated trust, constituted under a Trust Deed dated 27th March, 2012. The Charity was established by an initial gift from Sri Joydip ("the Settlor") in 2012. The Charity still does not actively fundraise and seeks to continue the philanthropic work desired by the Settlor, through the careful stewardship of its existing intellectual and educational resources and ad hoc contributions.

Appointment of Trustees

The Trustees are appointed by the Settlor, for a one year period by an appointment deed. Based on the performance, the period is extended further.

Legal Status

Sri Joydip Ashram is a Public Charitable and Educational Trust, which operates under Indian Trust Law, 1882.

Objects of the Trust


Education




