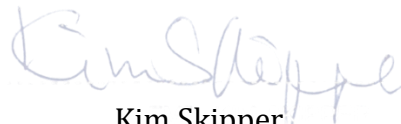

The purpose is to provide self-help to fight hunger, create jobs and strengthen equality through projects in Africa, Asia and South America.

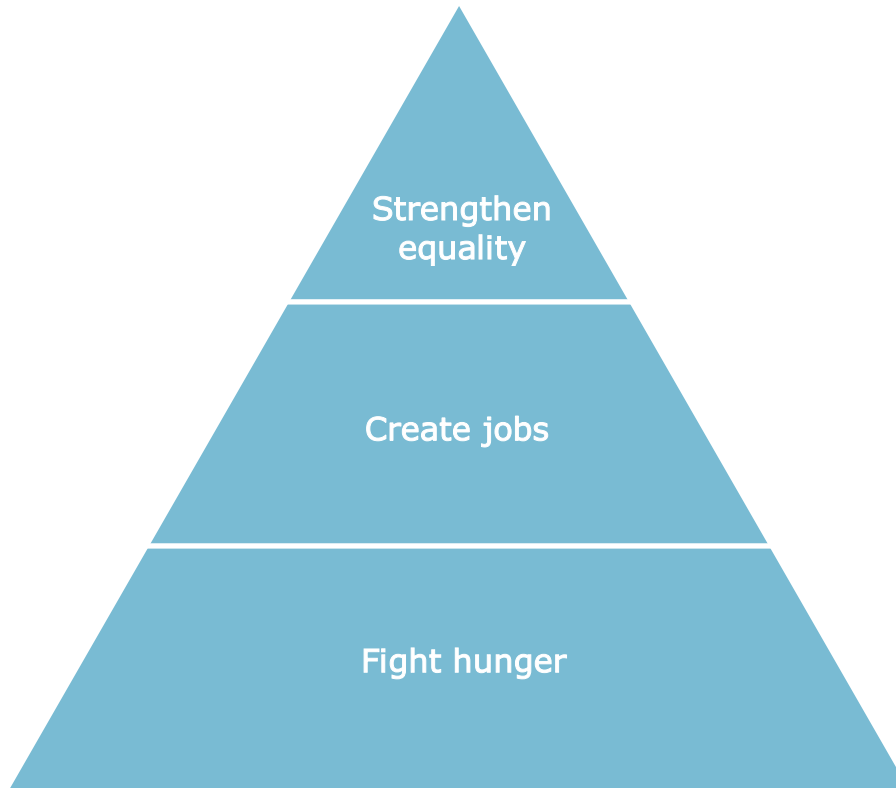
Distribution of projects 2018-2020:

PRINCIPLES	THE 9 EFFORTS (TAKEN BETWEEN 2018-2020)
HUMAN RIGHTS	<ol style="list-style-type: none"> 1. GLOBAL SUPPORTERS acknowledge the European Convention on Human Rights (EMRK) that is also incorporated in Danish law. 2. Our business partners must comply with international humanitarian laws and the highest ethical standards. 3. GLOBAL SUPPORTERS signed the UN Global Compact: “An Open Letter to Academic Institutions Educate Future Managers and Leaders on Business and Human Rights”.
LABOUR	<ol style="list-style-type: none"> 4. GLOBAL SUPPORTERS promote the elimination of forced labour, child labour and employment discrimination through written rules of ethics using the principle of “negative screening”. 5. During our financial assistance our business partners must be in conformity with our standards.
ENVIRONMENTAL	<ol style="list-style-type: none"> 6. GLOBAL SUPPORTERS are office based and have minimal environmental impact.

	<p>7. Our policy is not to provide financial support to borrowers dealing with animal experiments, fur industry, factory farming, excessive CO2 emissions etc.</p>
