#### **Human Rights**

- Update of Kärcher Futuretech Code of Conduct, harmonized with the Code of Conduct of Alfred Kärcher SE & Co. KG. Information of public about the new version.
- Repeated information of staff how to report potential violations of human rights.
- Detailed Integrity Guideline of Kärcher Futuretech established and informed to staff.
- Guideline for the selection of sales partners established, also considering compliance aspects.

## **MEASUREMENT OF OUTCOMES**

#### **Human Rights**

- Kärcher Futuretech's published Code of Conduct and Integrity Guideline always represent the latest findings and positions.
- Any potential violations of human rights experienced by the staff of Kärcher Futuretech can be reported and will be investigated thoroughly.
- A compliant behavior is mandatory for all sales partners.



## DESCRIPTION OF ACTIONS & RELEVANT POLICIES

#### Labour

- Continuous implementation of the Kärcher Futuretech Code of Ethics.
- The renewal of the certification "Beruf und Familie" ("Work and familiy") for Kärcher Futuretech has been granted.

## **MEASUREMENT OF OUTCOMES**

#### Labour

- Kärcher Futuretech do not tolerates any discrimination based on sex, age, race, nationality, disability, social origin or sexual leanings. Kärcher Futuretech advocates equal opportunity.
- Kärcher Fututech comdemns forced labour and physical punishment, threat and harassment of employees.
- Condemnation of child labour and compliance with the statutory regulations pertaining to the minimum age of employees.
- · Kärcher Futuretech is certified "Beruf und Familie".

## DESCRIPTION OF ACTIONS & RELEVANT POLICIES

#### Environment

- Kärcher Futuretech is still certified in accordance to ISO 14001
  and ISO 50001
- Definition of environmental goals 2021:
  - Documentation of the Separate Collection Obligation for the Year 2020 for Kärcher Futuretech completed
  - Development of a hot water module for lower requirements (40 kW; HWM 40). Supplying water consumers such as laundry or sanitary facilities with heated water, which reduces the CO2 footprint enormously on the basis of high efficiency.
  - Preparation of the requirements RoHS, REACH and WEEE for Kärcher Futuretech. Critical components are identified and substituted as far as possible. If necessary, the EC declarations of conformity are adapted.
- · Environmentally relevant norms are regularly reviewed.

## **MEASUREMENT OF OUTCOMES**

#### Environment

- Kärcher Futuretech is among others ISO 14001 and ISO 50001 certified.
- The 2020 environmental goals have been achieved.
  - Setting up a new hazardous substances warehouse and adapting the hazardous substances register
  - Preparation of "Documentation of the Separate Collection Obligation for the Year 2019" for Kärcher Futuretech
  - Reduction of stock quantities of chemicals in the plant and productionrelated quantity ordering
  - Labelling of all new KFT systems and devices with energy consumption data where necessary
- Materials are chosed and used in an ecofriendly way.



## DESCRIPTION OF ACTIONS & RELEVANT POLICIES

#### **Anti-Corruption**

- The existing process to check the due diligence of our sales partners is repeatedly trained and strictly followed.
- Clearance of suppliers of Kärcher Futuretech is only possible after due diligence check and written confirmation by the suppliers to adhere to the Kärcher Code of Conduct.
- Detailed Integrity Guideline of Kärcher Futuretech established and informed to staff.
- Guideline for the selection of sales partners established, considering compliance aspects.

## **MEASUREMENT OF OUTCOMES**

#### **Anti-Corruption**

- All sales partners have accepted the compliance standards of Kärcher Futuretech, including our anticorruption policy.
- New sales partners are selected on the principles of the respective guideline.
- All suppliers of Kärcher Futuretech have accepted the Code of Conduct, including our anti-corruption policy.
- The staff of Kärcher Futuretech is sensitized and strictly follows the published guideline.
