Since 2006, permission has been granted in different manifestations for the FPCD to use the "We Support" Logo on its website. Where possible the same logo is used in electronic newsletters, and annual reports, showing the FPCD's commitment to the ten principles. ### **Engagement with Global Compact Networks and Future Actions**

The FPCD is officially "Associated" with the United Nations Department of Public Information and therefore has opportunities to participate with Global Compact Networks at the United Nations and New York area. The FPCD will continue in the same fashion in the next biennium and will endeavor to participate actively, provide commentary to companies on Communications on Progress and continue to incorporate the Global Compact Principles in its sphere of influence. Future actions include a Midwife Capacity Building Programme at the Princess Grace Hospital in Monaco, a new Maternity Clinic to be constructed in a post conflict country and the establishment of the On-line Institute of Post Conflict Development. In this vein, the FPCD will be sure to advocate for the UN Global Compact through its sustainable development projects and social media platforms.

### **Reaffirmation of Commitment**

The FPCD would like to make this public disclosure to reaffirm its steadfast support to the Global Compact and its commitment to the ten principles in the areas of human rights, labour, the environment and anti-corruption.
