

# The challenge of evolving and creating opportunities

hroughout its 57 years of existence, APAE DE SÃO PAULO has been seeking to evolve its training, to learn more and more about intellectual disability and to propose the inclusion of people with intellectual disabilities in a more effective and adequate way.

In a globalized world, but with localized problems and characteristics, we are confronted daily with paradoxes that promote constant reflection on our vocation and our role in society.

There is before us the desire and constant search for the total inclusion of people with intellectual disabilities. By applying increasingly effective processes and techniques, we seek the transformation of environments so that they become more and more welcoming and aware of the cause. We constantly update our technological and technical capabilities to provide preventive and accurate diagnoses in the shortest time possible. We adopt best market practices, both for governance and administrative effectiveness. We exchanged information with centers of excellence in dealing with intellectual disabilities, seeking to minimize our eventual evolutionary delays.

However, society insists on not realizing the importance of the matter. In an extremely difficult year for all Brazilians, the nation faced weaknesses, shortcomings and the urgent need for transformation. Despite all this reflection, the matter of intellectual disability remains relegated to the background.

It is necessary to understand that our development as a nation and as a society that applies for the future goes through the attention and understanding of people with some kind of disability.

The statistics mask a harsh reality. As a reflection of society, the matter is relegated to non-priority plans. Individuals do not realize that a significant part of our people, whether by social, genetic or organic development, suffers from some level of intellectual deficit, which ends up suppressing their development and, indirectly, affecting the development of the country. They do not perceive, with a closer look, that the understanding of differences improves us.

The year 2018 was complicated. In the APAE DE SÃO PAULO, we live an unsatisfactory financial result. This has made us rethink the reasons why we are providing to society the services we provide. This made us, as well as all Brazilians, face our weaknesses, shortcomings and the need for transformation.

And the conclusion of these difficulties and reflections is that we will move on, evolving, transforming ourselves in order to do more and better, creating a stir and new opportunities so that we can have the future we want.

We may have to, like the caterpillar, evolve and abandon the cocoon so that we can fulfill our full potential. So let's continue with the courage and boldness that the challenges imposed deserve.

# Corporate Governance: our commitment to include

acing the scenario of uncertainties we still experience, with economic and political crises, allegations of corruption and a certain disregard for the principles of diversity, we continue to reaffirm our commitment to the social inclusion of people with disabilities in all social spheres.

The challenges are great, and our Organization follows its path aligned with the Convention on the Rights for People with Disabilities, promulgated by the UN and attentive to the best practices of social inclusion, always based on the good principles of corporate governance.

In light of this concept, we created the Compliance Program in 2018, with the objective of ensuring that all processes and methodologies follow the guidelines of the Organization's Code of Conduct, always emphasizing ethics and transparency in all operations and accountability to society, in accordance with the Anti-Corruption Law. The Program, which involves all administrators, associates, volunteers and partners of APAE DE SÃO PAULO, acts strongly in the defense of good management practices, ethics and transparency of actions.

Seeking to promote a more efficient management and to reaffirm its position of reference in good practices of governance, the Organization made some strategic changes in its structure, revising the bodies that make up the organizational structure, having in 2018 a general superintendence, an operations superintendence and an even more strategic board of directors, extinguishing voluntary board positions.

The decision was also made based on a study carried out by Fundação Dom Cabral, which pointed out the need for an administrative model more modern, dynamic and aligned with current needs. The expectation is to increase the presence and impact of APAE DE SÃO PAULO's work in society, through more agile and effective processes, and to guarantee effective support to people with intellectual disabilities in the city of São Paulo.

APAE DE SÃO PAULO also reiterates its support for the United Nations Global Compact, which aims to promote the sustainability of corporations in the areas of Human Rights, Labor, Environment and Anti-Corruption, having as one of its pillars the Defense and Ensuring Rights, which actions are promoted by the Center for Public Policy & Advocacy and the Articulation and Mobilization Program, with the aim of defending the human rights protection regarding people with disabilities, recognized internationally, and to fight for the non-violation of these rights.

The social inclusion of people with intellectual disabilities is fundamental for a fairer society with more opportunities for all. To this end, rights must be preserved and laws must be enforced in all public, private, and Voluntary Sector spheres.

APAE DE SÃO PAULO reaffirms its strong commitment to the inclusion of people with intellectual disabilities. Improving management and services is part of the process of promoting inclusiveness and equality for all. With good management practices, a lot of commitment and the crucial support of society, it is possible to do more and better.

# **Our Scope**

Facilitating the access of people with intellectual disabilities and their families to our services is a concern for APAE DE SÃO PAULO.

Therefore, we offer assistance in several units in the city of São Paulo, guaranteeing better quality of life and access with security. Since 2017, our Aging Service has been transferred to the Vila Clementino Unit, and integrated to the Socioeducation and Educational services. The union of these three services, in the same physical space, made possible an intergenerational interaction, through a perspective of integration of all the professionals involved, as well as the transfer of the Qualification and Professional Inclusion Service to the Itaim region, which facilitated contact






# **Public Assistance Service**

Aimed at assisting people who attend APAE DE SÃO PAULO or seek for the first time the services of the Organization, the professionals who work in the SAP -**Public Assistance Service are responsible for welcoming** new users and also for maintaining the relationship.

Orientation to families, scheduling of appointments and therapies and recording declarations, such as compliments and complaints, are the activities of this area with regard to the facilities offered to people with intellectual disabilities.

The area also assists the space for the Toy Library in the Vila Clementino Unit, which received 8,959 children in 2018.

The biggest challenge of SAP is to offer an increasingly humanized service, reducing waiting time and offering solutions that are more assertive. By 2018, customer contact channels were diversified and SAP began to provide assistance through WhatsApp and Chatbot.\* Customer satisfaction is also a constant concern. Therefore, periodic satisfaction surveys are conducted in order to seek resolutions and thus maintain continuous improvement.



### Health

APAE DE SÃO PAULO is a reference in the Neonatal Heel Prick Test in Brazil. Pioneer in the test, the Organization has the largest laboratory in Latin America, capable of detecting up to 50 diseases.

#### Laboratory

APAE DE SÃO PAULO implemented the Neonatal Heel Prick Test in Brazil in 1976 and, since 2001, it is a Reference Service in Neonatal Screening (SRTN) accredited by the Ministry of Health. Currently, it is responsible for conducting the examination of 80% of the babies born in the state capital and 67% of the newborns of the State of São Paulo, through the Brazilian Unified Health System (SUS) and private maternities and hospitals.

The Organization's Laboratory is the largest in Latin America in terms of the number

of tests carried out and, since its implementation, has screened more than 16 million Brazilian children.

The Organization has always worked for the development and mandatory testing in the Country. Supported by the 1988 Constitution, the test became compulsory and free throughout the national territory in 1992. In 2001, with the support and influence of APAE DE SÃO PAULO, the Ministry of Health instituted the National Neonatal Screening Program (PNTN).

#### **TESTS OFFERED**

#### **BASIC Neonatal Heel Prick Test**

It is mandatory and free across the country. In the State of São Paulo, it identifies six diseases: Phenylketonuria, Congenital Hypothyroidism, Cystic Fibrosis, Sickle Cell Anemia and other Hemoglobinopathies, Congenital Adrenal Hyperplasia and Biotinidase Deficiency.

#### **SUPER Neonatal Heel Prick Test**

It is the only one to screen 48 diseases and one of the most complete Neonatal Screening tests in the world. It includes in its panel, in addition to the ten diseases identified in the Basic Neonatal Heel Prick Test and MORE, another 38 diagnoses performed by means of the advanced technology of Mass Spectrometry in Tandem - MS/MS.

#### **Neonatal Heel Prick for SCID and AGAMA**

Detects a group of serious genetic diseases in which there is no production of T and/or B defense cells or protective antibodies. The test may be performed together with any of the above tests or at the discretion of the physician.

#### **Active Search**


The Laboratory has an Active Search system, which carries out the immediate call of all newborns who present alterations in the Neonatal Heel Prick Test. If resampling is requested, it is essential to do it immediately.

#### Neonatal Screening Outpatient Clinic

APAE DE SÃO PAULO also has the Neonatal Screening Outpatients Clinic with an interdisciplinary team to advise and treat the alteration cases of the Neonatal Heel Prick test, made up of specialists in the areas of Pediatric Endocrinology, Hematology, Nutrition, Psychology and Social Work.



#### **Divina Dieta**



With the mission of improving the quality of life of people with metabolic diseases and preventing the intellectual disability, APAE DE SÃO PAULO created Divina Dieta, a line of low-phenylalanine food products and other aminoacids, free from gluten, milk, eggs and products of animal origin.

The products are recommended for people with phenylketonuria, homocystinuria, leucinosis, isovaleric acidemia, propionic acidemia, methylmalonic acidemia and urea cycle defects. If these diseases are not treated properly, they can lead to intellectual disability. People with lactose intolerance, allergy to cow's milk protein, celiac disease, vegetarians and vegans also benefit from these foods.










#### **PRODUCTION VOLUME**

#### **Special Food Basket**

By means of sponsorship of the Special Food Basket, APAE DE SÃO PAULO assists patients from families in social vulnerability and people with special dietary needs. Private and legal persons can sponsor baskets with products for monthly consumption, thus avoiding the development of intellectual disability for cases diagnosed with phenylketonuria in the Neonatal Heel Prick Teste.



#### **Diagnosis Outpatient Clinic**

Often, intellectual disability is not directly linked to genetic issues or to inborn errors of metabolism, it is also due to socioenvironmental factors such as childbirth anoxia, malnutrition, excessive use of alcohol and drugs during pregnancy, among others. For these cases, APAE DE SÃO PAULO has a Diagnosis Outpatient Clinic of intellectual disability, composed of a multi and interdisciplinary team of Health, in the areas of neuropediatrics, genetics, psychiatry, neuropsychology and social welfare.


#### **GENETIC ADVICE**

Genetic Counseling for patients and their families is also part of the services of the Diagnosis Outpatient Clinic.

During the appointment, the possible consequences associated with a genetic disease are informed.



#### **Stimulation and Habilitation**

The services provided by the Organization to people with disabilities begin in early childhood when children do not reach the milestones expected from child development. In these situations, the Stimulation and Habilitation Service of APAE DE SÃO PAULO aims to promote the overall development of the child with a confirmed hypothesis or diagnosis of neuropsychomotor development delay, intellectual disability, genetic syndromes and preventive care for the newborn at risk. The activities are performed by a multi and interdisciplinary team of speech therapists, physiotherapists, occupational therapists, psychologists and social workers, with the presence and active participation of the parents.

#### News Moment Program

With more than 30 years of existence, it was developed to provide psychological care and give first support to parents or pregnant women who have just received news of the suspected or confirmed diagnosis. The program aims to humanize the moment of the news, welcome the parents in their elaboration process, in order to build a healthy family bond. Thus, giving the conditions for the family to become effective agent in the development and social inclusion of the child.

# Private Service and Health Operators

With an interdisciplinary medical team capable of identifying and streamlining the diagnostic process and orienting family members, the Organization offers the clients various services such as consultations, neuropsychological, functional, psychopedagogical and therapeutic evaluations.















APAE DE SÃO PAULO counts on medical appointments in Genetics, Genetic Counseling, Neurology, Endocrinology and Psychiatry, aimed at patients up to 17 years and 11 months, except Genetics, which has no age limit. Regarding therapies, there are options in the areas of Phonoaudiology, Physiotherapy, Occupational Therapy, Psychology and Hydrotherapy, for children and young public up to 14 years. The aim is to provide preventive and rehabilitative care, with a focus on global development.

Comprehensive Neuropsychological, Psychodiagnostic of Intellectual Function and Learning Disorder assessments are also available for patients up to 17 years and 11 months. The main objective is to investigate functions such as attention, language, perception, memory, motor functions in people with complaints of cognitive and behavioral changes. The assessments help in understanding the impact of changes in the functioning of the individual and enable the professional to indicate the treatment more appropriate to each case.

#### HIGHLIGHTS OF THE YEAR

We expanded the service to the private market, totaling more agreements with renowned health care providers for consultations and therapies.



### **Inclusion**

A strategic pillar of the Organization regarding support for the inclusion of people with intellectual disabilities in society. The Inclusion services work directly with the schools of the regular education system, in the labor market, in cultural and sports activities, as well as maintain the functionalities of people with disabilities in the process of aging.




Accompanying the life cycle of the person with intellectual disability, one of the supports offered by APAE DE SÃO PAULO is the Specialized Educational Assistance (AEE), which offers support to the student from 04 to 17 years old, with the objective of breaking down barriers in the teaching and learning process, through accessible resources and strategies, enhancing the conditions for continuity of studies in other levels of education.

The assistance of the AEE is carried out in rooms properly equipped with teaching materials, technological resources and games. The set of activities is developed through projects, as we believe this is a way to organize teaching and learning activities in a meaningful way.

#### **SENSORY INTEGRATION ROOM**

We offer care to children from 02 to 12 years old, with the objective of promoting, through the intervention of Sensory Integration, better development of the person with intellectual disability and/or TEA (Autism Spectrum Disorder), performing the work with sensory stimulation resources, so that the child can acquire autonomy and thereby improve their quality of life.



#### **PSYCHOPEDAGOGY ASSISTANCE**

The psychopedagogical assistance serves students from 04 to 17 years old, with learning difficulties.

It aims to identify this process from a multidisciplinary and interdisciplinary perspective, considering the psychological, cognitive and social factors of the student. It stresses the importance of the integration between psychopedagogical monitoring, school and family, in order to minimize or overcome the difficulties presented in the student's learning process.

#### Socioeducation

During adolescence and youth, the Socioeducation Service has the aim of developing skills and abilities for the self-management and autonomy of people with intellectual disabilities. The activities carried out use sports, visual arts, dance, theater and music languages, offering each participant an appropriate stimulus for their need

# HIGHLIGHTS OF THE YEAR

Throughout the year 2018, the main objective of the Socioeducation Service was to establish partnerships with public or private facilities in the living regions of people with intellectual disabilities in order to initiate a process of guaranteeing community life for these people.

Three partnerships were carried out in the southern region of the municipality, where the highest demand of the people assisted in the Socioeducation Service is concentrated. Currently, 70 people with intellectual disabilities attend inclusive activities in their territory.

#### **Qualification and Professional Inclusion**

The Organization offers the Qualification and Professional Inclusion Service for people with intellectual disability and TEA - Autism Spectrum Disorder who seek to enter the labor market. Based on the Supported Employment methodology, used in European countries and the United States, young people and adults are included in companies and receive technical support for at least 12 months. Therewith, people who historically found barriers to conquer their space find the necessary support for their effective inclusion and permanence in the working world.

APAE DE SÃO PAULO is still a forming entity in Professional Learning.

Its action has two units, Itaim and Interlagos, but develops decentralized activities in several regions of the city.

In addition to partnerships with important private companies, in 2018, processes for inclusion in the Public Prosecution Office of the State of São Paulo and Regional Labor Court are now carried out.

#### **Aging**

For this life cycle, the Organization has the Aging Service that assists people with intellectual disabilities, who present suggestive signs of aging.

Its proposal of assistance contemplates activities that are offered through workshops, aiming at the preservation of the functionalities of the individual. To this end, it counts on a multi and interdisciplinary team specialized in Gerontology. All activities developed aim to maintain functionality through health promotion actions, and the exercise of autonomy.






#### HIGHLIGHTS OF THE YEAR

• In November of this year, we supported the marriage of the couple with intellectual disabilities, Robinson Padrini and Priscila Oliveira, who faced many difficulties in fulfiling the dream of marriage. With the action of the Public Policies and Advocacy Center, the right provided for in the Brazilian Inclusion Law was guaranteed and the engaged couple got married. In all, the news was reported in 45 newspapers and news portals across the country, highlighting O Estado de S.Paulo, Terra, UOL, IstoÉ, R7, Correio Braziliense and Jornal do Brasil, with more than 1 million Reais on media exposure.

#### **Violence Prevention Program**

The program acts based on the compulsory notifications sent by other areas of APAE DE SÃO PAULO. The main objective is for professionals to identify the urgent need to intervene with families in order to minimize situations of vulnerability that signal a risk of violence; implement actions and referrals aimed at ending the cycle of violence; guide cases involving the violation of rights. Psychosocial care is provided for people with intellectual disabilities and their families.

The program also works with prevention, conducting orientation actions, raising awareness with groups of family members and training not only of the Organization's employees, but also of others who deal with intellectual disability.

The purpose of the training is to prepare professionals to identify possible signs of violence and build a professional perspective of prevention


#### **Ensuring Rights Project**


In order to educate and touch the players of the protection and guarantee of rights system regarding public and social policies directed at children and adolescents with intellectual disabilities and to assist and guide in the legal and psychosocial areas people with intellectual disabilities and their families, the project - in 2018 - had a social impact of 617 beneficiaries.

The assistances took place in the period from May to December, in a direct way, in training, considering the Organization's public, family members and professionals who work in the area of intellectual disability.

# Public Policies and Advocacy

All the services offered by APAE DE SÃO PAULO to people with intellectual disabilities and their families have the social inclusion as their guiding principle. However, there are still many barriers to overcome. With that in mind, the Public Policies and Advocacy Center was created, which seeks to guarantee the fundamental rights listed in the Convention on the Rights for People with Disabilities, enacted by the UN in 2008.

#### **Advocacy**

It acts in the incidence of public policies in a collaborative way with the government departments, elaborating and orienting projects of public interest, as well as focusing on the Legislative and Executive branches so that the laws are actually fulfilled. It also is represented in councils of rights, systems, forums and social movements. The Organization also acts in the articulation and training of players of the Ensuring Rights System through projects sponsored by private social investment and partnerships with the government.

#### HIGHLIGHTS OF THE YEAR

- In March, APAE DE SÃO PAULO was elected representative of the Municipal Council of Social Welfare in the workers segment; and in August was re-elected for the Coordination of the São Paulo Forum of Entities for People with Disabilities.
- In September 2018, a campaign on Inclusive Education was launched with the objective of disseminating an important channel of complaints regarding violations of rights occurred in the school environment. The telephone number mentioned in the campaign is from the Municipal Secretary of the Person with Disabilities, who became responsible for receiving calls and also generating data and information about this reality.
- On November 14, 2018, an amendment was made to Decree 58,514, which approves and establishes the Municipal Plan on Early Childhood 2018-2030 with proposals related to children with disabilities.
- Approval of the joint resolution CONANDA\* and CONADE\* No. 01, of October 24, 2018, which provides guidelines for the care of children and adolescents in the System of Ensuring Rights of Children and Adolescents.

#### **Articulation and Mobilization Program**

In defense of the rights of people with disabilities, APAE DE SÃO PAULO, through its Articulation and Mobilization Program, counts on the support and partnership of institutions of government.

Its objectives are to focus on public policies aimed at protecting, promoting and guaranteeing the rights of people with intellectual disabilities and to mobilize the players of the protection and defense system to identify and intervene in situations of violence and violation of rights against people with disabilities.

In 2018, the program worked in the institutional representation in commissions and working groups on Protection and Prevention of Violence; on the preparation of theoretical publications, two newsletters for the professionals of the protection system who work in the State of São Paulo, and on an article with international publication, on the website of Inclusion International; on the spreading of knowledge through the "I Seminário Mediação Assistiva: como gerir conflitos no contexto da pessoa com deficiência" seminar, on the "Fortalecendo o Sistema de Garantia de Direitos: prevenção e atendimento de crianças e adolescents vítimas de abuso e exploração secual"

seminar, of the Municipal Council for the Rights of the Child and Adolescent of São Paulo, and on the cycle of lectures "Compreendendo a deficiência intelectual", conducted by the Education and Research Institute of APAE DE SÃO PAULO.



#### HIGHLIGHTS OF THE YEAR

A partnership was established with the Laboratory for Analysis and Prevention of Violence (LAPREV), of Federal University of São Carlos (UFSCAR), to collect and analyze data on violence against people with disabilities in new projects was established. As well as the implementation of two projects: "Territories and Networks: Prevention of violence against people with disabilities" and "Territory for All: accessibility, emancipation and violence prevention".



In December 2018, APAE DE SÃO PAULO took on the management of the Technical Support Center in the 1st Police Station for People with Disabilities/SP, in partnership with the State Secretariat for the Rights for People with Disabilities - SEDESP. People with all types of disability (physical, hearing, visual, deafblind, intellectual or multiple disabilities), who have been victims of any crime, violation of rights or feel threatened, can access the service, which also has psychosocial and legal guidance.



#### HIGHLIGHTS OF THE YEAR

- The selfdefender Stephanie Ferreira Lima was elected Full Member of the Board of the Municipal Council for People with Disabilities (CMPD), of the biennium 2017-2019. Stephanie, who was an substitute of the Board, took the chair of Rosana Bignami after Rosana resigned the position. It was the first time that a person with intellectual disabilities took up a position within the Board.
- Two selfdefenders competed and won the elections for the Disability and Reduced Mobility chair: Ronie Vitorino, running for the title, and Ana Júlia Fernandes, running for reelection, as a substitute. In this space, the duo has the opportunity to discuss relevant themes about the youth of the city of São Paulo, living with young militants of various causes, providing respect for difference and diversity.
- The selfdefenders also participated in the workshop, held by APAE DE SÃO PAULO with the director of Asdown Colombia, Mônica Cortéz. The speaker shared her experiences regarding the exercise of supported decision-making and selfdefense in another country.

## **Education and Research Institute**

The Education and Research Institute of APAE DE SÃO PAULO generates and spreads knowledge about intellectual disability. Research and training are essential in the inclusion process.


Created 34 years ago, the Education and Research Institute of APAE DE SÃO PAULO, of scientific and educational character, acts in the generation and dissemination of the knowledge about intellectual deficiency, gathering programs and projects in the areas of training and professional qualification. It is also responsible for the structuring and management of scientific researches with the objective of assisting in the process of inclusion, prevention and in promoting the quality of life of people with intellectual disabilities, by fomenting discussions on the subject.



#### Research

Acting in the structuring and conduction of scientific studies in the biological, genetic, clinical and behavioral aspects of intellectual disability and counting on an acting Scientific Board. In 2018, 12 scientific researches were completed.

The research activity provides the Organization with the role of player, being able to create, test, criticize, improve and then implement new processes and technologies for diagnosis and monitoring of people with intellectual disabilities. In addition to subsidizing data and information in the formation of public policies aimed at the well-being of people with disabilities and the community.





#### Scientific Board

Its objective is to collaborate in the decisions related to the promotion of research and to establish processes, protocols and procedures to produce science in a reasoned and consistent way.

#### **Education**

11 board members

It develops activities aimed at training, updating and improving the professionals dedicated to the areas of Health, Education and Human Rights, contributing to spread the benefits of the knowledge gathered in the Organization to all segments of society. The Institute has a portfolio of courses on the subject of intellectual disability.

## Scientific Conference

The III Jornada Científica (III Scientific Conference), which had 66 participants, aimed to share the scientific productions made during the year by researchers from the Organization and educational institutes interested in the subject, in order to exchange experiences that result in the improvement of the quality of life of the people with intellectual disabilities



#### **Partnerships**

The partnerships contribute to the validation of the work carried out, and the good results come from projects in partnership with public bodies, teaching and research institutions for training the public network and social organizations. It is worth mentioning the affiliation of APAE DE SÃO PAULO to Inclusion International and the role of the Institute in translating the entity's newsletters, making the information of this international organization, which brings together 52 member countries, accessible to all Portuguese-speaking institutions.





# International Seminar on Legal Capacity and Supported Decision-Making

This event, held in September, brought together 17 national and international experts and the professional community on the subject, with the purpose of establishing guidelines for the implementation of the new paradigm of legal capacity and supported decision-making. During the event, the main changes, challenges and international experiences were presented. These actions contributed to engage players of the Ensuring Rights System about the importance of their role in the implementation process of the new paradigm.



The only technical & scientific journal focused on intellectual disability, Revista DI came to its 14<sup>th</sup>edition, bringing as its theme self-defense and clarifying how people with intellectual disabilities are already obtaining their guaranteed voice space, and reporting experiences of cases of active individuals in the self-advocacy of their rights, providing guidance on how organizations that support initiatives can contribute to strengthening self-advocacy for the disabled.

#### Jovem Pesquisador Scholarship

In June, a call for selection of research projects was opened of the Jovem Pesquisador Scholarship, aimed at candidates who already have PhD degrees.

Of the 19 papers submitted, 14 were preselected and two of the four scholarships available were filled out with the following themes:

- 1. Translational neuroimaging in intellectual disability: assessment of molecular alterations associated with aging in Down Syndrome;
- **2.** Production of pluripotent stem cells induced from peeled epithelial cells in the urine of individuals with Down Syndrome.

## Marketing and Communication

Internal and institutional communication is fundamental for the strategic positioning of an Organization. In dealing with the issue of intellectual disability, a matter of great depth, the role of communication is to overcome barriers, taking our great mission to include to the greatest number of people.



#### HIGHLIGHTS OF THE YEAR

In order to make the population aware of the importance of the Neonatal Heel Prick Test, APAE DE SÃO PAULO and Unisert, in partnership with Plug, promoted the second edition of Lilac June. We emphasize the importance of the test, which is fast, free, mandatory by law and detects illness in the first days of the newborn's life even before the symptoms appear. For the celebration of the date, monuments in São Paulo and in Rio de Janeiro received lilac lighting, the color of the campaign. We also had the support of several bloggers and digital influencers who supported the cause, such as the actress and official ambassador of the campaign Naiumi Goldoni and the tv hostess Sabrina Sato. In addition, we also count on the support of the magazines Materlife and Pais & Filhos, the brand Chicco and Instituto Mauricio de Souza.

In general, covering all the areas, services and activities of the Organization, we achieved a media exposure of R\$ 96,974,210, with special mention on O Estado de S. Paulo, Globonews, TV Globo, TV Record, TV Cultura, TV Brasil, TV Bandeirantes, RedeTV!, R7, G1, among other vehicles of great relevance.

Our social media is constantly growing. We reached 428,000 fans on our Facebook page, getting 106% increase over 2017. There were an average of 48 thousand hits per month on our site, showing the relevance of the channel for people to know about intellectual disability.

On March 21, the World Down Syndrome Day is celebrated. In 2018 it was no different, our campaign was intended to make the voice of people with Down Syndrome increasingly stronger, and to pursue a more and more inclusive world in which they could #IrProMundo and make their own choices. To make this action even more effective, we have the help of celebrities to spread this important date.

In partnership with Z515, the Marketing and Communication area of APAE DE SÃO PAULO conceived the film creation project and the ads of the Inclusive Education campaign. The concept of the ads is that schools that close doors for people with intellectual disabilities are against the law and giving a class of intolerance. Because of its importance, the campaign has turned viral into social media.




## **Personnel Management**

#### **PRACTICAL ARTS**

The volunteers develop craftwork to be marketed at two major events, the Mother's Day Bazaar and the Christmas Bazaar, as well as the production of promotional gifts for individuals and businesses on demand. All income is returned to the Organization's projects.



The permanent bazaar of APAE DE SÃO PAULO is another source of income. We receive donations of clothes, toys, furniture, appliances, utensils and other products, in good state of conservation, in addition to the realization of special bazaars with partner companies.

#### **Services**

The year 2018 was one of many challenges facing the Country's economic and financial situation. Even with this atypical moment, the Organization achieved a return beyond expectations of 600 new associates planned for 1,476 new donors.

In addition, for actions with donations starting at R\$ 50,000 per year, the company is certified with the Partner Company seal for dissemination in its products and communication materials.





#### **Sponsorship of Projects**

In 2018, we had the support of Instituto Helena Florisbal and Fundação Prada in sponsoring the Self-defense Program and the Professional Qualification and Inclusion Service, respectively.

#### **CMPC Melhoramentos**

In partnership with the baby care brand Babysec, of CMPC Melhoramentos, an initiative was launched in October in Latin America to raise the awareness of the population about the importance of social inclusion since childhood. Created by the body BBDO Chile, the initiative consisted in the publication of a video with testimonies of parents whose children have Down Syndrome. In addition, the diapers were stamped with baby Trini, who has Down Syndrome, and the seal of Partner Company of APAE DE SÃO PAULO in their packaging.

#### BGS

For the third consecutive year, we participated in the largest game fair in Latin America, the BGS - Brasil Game Show, with food collection and institutional action. For the first time, in partnership with Brazilians Against Time (Br.AT), we held a marathon of speedruns - competitions to finalize games in less time

The games were performed live, with national and international participants, and also transmitted online, through the Twitch platform.



### **Finance**

The economic uncertainties of the Brazilian market in 2018 negatively affected the main revenues of the Organization.

The revenues of APAE DE SÃO PAULO are derived from the partnership that the Organization maintains with the Brazilian Unified Health System (SUS) and the Municipal Secretariat of Education (SME), donations, service provision and covenant of projects approved by public bodies, which are financed by partner companies and individuals who use the tax exemption as a counterpart.


This moment of crisis affected all branches of activity significantly, contributing to the difficult moment that the Organization spent in 2018.




#### **EVOLUTION OF INCOME** (in thousands of R\$)

## Independent auditors' report on the financial statements

## To the Board Members and Directors of the Associação de Pais e Amigos dos Excepcionais de São Paulo-SP – APAE DE SÃO PAULO.

We have audited the financial statements of the Associação de Pais e Amigos dos Excepcionais de São Paulo-SP – APAE DE SÃO PAULO ("Entity"), which comprise the balance sheet as of December 31st, 2018 and the related income statements, comprehensive income, changes in net worth and cash flows for the year ended on that date, as well as the related explanatory notes, including significant accounting policies and other clarifying information.

In our opinion, the financial statements referred to above present fairly, in all material respects, the financial position of the Associação de Pais e Amigos dos Excepcionais de São Paulo-SP – APAE DE SÃO PAULO as of December 31, 2018, the performance of its operations and the changes in its cash flows for the year then ended, in accordance with accounting practices adopted in Brazil.

#### **Basis for our opinion**

Our audit was conducted according to the Brazilian and international audit standards.

Our responsibility, in accordance with such standards, are described in the following section entitled "Responsibilities of the auditor for auditing the financial statements". We are independent in relation to the Entity, in accordance with the relevant ethical principles set out in the Code of Ethics for Professional Accountants and professional standards issued by the Federal Accounting Council, and we complied with other ethical responsibilities according to these standards. We believe that the audit evidence obtained is enough and appropriate to provide a basis for our opinion.

#### Management's responsibility for the financial statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting practices adopted in Brazil and by such internal control as management determines is necessary to enable the preparation of financial statements that are free from material misstatement, whether due to fraud or error.

In the preparation of financial statements, management is responsible for assessing the ability of the Company to continue operating, promoting, where applicable, the matters relating to its operational continuity and use of this accounting basis in preparing the financial statements, unless the management intends to liquidate the Company or cease operations, or has no realistic alternative to avoid the closure of operations.

#### Auditor's responsibilities for the audit of financial statements

We aim to obtain reasonable assurance that the financial statements, taken as a whole, are free from material misstatement, whether due to fraud or error, and issue an audit report containing our opinion. Reasonable safety is a high level of safety but is not a guarantee that an audit conducted in accordance with the Brazilian and international standards on auditing will always detect any relevant existing distortions. Misstatements may arise from fraud or error and are considered relevant if, individually or jointly, they may reasonably be expected to influence the economic decisions of users taken based on these financial statements.

As part of an audit conducted in accordance with Brazilian and international standards on auditing, we exercise professional judgment and maintain professional skepticism throughout the audit. Furthermore:

- We identify and assess the risks of material misstatement in the financial statements, regardless of whether due to fraud or error; we plan and perform audit procedures in response to these risks; and we obtain audit evidence that is sufficient and appropriate to provide a basis for our opinion. The risk of not detecting material misstatement resulting from fraud is greater than that arising from error, since fraud may involve the act of circumventing internal controls, collusion, forgery, omission, or false intentional representations.
- We have obtained an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Company's internal control.
- We assess the adequacy of accounting policies used and the reasonableness of accounting estimates and respective disclosures made by the management.
- We concluded on the adequacy of the use, by the management, of the operational continuity accounting base and, based on the audit evidences obtained, if there is relevant uncertainty in relation to events or conditions that may raise significant doubt on the Company's ability of operational continuity. If we conclude that there is relevant uncertainty, we should draw attention in our audit report to the respective disclosures in the financial statements or include a change in our opinion if the disclosures are inadequate. Our conclusions are based on the audit evidence obtained up to the date of our report. However, future events or conditions may cause the Company to no longer be in operational continuity.
- We evaluated the overall presentation, structure and content of the financial statements, including the disclosures, and whether the financial statements represent the underlying transactions and events in a manner that achieves fair presentation.
- We have communicated with the management regarding, among other things, the planned scope, the timing of the audit and the significant findings of the audit, including any significant deficiencies in internal control that we identified during our work.
