ICPC employs part-time national expert from different regions of the project (Bandung, Surabaya, Makassar, Medan, Batam and Lombok) for different sectors (textile, industrial zone, and tourism) and make use of RECP resource pool for any additional experts. Each national expert is expected to work with the company in RECP assessment and implementation. Facilitators will also be recruited for establishing and facilitating RECP Club.

Work Areas of Activities: 1. RECP Capacity and Network; 2. RECP Implementation and Replication; 3. RECP Policy and Regulatory Framework; 4. RECP Technology and Innovation; 5. RECP Investment and Finance

Implementation:

PBPN is doing RECP Implementation and replication activities of the project focused on textile, tourism, industrial zone and micro enterprises (rice mills) and the area is widely spread in Indonesia. The information of all RECP activities publishes on RECP website (www.recpindonesia.org) that always keep updating.

Measurement of outcomes

RECP is implemented in a total of 149 units from textile (79), tourism (31), food processing & micro-enterprises (14), and industries in industrial zones (25) during the project from 2012 – 2020.

The Environmental Benefits RECP Project in cooperation with UNIDO has achieved (till 30 September 2020):

- A total of 394,551 tons of CO₂ per year avoided from implemented options
- A total of 75,292 Mega watt-hours of electricity saved is reported per year

- A total of 123,919 tons of coal saved every year from implemented options
- A total of 768 tons of wood saved per year
- A total of 2,849,740 cubic meters of water saved per year
