# Key Outcomes in 2020

- Recycling rate: Diverted 20,000 MT of waste away from landfill
- GHG Emissions: Contributed to a nett negative 130MT CO2 eq through the use of renewable energy derived from waste wood gasification

- Recycling rate: Increase the national recycling rate of plastic, wood, ash & sludges by 2%, 10%, 20% respectively (using 2019 as the base year)
