



The organization subscribes to the process approach rather than the service delivery approach and therefore the focus of its interventions is on building the capacity of the communities rather than providing them direct developmental support. The welfare approach being pursued by the Government of India for the past 50 years has failed to improve the socio-economic status of the marginalized and deprived section of the society and the organization is instead focusing on a rights-based approach to development.

The last four year experiences in working with the rural communities have strongly reinforced the belief that development is a continuous process, which cannot be achieved in a short span of time. Development shows positive trends of growth which the community themselves feel, need and realize the importance of maintaining it in a sustainable manner. Based upon our understanding all the development interventions need to focus on search for alternative options, addressing different type of problems at the community level, then building their capacity and later developing a sense of ownership among them.

Based upon the diverse socio-cultural and different geo-political characteristics of the state, we have identified strengthening of local self-governance institutions and the sustainable management of natural resources as key thematic areas.

2. **PROMOTION OF NATIONAL INTERGRATION CAMP**The Uttarakhand Jan Jagriti Samiti organize seven days camp at Bhagwanpur Block, Uttarakhand. The Society invited participants from differentstates and districts of Uttarakhand, altogethor 100 youths attended. The inaugural session moved with high applaud of the participants and in galaxies of aims and objectives of the National Integration Camp. The camp was organized withdifferent activities from morning to evening everyday on routine basis, including site seeing etc. The Camp yielded the desired results and all the participantssubstantially contributed to the success of the camp. It will be a privilege to declare and to place on the record tha! the NIC was successfully accomplished and concluded successfully. The society further proposes to organize such camp innear future.
3. **VOCATIONAL TRAINING PROGRAM**: The programme was held at Roorkee town, under this programme 50 women SHGs has taken part for two months course, where two instructors and two staffs were appointed by the society for imparting the training. The participants successfully received the training, where all the participants expressed satisfaction that they could operate Microsoft, word and power point applications.
4. **WORKING CHILDREN PROGRAME**: The Society organized this Programe to give a Knowledge of Vocational Training and a general knowledge of study. The targetedchildren were from under privileged families. They were trained to make bamboo craft items, handicrafts etc. The society invited the experts from entrepreneurship office asresource person and imparted training. Although, Government has taken this issue as a Main frame and enacted various laws for enlistment of the children and launched very effective schemes to grow and develop the children into responsible citizens.
5. **CULTURAL AWARENESS PROGRAM**: During the year our society has organized an awareness program on development of traditional art & culture at town hall . Roorkee in which the participants were awarded about importance of traditional art and culture and develop it by giving proper training & knowledge about it to their children so that they can, adopt it and promote their culture. The participants were also awarded that how the traditional art and culture can bring integration and communal harmony among various tribes of Uttarakhand and with other community.
6. **WATERSHED DEVELOPMENT PROGRAMME:-** The society organized the said programme with the help ofLocal Authority. With this' programme the benefit covered for 1 ha. of land under Bhagwanpur area. Different activities was taken under this programme.
7. **COMMUNITY WELFARE PROGRAMME**: Under this programme, the society benevolently rendered help to those poor villagers who are living in wretched condition by establishing family assistance specially for the old age person who were deprived of their family members and got separated from their dear ones. The society also extended help to the children who were under privileged in the society, by guiding them job oriented training and education so that they could work towards uplifting their economic status.



8. **CONSUMER AWARENESS PROGRAM:** This programme was organized for the public to create awareness on the consumer rights, such as, legal provision, juvenile, human trafficking, needs and importance of lodging and FIR and the rights to information act, consumer protection, duties and rights, right to safety, right to be informed, right to choose, right to be heard, right to seek redressal and right to consumer education were the main topics of this program.
9. **DRAMA ON BUDDHIST CULTURAL PROGRAM:** The one day programme of drama on Cultural competition was held at Roorkee town of Haridwar district, under this programme two schools participated. The prizes for the winners were categorized and given to the first, second and third respectively. The participants gave their best show which really enthralled the gathering. The Chief Guest for this program was Shri. Akhilesh Verma, Honoree Secretary, IIE in his speech lauded the society for organizing such program giving opportunity to the upcoming young talented students and advised the students to avail the opportunity in the future to become professional.
10. **FASHION SHOW PROGRAM:** The fashion show programme on traditional attires was organized to revive and show case the ethnic wears of the tribe. The youth organization, clubs and various NGOs under Haridwar District were invited to participate for the programme, in which a total of 50 youths participated. The participants successfully performed the show which really enthralled the gathering which many got benefited to glimpse age old tradition of our forefathers. The society also awarded certificates to the participants during this program.
11. **SEMINAR ON NEW & RENEWABLE ENERGY:-** The society has organized one day seminar on new & renewable energy at Roorkee town to the village council members, women organization and the youth organization. The resource persons for the seminar were invited from the concern department of New & Renewable Energy. The resource persons shared on different method of getting energy with power point presentation and asked the villagers to come and contact the department for installation or other assistance. The villagers got very benefited through this seminar and thank the resource persons and the organizers.
12. **SEMINAR ON FOOD PROCESSING** The seminar on food processing was held at Khajuri village for the farmers and SHGs of Khajuri village. In which fifty persons participated. The resource person for the program was Mr. Rajneesh Kumar Secretary, HSS, Govt Approved Institution. He spoke on various ways to preserve food and asked the participants to take as all entrepreneur to uplift once economy. The participants learnt many things through this program.
13. **WOMEN SHG FARMING .PROGRAMME:** The Society conducted this programme in collaboration with the Hardik Sewa Sansthan, to create awareness and educate the different existing women SHGs in the village. The resource was Mr. Arvind Kumar who has vast experience in Organic farming. In this program he encouraged the participants to learn and take up only organic farming which is only product good for our health in the present scenario for our health maintenance. He deliberated in detail about the latest method of cultivating organic farming. The participants learnt a lot from him during this seminar where everyone decided to start the organic farming. Another resource person Mr. Jitender Singh on the



different ways of farming activities and explained that one should think which is viable for that particular area/earth and take up that suitable farming for her income generation. Like wise we have to take the example of women folks in running the daily vegetable business which we should not feel shy to take up the income business. Through this program the participants especially the women SHGs got immense benefit for their future activity in farming.

14. **SEMINAR ON ENVIRONMENTAL POLLUTION:** The society organized this program for the rural people of the area. Resource Person explained briefly on the Miming, a variety of environmental problems now affect our earth. As globalization continues and the earth's natural processes transform local problems into global issues, some of the problems now affecting the world are acid rain, air pollution, global warming, hazardous waste, ozone depletion, smog, water pollution, overpopulation etc. Smog and toxins are floating in the air, caused by the wastage from industrial smokestacks and by the over use of petroleum-burning vehicles pollution environment effect the human life. One in five people around the world are dying every year due to factors related to the effect of environmental pollution. But, the most dangerous problem of environmental pollution on human life is the greenhouse effect. The Ecumenical Water Network said about 1.1 billion people worldwide, most of them in Asia, are denied of adequate water and sanitation, while two million people die every year of diseases caused by poor water and sanitation. Most environmental problems are occurring by improper use of and resources.

15. **SEMINAR ON AYUSH PROGRAMME:-** The programme on AYUSH was conducted with the help of one specialist doctor on AYUSH. He briefed the seminar that the umbrella term AYUSH is the acronym for Ayurveda, Yoga & Naturopathy Siddha and Homoeopathy At present in a global resurgence of demand for natural medicine has given a significant fillip to the development of Indian medicine. This system is moving ahead with use of latest technological & scientific developments. AYUSH system of medicine have age-old acceptance among various communities in India and played an important role in prevention and mitigation of disease. The chronic inflammatory and degenerative conditions that the elderly suffer from need special care, but with a health infrastructure already creaking under the burden of a growing population, care of the elderly is not a priority. Given this backdrop, Ayurveda provides the ideal health option with its Rasayana therapy which is a dedicated branch of Ayurveda for the care of the elderly. This was one of the 8 branches of Ayurveda developed millennia ago, and today in 21 st century we are looking to it for solutions. The fourth campaign was on Quality Assurance of AYUSH drugs.

16. **EDUCATIONAL COACHING PROGRAMME:** This program was organized to cater to the needs of the students of lesser privileged groups who have been aspiring for public services. The main motive of this program was to help the poor students who could not afford to pay high fees for coaching classes. The program was conducted with good faculty members, for which the results of the year was quite satisfactory. The students came from outstation and from the local area.

17. **WOMEN AND CHILDREN HEALTH AWARENESS CAMP:** The Uttarakhand Jan Jagriti Samiti organized seminar in Sadoli, Roorkee on the topic 'Information regarding health, hygiene safe drinking water and its management cleanliness of Environment and its effect of having worms in the stomach of children'. Dr Gupta was chief guest of these Women and



Children Awareness Camp. Dr Gupta gave special information on women health Problem, Family Planning, Vaccination Advantage of breast feeding over other source of milk and important of the balance diet for pregnant women. Uttarakhand Jan Jagriti Samiti maintained continuity of health awareness camp and conducted 2 camps on health, hygiene, balance diet, safe drinking water, protecting from frequent sickness and seasonal diseases.
