One year ago, Capri Holdings Limited signed the United Nations Global Compact (UNGC), aligning our business operations and sustainability strategies with universal principles on human rights, labor, the environment and anti-corruption. The UNGC's Ten Principles helped shape our company's corporate social responsibility strategy, which we released in our group's first CSR report on April 22, 2020. We believe the Ten Principles are a useful framework that allows Capri to engage with our global employee base, our business partners and our suppliers around the sustainability topics most important to our business and industry.

Our 2020 CSR report defines social and environmental sustainability initiatives already in action across our three brands, along with ambitious, measurable goals for 2025 and beyond. Our strategy is divided into three areas: **Our World**, focused on actions across our operations and supply chain meant to significantly reduce our environmental impact. **Our Community**, fostering a supportive, healthy, diverse and inclusive workplace for all of our employees. **Our Philanthropy**, connecting the talents, energy and success of our brands to those in need around the world.
