Part II. Description of Actions

Actions we have taken include;

- As a member of the UN Global Compact Local Network in Nigeria, we have provided
- Input in the activities and consultations of the local network in Nigeria.
- We encouraged and advocated for greater participation by other non-members of the
- UN Global compact to register and join the network.
- Participated in the process leading to the adoption of the UN Global compact on Migration.
- We renewed or updated our records on the EU Transparency Register for accountability. We also maintained membership of Thomas Reuters Trust Law and Namati, to support the provision of human rights and legal services to people from poor, underserved, and marginalized groups.
- We got approval by the ECOSOC committee to be granted the UN ECOSOC special consultative status in 2018.
- Our organization endorsed the Charter for Change, and our President CEO is Co-chairing the Advocacy Working Group since 2019, and Co-moderator of the Policy Session of the 2020 C4C annual meeting. Invitee to the Grand Bargain Localization WorkStream, Inter Agency Standing Committee (IASC RG3).
- Our Organization is one of the Co-Facilitators of the Grand Bargain Country Level Dialogue – Nigeria on Localization. To improve the participation of local actors in decision making and programming. Also hosting the Country Level Consultation of the CHS Alliance.
- We are active in the policy formulations and consultations with GNDR Nigeria-West Africa.
- Ohaha Family Foundation has been active from MDGs to SDGs, advocating for localization and domestication from words to action.
- With the Covid-19 movement restrictions, we designed a pilot program GBV Heartline, and commissioned a survey to understand the prevalence of Gender Based Violence (GBV).
- Managed services disruption by distribution of birthing kits, and essential mineral supplements to pregnant women in remote villages.
- Humanitarian response program in Nigeria, policy influencing and delivering humanitarian programmes to conflict affected zones, by providing essential medicine, healthcare, food and nutrition, NFIs to the affected population.

Part III. Measurement of Outcomes

Measurements of outcomes include:

- We received approval for the ECOSOC special consultative status in 2018
- Encouraged NGOs to endorse the Charter for change, registered GNDR.
- Co-facilitated policy advocacy and information outreach on localization in Nigeria.
- We participated in the process leading to the adoption of the UN Global Compact on migration in Morocco, December 2018
- Launched a Pilot Program GBV Heartline to respond to GBV and prevention in Nigeria.
- Our healthcare, nutrition, and Social protection program scaled-up to reach another 5500 conflict affected people.
