Attracting new participants to the UN Global Compact through outreach and awareness raising.	Supporting the development of occupational therapy associations and education programmes internationally in the reporting period, two occupational therapy associations from middle to low economy countries were admitted as Full Members of WFOT. In addition, four new occupational therapy associations were admitted as Associate Members of WFOT. WFOT is working with these Associate Members to develop and approve an occupational therapy education programme in each of these countries.
Organising learning and dialogue events, workshops and training for members on the UN Global Compact and specific topics relevant to corporate sustainability.	The ongoing work of WFOT in relation to principles of the UN Global Compact is communicated to representatives of member organisations through an online portal.
Engaging members in collective action efforts on Global Compact-related issues.	Regular communications are sent to member organisations. Experts from the international membership are sought regularly work on WFOT initiatives relating to the UN Global Compact. A Council Meeting held in 2021 was attended by 83 international delegates. Reports address Global Compact, SDGs and related issues.
Other actions to support the Global Compact to engage with the initiative.	WFOT business practices support sustainability including: online and paperless meetings; implementation of risk management procedures; attention to governance; and development of position statements and other documents addressing related issues. Innovation Change Agent Narratives	Work is underway to provide a collection of exemplars highlighting advocacy, policy, and program development from different regions of the world. Project participants will develop a narrative template, recruit narratives and supporting multimedia materials from every WFOT region, and work with WFOT to make this web accessible to organisation and individual members.

Since then, the project team has had a number of accomplishments including publication of the WFOT position statement on sustainability and the sustainability principles document, producing a special issue of the WFOT Bulletin focusing on sustainability, and presenting posters and other presentations at professional conferences. The next phase in this project involves the dissemination and promotion of the 2018 WFOT sustainability principles document to increase uptake of the topic in the occupational therapy community.
WFOT Executive and Council Meetings, and Congress	Initiatives are ongoing for WFOT for reducing the amount of printed material at meetings (e.g. use of data projection instead of printing meeting papers; website for general information); and at Congress by providing the alternative of a Congress app, website.
