During this 2-Year period we have as well partnered with Life Line Hospital a unit of the VPS group of Hospitals UAE, with over 100 Medical facilities and Hospitals to deliver Emergency Resuscitation Training and we are happy to state that we exceeded our goal of training 10,000 people by the year 2020 by 50%.

We still maintain our strategic partnership with University of Nigeria Teaching Hospital, School of Cardiothoracic Nursing, Lily Hospital Warri, Good shepherd Catholic Church Irawo, Owode Lagos Nigeria and Applegreen Consult, Healthrak, Society for Nurse Endoscopist and Minimally Invasive Surgery (SNEMIS).

1. BLS for healthcare provider course

The BLS Course trains participants to promptly recognize several life-threatening emergencies, give high-quality chest compressions, deliver appropriate ventilations and provide early use of an AED. In the Instructor-led course, students participate in simulated clinical scenarios and learning stations.

> FEATURES

- Updated science and education from the new Update for CPR and Emergency Cardiovascular Care (ECC).
- Instructor-led, hands-on class format reinforces skills proficiency
- Emphasis on high-quality CPR including a team dynamics classroom activity
- Video-based course with live simulations

2. HEARTSAVER FIRST AID:

Is a video-based, instructor-led course that teaches students critical skills to respond to and manage an emergency in the first few minutes until emergency medical services arrives. Students learn duties and responsibilities of first aid rescuers; firstaid actions for medical emergencies, including severe choking, heart attack, and stroke; and skills for handling injury and environmental emergencies, including external bleeding, broken bones and sprains, and bites and stings. This course is for anyone with limited or no medical training who needs a course completion card in first aid to meet job regulatory or other requirements.

- Instructor-led, hands-on class format reinforces skills proficiency
- Student Workbook comes with Heartsaver First Aid Quick Reference Guide that summarizes first aid actions for many injuries and illnesses *Update for Cardiopulmonary Resuscitation and Emergency Cardiovascular Care.*

3. HEARTSAVER CPR AED

Heartsaver® CPR AED is a video-based, instructor-led course that teaches adult and child CPR and AED use, infant CPR, and how to relieve choking in adults, children, and infants. This course teaches skills with research-proven practice-while-watching techniques, which allows instructors to observe the students, provide feedback and guide the students' learning of the skills.

This course teaches skills with the research-proven practice-while-watching technique, which allows instructors to observe the students, provide feedback, and guide the students' learning of skills.

✤ GOVERNANCE AND MANAGEMENT

Prudent Heart Care training site is managed by Prudent Heart Care Foundation Inc. Training site activities are therefore overseen by a training director who reports to the Board of Trustees. The Training Site director ensures compliance of training and assessment, client liaison, marketing, resource allocation, staff allocation, compliance with training policies and procedures and quality assurance.

✤ STAFFING

Currently we have **6 BLS** instructors, **2 ACLS Instructors**, **2 PALS** instructor and **1 Training Cordinator**

Training Site Director and a Board of Trustees that oversee the activities of the foundation

✤ CAPITAL RESOURCES

Prudent Heart Care Life support training site owns all resources without any indebtedness.

These includes the following:

- All training requirements including defibrillators, manikins, simulators
- Stationery
- Phones and office equipment
- In-house instructors who are well experienced and highly qualified.
- Continuous liaison with employers in target Hospitals, industries, companies and organization

✤ TARGET AUDIENCE/GROUPS

<u>All health care professionals:</u> Doctors, Nurses, Technicians, Paramedics who are working in and out of hospital. All health care professionals that require at a minimum BLS

for health professionals licensing and as required by the type of work they do.

We are targeting the medical centers and hospitals located in major cities in the country.

All non-health care professionals:

School teachers, secondary school children, HSE, guest executives who need a course completion card in CPR AED First Aid to meet regulatory or job requirements.

Moreso, we have our focus on the school teachers, traders, religious organizations, students which will have them equipped with lifesaving skills, help them respond in case of emergency and consequently make them more socially responsible.

***** How Prudent Heart Care meets monthly obligations including:

- All equipment required for the continued operation of the business is wholly owned.
- Fees are paid by clients on a course basis and by individual participants on attendance as per PHCF Inc policy on trainings.
- Major expansion requiring finance is not considered necessary at this stage.
- Equipment replacement is factored into running costs.
- Annual budget plan is made and reviewed based on the requirement.
- Individual and corporate sponsorship of trainings.
- Medical outreaches/camps are organized from personal funds from the Founder.
- Prudent Heart Care have NEVER received any cash donation from any individual nor corporate body but has had one of its events sponsored by JNC International who provided us with an ECG machine and a patient monitoring device on lease. We are open to collaborations with UNGC local network, sponsorships and goodwill donations to sustain our projects.

✤ COURSE PROCEDURES

- Training director prepares and circulates the training calendar among the clients. Upon receiving same, the candidates are advised of a course and location by email with a pre-course letter – this is initially forwarded to the client and then a copy forwarded to the trainer.
- The trainer will arrive at the venue, set up for the training and assessment. Welcome and register students, introduce them and present the course
- The trainer ensures all participants complete appropriate paperwork including attendance sheet, course roster and evaluation form.
- At the completion of training and assessment advise participants of their results, sign off on forms as appropriate and negotiate additional assessment opportunities for those who have not met the required standard (Remediation)
- The trainer then provides all forms completed to the office where the course and student data is entered into the computer.





