**To attain this, we have continued in our COVID RESILIENCE PROGRAMMES and we have convened our Global Health Conference, the Grand Health Bazaar #GHB2021 themed 'Engaging Relevant Tools for Sustainability in the 'Next' Normal'**

I am pleased to confirm that LiveWell Initiative LWI reaffirms its support of the Ten Principles of the United Nations Global Compact in the areas of Human Rights, Labour, Environment and Anti-Corruption.

It is the policy of the organisation that there should be no discrimination in considering applications for employment including those from the female gender and disabled persons. All employees are given equal opportunities for self-development. As at 14<sup>th</sup> October, 2021,

- We have engaged in Pro-Poor Free Health Programmes in low income communities, and COVID-19 RESILIENCE with bias towards **PMTCT Preventing Mother to Child Transmission of Viral Hepatitis** in Blighted communities and Provided Sanitizers, Face masks and other protective gear against COVID-19 for these communities.
- In addition, we have published our ongoing COVID-19 related Research work, using 4-Aminoquinolines for COVID-19 Positively Tested Persons and as Prophylaxis in untested or exposed persons, with reliable and impactful outcomes, published in open access peer reviewed scientific journals with high impact factor. Indeed our COVID-19 RESPONSE IN AFRICA is impactful in the community, in particular Oyo State Nigeria.
- Our **TELEHEALTH and TELEMEDICINE** Services in response to COVID-19, are running well, and we recently launched our Wellness packs as a **Non-COVID Response**
- In the past year, we have promoted and are still promoting SDGs 1, 3, 4, 5, 6, 10 and 17. We have expanded scope of SDGs to accommodate SDG 10, and we are Educating and Researching into Vaccine Hesitancy, representing GIANT USA as its country office in Nigeria, and we have trained over 15 Interns as Vaccine Infodemic interns in-house at LWI.
- Our Maternal and Child care services at our Health Post among low income indigenous populations, is ongoing through self effort (*looking for partners to scale*), and
- We have employed more than 70% female workforce at LWI and WIHA jointly.
- Through self effort, the first ever **Womens Wellness Center in Hepatitis (WWC-H)**, promoting SDGs 3, 4 and 5 and its services continue to cover Antenatal, Maternal and Child Health Services, Family Planning and Immunization. Recently as observed above, we have added free screening f ALL PREGNANT WOMEN, for viral hepatitis.
- In its pursuit of the **SDGs 1,3,4,5,6,10 and 17** the organization continues to collaborate with government, private sector, educational institutions, developmental partners and communities. Thank you.

In line with **SDG17**, LWI last year joined the **Women's Healthcare Working Group of the International Finance Corporation IFC** with a commitment to ensure that women are placed at the board level as well as high positions of Authority within the health system.

Our subsidiary **Women in Hepatitis Africa WIHA**, continues to give a strong voice to the **Women of Africa (SDG 3, 4, 5)** in the elimination of viral hepatitis by 2030. Through the Women of Africa and we are expanding our **Health Missions to the Poor and Underserved people**.

We are **Screening Pregnant Women for Viral Hepatitis** and we are **empowering low income women with IPC Training in Infection Prevention and Control.(SDG 1, 3, 6,10)**

We are joining the **Commonwealth Institute to reward Extraordinary Women Advancing Healthcare** and we shall soon be hosting the **first EWAH Awards in Nigeria and our upcoming Grand Health Bazaar #GHB2021 (SDG 3, 17)**

In this annual Communication on Progress, we provide an indepth description of our actions to continually improve the integration of the **Global Compact** and its principles into our business strategy, culture and daily operations. We also commit to sharing this information with our **Multisectoral Stakeholders and Communities**, using our primary channels of communication.

We marked the **World Humanitarian Day 2021** with a humble **Resilience Programme** where we dewormed children in a low income community. We also handed out **IPC Training and Advisory** to mothers, and gave our **Haematinics** to the women and children. We are **Promoting Handwashing, Water and Sanitation**. As part of our **SDG6 Programmes** on **Personal Hygiene and Handwashing**. In addition we marked **World Patient Safety Day #WPSD2021** on September 17<sup>th</sup> 2021 and gave our **Pregnant Women a Voice**, to speak out on **Safe Birthing for Mother and Child**. In line with the **WHO Declaration 2021 on WPSD**.

We Stand by our vow, to continue to support the **UN Global Compact** and All its Principles in entirety. Thank you.
