Part III. Measurement of Outcomes

Objective 1: Research, Publication and Policy Recommendation

The two compliance books provided guidance for Chinese enterprises in strengthening compliance. Some research findings have been accepted by related departments in promoting corporate compliance. NATC's research on ISO19600 pushed China National Institute of Standardization (CNIS) to localize the standard. Through the policy recommendation reports submitted in last few years, NATC has enhanced the compliance awareness of Chinese government and market participants. Evidence has shown that in 2017, Chinese government has attached importance to corporate compliance. In addition, all kinds of enterprise associations have advocated strengthening corporate compliance operation. Strengthening compliance has gradually develop into collective action of more Chinese enterprises.NATC has pushed SASAC's program of choosing pilot SOEs to enhance compliance management, and helped to improve the draft Guidance for SOEs to establish compliance management system.

Objective 2: Compliance Knowledge Sharing

NATC deepened cooperated with China Association of Automobile Manufactures, AdvaMed, China Petroleum and Chemical Industry Federation and other associations. The seminars pushed collective action within the targeted industries, and rendered compliance Guidance on three key compliance topics for auto companies. And the collective action within different industries will exert a significant impact on the whole business environment.

Objective 3: Compliance Training

With participants from all around China, NATC's trainings have spread compliance knowledge to enterprises in different regions of China, especially major cities like Beijing, Shenzhen and Shanghai. SOEs, foreign enterprises, private companies and joint ventures have all joined the trainings, and it can be seen that the trainings have started to influence more and more medium and small sized companies.

Being influenced by NATC's training programs, some SOEs were enlightened to search for the mode of establishing compliance management system suitable for their companies and remedy some weaknesses in their management systems; and private companies started to search for ways to integrate the function of compliance into their management system.

Objective 4: Compliance Club

The club events served as a platform for enterprises to discuss specific compliance topics and share compliance practices. After the Compliance Talent Exchange Program, more enterprises form different industries were enrolled in the compliance club and started to stress compliance capacity building.

As the club expanding, and more associations seeking to cooperate with NATC, NATC will establish Corporate Compliance Promotion Alliance of China with the support of some major enterprise associations to further expand the club and form a joint force of market participants to strengthen the compliance capacity building.

Objective 5: Compliance Forum

Through the 4 forums, compliance awareness of the participating companies was enhanced, and compliance knowledge on identifying compliance risks and setting up compliance management system was spread. The practical tools and methods introduced by the speakers enlightened the participating companies to take actions to deal with compliance issues.

The forum also laid foundation for further cooperation between NATC and relevant associations and departments, and multiple sides will conduct more trainings and other activities together to promote corporate compliance.

Information on NATC events reached more readers through the website and attracted them to attend our activities. More compliance practitioners resort to the website to acquire compliance research findings and best practices on compliance management.
