Engage in Global Compact Local Networks

- Practical Action in Bolivia joined the UNGC local network and was recognised in December 2021 for Practical Action's work since 2010 in Bolivia, within the framework of SDG 2 to end hunger, achieve food security, improve nutrition and promote sustainable agriculture, promoting the productive use of energy under a market-based approach in different value chains. - Practical Action are partners on the **Global Plan of Action for Sustainable Energy in Displacement Settings (GPA)**, which is hosted by UNITAR. The GPA works to support humanitarian partners to deliver the actions of SDG7 for displacement contexts. Practical Action are on the steering committee for the GPA and secured €10,000,000 (euros) of funding from the IKEA Foundation to partner with UNHCR on developing a 5-year project on humanitarian energy in displacement contexts including implementation and advocacy

Conduct applied research & thought leadership to advance best practices & participating in Global Compact events

- Practical Action was recognised in 2020 for outstanding collaboration in Latin America for its Brighter Futures project that will improve the education of hundreds of thousands of children in rural Peru: <https://practicalaction.org/news-media/2021/09/03/practical-action-recognised-for-outstanding-collaboration-in-latin-america/>
- Practical Action has **observer status for UNFCCC and UNCBD** global environmental agreements and is an active participant in the conference of parties (COP). In Dec 2019 Practical Action engaged in the COP25 in Madrid, with a delegation of seven staff including one each from Kenya, Nepal, Zimbabwe and Bangladesh with the latter two part of the official government delegations. In November 2021 Practical Action attended COP26 in Glasgow with a delegation of 14 staff from the UK, Peru, Zimbabwe and Nepal with the Nepal colleagues part of the official government delegation. Attending and speaking at several side events, we engaged with the negotiations directly via our staff on the Nepal delegation and indirectly as official observers to the process. We shared a policy brief based on lessons learned from the establishment of the Climate Technology Centre and Network to help shape the operationalisation of the Santiago Network for Loss and Damage. It was widely used by negotiators with the inputs captured in the final Glasgow Climate Pact. We released a report with University College London on the slow progress of the Warsaw International Mechanism, where we highlighted the disconnect between escalating climate impacts in developing countries not being reflected in the technical work of the negotiating bodies. In addition to this, Practical Action, with Oxfam International and Prakriti Resources Institute, hosted an official Blue Zone side event “How Vulnerable Countries are Responding to Loss and Damage and What Support They Need”. Key speakers included First Minister Nicola Sturgeon who announced the Scottish Government would be committing 2 million pounds to a dedicated loss and damage fund, and H.E. Ramsahay Prasad Yadav, Minister of Forests and Environment, Government of Nepal. Our technical report and these events contributed to the high profile that Loss and damage received at COP26 and has firmly secured loss and damage as an agenda item at the next COP.

- In February 2020 Networking Event at the **World Urban Forum** showcasing Practical Action’s innovation in dealing with waste problems (both faecal sludge and household waste) in the Rohingya Refugee camp in Cox’s Bazaar in Bangladesh. The options for design were constrained by many factors including a lack of space, extreme weather events, steep slopes, and a prohibition on building permanent structures. But sometimes constraints lead to the best innovations, such as our decentralised sludge treatment plants

Support Global Compact principles, special initiatives and work streams

This is achieved through our four program *change ambitions*: Resilience that Protects, Energy that Transforms, Cities Fit for People and Farming that Works.

- Co-hosted in June 2021 the 15th International **Conference on Community-based Adaptation** to Climate Change. CBA15 was funded by the Climate Justice Resilience Fund, Irish Aid and IIED, and organised with co-hosts the Global Resilience Partnership, CARE, Practical Action and ICCCAD, in collaboration with the contributing partners Green Africa Youth Organisation, BRAC, the Huariou Commission, IUCN NL, African Centre for Trade and Development, GIZ and VSO, and sponsorship from EnGen. CBA15 provided a hub for people who are on a pathway to climate-resilient, low-emission and sustainable development and want to thrive in the face of climate change.

Practical Action ensures its work, projects and programmes adhere to its ethical code of conduct and expects all employees, volunteers, consultants, suppliers/contractors, partners, beneficiaries, trustees, and any other parties who have a business relationship with any Practical Action offices to abide by it and other organisational policies, including Safeguarding, Financial Crime, Protecting Practical Action from Terrorist Financing; Dignity and Diversity at Work.

- Practical Action has a cycle of regular policy review, strengthening policies where gaps are identified and a comprehensive roll out and training programme in all key areas that are relevant to our ethical code of conduct. Specifically
 - Safeguarding policy and procedures are reviewed annually, updated according to need, with compulsory annual training for all staff to update their skills and knowledge. Legal compliance for reporting incidents is strictly adhered to.
 - Financial policies and audit reviewed and updated regularly
