ACTIVITY1: NETWORKING ACTIVITIES & EVENTS

2019

We were actively involved in a number of networking events:

- 7x networking seminars in Bangkok, Pattaya, Phuket & Chiang Mai to highlight bondage labor & human trafficking.

- Transparency International: anti-corruption lecture with MP Stewart.

- participant in various events regarding the establishment of a Memorandum agreement between [12]x ASEAN Foundations to further the protective measures on civil liberties and the rights of defendants in the Thai, Cambodian, Myanmar, Laos & Vietnamese legal systems;

- attended the UN Session on Anti-Corruption and Anti-Corruption Day.

- Thai sustainability council including [38] attendees inluding local Thai lawyers, government officials, Thai business representatives and employees.

2020

Due to the pandemic of Covid-19, our activities have been limited:
communications regarding public health, immigration, employment & economic affairs.

Outcome: increased awareness of the ITF & UN Global Compact including capacitybuilding, cooperation & information sharing.

ACTIVITY 2: WORKSHOPS & TRAINING

- 2019: we hosted 4 workshops to inform potential stakeholders & interested parties relating to Thai & ASEAN labor practices, human trafficking, sex working, bribery & business / sustainability practices.
- 2020: scheduled workshops cancelled; therefore, non performed.

Outcome: prior competency & skill development. Subject to safeguarding measures, it shall require reinstitution from 2022 onwards.

- Increased knowledge & capacity-building for greater awareness / skills pursuant to the SDGs.

Outcome: continuation of the Pro Bono Legal Centre.

ACTIVITY 5: STAKEHOLDER COMMITTEE & CSR NETWORK

- The ITF conducted 3 Stakeholder Committee meetings consisting of 31 & 11 members from interested parties.
- The Agendas focused on (i) Human Rights, Civil Liberties & Sustainability; and (ii) Internal Compliance & Operations.

Outcome: ratification of the UNGC 10 Principles and a commitment to its practical implementation in business for economic & social development.

ACTIVITY 6: ENGAGEMENT WITHIN THE LOCAL NETWORK

• 2019 & 2021 remote engagement & participation with Global Compact Local Networks and its events; including attendance at various seminars.

ITF should continue its engagement & activities with the UN Global Compact in Thailand, USA & UK and its various members.

CONCLUSIONS

Until the impact of Covid-19:

- 1. the ITF had effected significant measures to implement awareness of the UNGC SDGs;
- 2. ongoing steps regarding human rights & civil liberty advice via the Pro Bono Legal Centre.
- 3. continued mapping of CSR entities in Thailand.
- 4. further requests for cooperation from the Thai government & ASEAN entities to support the UNGC principles.
