- Above 10,000 persons (law enforcement officials, paramilitary officials' government child protection actors, parents, teachers, adolescents/children, community leaders like village headmen and religious leaders, journalists and general public) were sensitized and trained on issues related to child protection, human trafficking and violence against children especially child sexual abuse in Manipur. Maximum of the activities were conducted in partnership with Government agencies such as Manipur Police, Manipur Social Welfare Department, Manipur State Commission for Protection of Child Right, Manipur State Legal Services Authority etc.
- Around 120 boys within the age-group of 8-12 years were sensitized on adopting gender-equal behavior and were trained to become change agents in their communities promoting gender equality, child rights and child protection.
- FXB India Suraksha (FXBIS) was invited as resource person to train law enforcement agencies including Police officers and judicial officers (judges, prosecutors and lawyers) and child protection actors including Child Welfare Committees and Juvenile Justice Board organized by the Lal Bahadur Shastri National Academy of Administration, V. V Giri National Labour Institute, Bureau of Police Research and Development, Central Academy for Police Training, Madhya Pradesh and Central Detective Institute for Police Training, Ghaziabad. Over 5000 law enforcement officials were trained.
- FXBIS in association with Madhya Pradesh Police conducted a vulnerability mapping exercise of hotspots prone to human trafficking in few of the selected locations in Madhya Pradesh. FXBIS developed a hotspot mapping questionnaire and trained the Police officials on using the same to carry out the exercise.
- 15 vulnerable/potential victim(s) or survivors of gender-based violence and human trafficking were
 provided with economic rehabilitation in Darjeeling, West Bengal. A food business initiative with the name
 We Kitchen was started to support three women to sell cooked and packaged food products. They were
 trained on sustainable ways of selling cooked food products, its durability and marketing strategies.
 Moreover, 12 vulnerable girls were identified belonging to trafficking prone areas in the Dooars region of
 West Bengal and were supported with piggery farming as an economic support to reduce their
 vulnerability.
- Over 200 victims of trafficking were rescued for the period of 2018-2021 from various locations in the country. Among these 179 victims belonged to Nepal who were rescued in Manipur. Later they were repatriated back to their native places in Nepal with the support of FXBIS.
- Designed and launched e-learning portal and mobile application named 'PRITI-Police Response to incidences of Trafficking and Intimidation" for the Police officials in Madhya Pradesh. The portal and the application would help the Police officials to access reading materials related to modern day slavery, gender-based violence and child protection. It was launched by the Special Director General of Police, Madhya Pradesh on the 8th March 2021.
- A Gender Resource Centre (GRC) was established at the Madhya Pradesh Police Academy, Bhouri, Bhopal on 8th March 2021. A vision document for the functioning of the center was also developed and handed over to the MP Police during the occasion.
- FXBIS developed a Standard Operating Procedure for identification and screening of victims of trafficking to be used by Police officials. This document was developed as an outcome of a research conducted on identifying promising practices, gaps, and challenges in integrating or separating services for Trafficking in Persons (TIP) and Gender Based Violence (GBV) victims and optimizing screening and support services.
- With the outbreak of Covid 19, FXBIS supported over 20000 needy families with dry ration relief and dry milk for toddlers across its various project locations in India.

Part III. Measurement of Outcomes

- FXBIS' oldest running day-care programme for railway platform children in Jaipur (capital city of Rajasthan state in Western India) catered to around 40 children in addressing their psycho-social vulnerabilities while working at the platform. Under the programme, a day-care centre functions where children can relax, clean, eat nutritious meals. Supplementary education classes and computer knowledge is imparted to those who had dropped out of school but wish to resume education.
- FXBIS continues to run the 24*7 child in distress helpline service called "Childline 1098" in Gautam Budh Nagar district of Uttar Pradesh (India's most populated province) and Ukhrul district of Manipur (a tribal district in the Northeastern part of India, prominent source state for human trafficking within India and outside its borders). Over 1500 calls were successfully addressed in both the districts
- Assam Rifles adopted and integrated FXBIS' training tools on human trafficking and child protection in their inservice training course conducted for the newly recruited personnel of Assam Rifles.
- FXBIS was selected as a Host organization by IBM to set up Trafficking Analysis Hub in India to support
 organization in prevention of vulnerable people from trafficking especially for forced labour.
- FXBIS' thematic expert on Protection and Safety of women and children, Mr. Satya Prakash, Chief Operating
 Officer, was selected as a fellow for the prestigious International Visitor Leadership Program (IVLP) by the US
 State Department, 2020-2021.
- FXBIS was nominated as the Nodal NGO to work with the district administration of Gautam Budh Nagar district, Uttar Pradesh in providing support to needy families in the district with the outbreak of Covid 19 in 2020.
- FXBIS was nominated as a Drafting Partner of a State level Standard Operating Procedure on Pre-Rescue, Rescue and Post-Rescue Procedures of trafficking in persons in Manipur.
- Every year the 'Global Hand-washing Day' is observed across project locations in India on the 15th of October, to inculcate the practice of proper hand-washing amongst children. Each year over 20,000 children and adolescents are taught, and it is expected that most of them would in turn educate their families through their practice at home.
- FXBIS renovated 36 schools, upgraded 8 schools as smart schools with digital equipment and learning materials, 9 Anganwadi centres (basic village level health care system for children) in Assam and Meghalaya.
- Supporting the country's "Clean India Mission", FXBIS facilitates building of toilets at its intervention locations. Promoted access to household toilets to 206 families by assisting them to construct and renovate toilets. Also, FXBIS provided functional toilets, hand washing, water supply and facilities for menstrual hygiene in 22 schools in Assam benefiting over 4000 students since 202-2021.
