Bonsucro's Activities in Support of the UNGC Principles (2020-2022)

Bonsucro is a non-profit multi-stakeholder platform for sustainable sugarcane. We have over 280 members in over 50 countries, and certified mills and sugarcane farmers in 21 countries. Our latest activities in relation to our commitments to the UNGC focuses on:

Africa:

 We have received a grant from ISEAL to lead implementation of the "Good Practice, Better Finance: Enabling access to preferential finance terms as an incentive for improving sustainability performance in the agricultural sector" in South Africa. Asia/Pacific:

- We have carried out a project with the IFC in Pakistan to support continuous improvement and Bonsucro certification of two sugarcane mills

- We convened the sugarcane industry in Japan and Thailand to promote sustainability in sugar supply chains and collective commitments and strategies.

Latin America:

- Since December 2020, we have been active participants of the UNGC Brazil Network, in particular the <u>Sustainable Agri Platform</u> meetings.
- Within the platform we are coordinating one of the UNGC projects on Sustainable Finance.

Global:

 Following extensive consultations with stakeholders, Bonsucro has adopted a new <u>Strategic</u> <u>Plan</u> with ambitious targets on Climate Action, Human Rights, Water Stewardship and Living Wage. The strategy also emphasises Bonsucro's role as a convening platform to enable collective action at country and industry level.



- Bonsucro has published a new <u>Bonsucro Production Standard</u> for the sugarcane sector, which was developed by an independent expert working group following over 2 years of public consultations and stakeholder engagement.
- Organisation of training sessions and a licensed trainer scheme on topics related to the Ten Principles of the UNGC, which are covered in the criteria and indicators of the Bonsucro Production Standard.
- Review and roll-out of <u>Bonsucro's Code of Conduct</u> and <u>Grievance Mechanism</u> to ensure that our members seek alignment to the UN Guiding Principles on Business and Human Rights (UNGP).
- As a global platform we enable dialogue and build collaboration with companies and NGOs involved in the Global Compact, which includes many of Bonsucro's members.
- We continue to formally endorse the UNGC to our membership
- We promote impact projects on areas relevant to the UNGC particularly on Human Rights, Labour, and Environment.

Measurement of Outcomes

We are constantly working to improve the social, environmental, and economic sustainability of sugarcane farming and production of its derived products. Our Monitoring & Evaluation System reflects our objectives in these areas. Every year, Bonsucro publishes its <u>Outcome Report</u> to provide stakeholders with a view on key improvements achieved by the sustainable sugarcane sector, made of operators which participate in the Bonsucro platform and/or achieve Bonsucro certification.

It is based on analyses carried out by the Bonsucro secretariat using different sources of data. The report seeks to assess key monitoring & evaluation indicators, to provide an evaluation of the performance of the organisation in delivering its mission and reaching its vision, and to identify the measurable outcomes directly achieved by operators. Amongst the highlights of the most recent Outcome Report, I would emphasise the ones below:
