## **CEO Statement**

Two years ago, Capri Holdings Limited signed the United Nations Global Compact (UNGC), signaling our company's commitment to align our business operations and sustainability strategies with universal principles on human rights, labor, the environment and anti-corruption. The UNGC's Ten Principles helped shape our corporate social responsibility (CSR) strategy, which is divided into three areas:

- Our World We know that the success of our company is directly linked to the sustainability of the world around us. Our brands strive to create the highest quality luxury products with longevity and sustainability in mind. Operating responsibly helps us to lower our impact on the planet and to promote industry-wide environmental change.
- Our Community We believe we have a responsibility to those who work with us. Our company strives to create inclusive workplaces where all of our employees are empowered and respected. We are committed to creating meaningful opportunities for our diverse Capri community to grow.
- Our Philanthropy Giving back is embedded in Capri's culture. We remain steadfast in our commitment of support and driving positive change in the communities where we live and work.

We believe the Ten Principles are a useful framework that allows Capri to engage with our global employee base, our business partners and our suppliers around the environmental, social and corporate governance (ESG) issues of greatest importance to our stakeholders. By incorporating the Ten Principles into our CSR initiatives, we aim to uphold our responsibilities to Our World, Our Community and Our Philanthropy.

As part of our 2020 CSR strategy, we previously committed to ambitious, measurable goals around greenhouse gas emissions, renewable energy, raw material sourcing, water use, waste reduction, diversity and inclusion, and philanthropic giving. Our 2021 CSR Annual Update, issued in December 2021, provides an update on Capri's activities to drive meaningful progress toward those goals during Fiscal Year 2021, along with some of the major CSR-related activities undertaken during the first half of Fiscal Year 2022. Information on how our initiatives and strategic focus areas align to the Ten Principles can be found in our 2021 CSR report appendix.

Living up to these commitments is an ongoing and ever-evolving process. Attached to this cover note, you will find the Ten Principles of the UNGC, along with the steps Capri has taken to make progress against each Principle over the past 12 months.
