Dear Mr. Secretary-General,

I am happy to reaffirm Huntsman's continuing support for the Ten Principles of the Global Compact with respect to human rights, labor, environment, and anti-corruption and to confirm our support for the United Nations 17 Sustainable Development Goals.

As the global community continues to face significant challenges, including the geopolitical crisis in Europe and worldwide disruptions to supply chains, Huntsman continues to make improvements. Details of our progress are available to all stakeholders on www.Huntsman.com/sustainability. Specifically in 2021, we built on previous years' successes in many ways, including:

- **Multiple planned investments to enable safer products and lower carbon mobility** – We have invested in the United States to expand our production of E-GRADE® High-Purity Amines which are used to make semiconductors cleaner and more reliable. We also announced plans to increase our production capacity for ULTRAPURE™ Ethylene Carbonates that are used in electric vehicles. Huntsman is the only provider of these carbonates in North America.
- **Accelerating circularity through the value chain** – We continue to expand our capacity to transform PET scrap (e.g., including recycled plastic bottles) into TEROL® polyester polyols which provides us the ability to meet increasing market demand for recycled content and further grow the value-stream for upcycling waste PET.
- **Scaling low carbon solutions.** Through Huntsman Building Solutions (HBS), the largest global franchise in spray polyurethane foam (SPF) insulation, we continue scaling production for the world's foremost energy-saving insulation – that enables greenhouse gas (GHG) savings by dramatically improving energy efficiency in buildings.
- **Improving carbon performance and announcing new aspirations** – By the end of 2021, we have reduced the GHG intensity of our production by 8% as compared to our 2019 baseline. In November 2021, we announced our aspiration to achieve carbon-neutrality by 2050 and to engage our top carbon-producing suppliers on their climate targets.
- **Improving resilience for water stress** – By the end of 2021, we have reduced the water intensity of our production in water stressed areas by 65% as compared to our 2019 baseline.

- **Elevating reporting** – We continue to improve our reporting to better meet the growing needs of our stakeholders and interest in environmental, social, and governance (ESG) issues from the investor community. Our 2021 sustainability report will be our 11th publication. In the report we applied the new 2021 Global Reporting Initiative (GRI) standards and disclosed our management of climate-related risks and opportunities against the Task Force on Climate Related (TCFD) Framework.
- **Elevating governance** – In February 2021, we announced the creation of our Board Sustainability Committee which oversees sustainability and other related corporate social responsibilities and governance matters at Huntsman.

We continue to incorporate the Ten Principles as appropriate into our corporate policies and standards, which we see as complementary to our own business values and goals. With this communication, we express our continued commitment to advance those principles within our sphere of influence.
