The Save the Climat as a Civil Society NGO Member of the UN GLOBAL COMPACT Non-business Participant, has worked since its adhesion on the image promotion of the UN GLOBAL COMPACT, and to this date, from our organization's promotional efforts, we have already brought 3 Civil Society Organizations to apply for UN GLOBAL COMPACT adhesion.

The Save the Climat with Headquarter in Democratic Republic of Congo and AEPT Cameroun based in Cameroon, have signed and formalized since 11 May 2022 one Consortium Partnerships with mutual aims to advance the UN Global Compact principles, to advance the Work of UN ECOSOC, the well implementation of UN Agenda 2030 of SDGs, the United Nations Work in general and other relevant works with Civil Society Organizations and multistakeholders.

The Save the Climat has activey attended, the UN Global Compact Leaders Summits in 2020 and in 2022. ,

The Organization has also taken these concrete actions to advance ten principles of the UN Global Compact:

- By working on the Protection of our Global Climate and Environment during the implementation of the "Project on the creation of waste recovery to fuel briquettes and biofertilizer enterprises to operate successfully in DRC under EBAFOSA DRC", from

June 2020 until today, by the Support of EBApreneurSolutions Nigeria and UNEP_Ebafosa and the Canada Government

- By working on Human Rights Issues since ages until today, with its national and International Partners, as for example with PEPA based in DRC, with CIVICUS World Alliance as a Voting Member, etc. The list is not exhaustive.
