#### Environment

In order to reduce the emission/load of  $CO_2$  and  $NO_x$  to the environment, we invested in Electric cars and Forklifts.

We are aware of and acknowledge our responsibility with respect to environment as well as local and national legislation.



#### Anticorruption

A practical handling has been described in the internal Quality System. This is part of our Code of Conduct, ensuring proper behavior maintain one of our core values. Furthermore senior management has attended workshops held by affiliated law firm / legal advisor.

#### Upcoming

Our goal is to optimize sorting and distribution of waste and thereby minimize amount of "waste of combustible" with 30 percent before year 2023.

We will continue replacement of diesel truck with electrical trucks – to reduce CO2 emission from our vehicle fleet and scope 1, net-zero goal by 2030.
