

ARIOLU SUES FOR PEACE & UNITY COUNSELS RUMUIEBEKWE COMMUNITY TO EMBRACE DIALOGUE



Warns youth bodies to identify with State Government or face the wrath of the law.

Chairman of Obio/Akpor Local Government Council, Barr George Ariolu, has appealed to members of Rumuiebekwe Community to sheath their swords and embrace dialogue.

He said the emphasis of the Council under his watch is to ensure that communities in the LGA enjoy relative peace and live in unity and harmony.

The Chairman made this call on Tuesday, during a visit

by the Rumuiebekwe Community Council to Obio/Akpor Local Government Council Headquarters, Rumuodomaya.

According to the Council boss, his administration is purposeful in delivering dividends of democracy to the people, adding that his position as Chairman of Obio/Akpor is for the services of the people.

Reminding them that without peace, development can not thrive, he described his administration as one with full respect for rule of law, which is the bedrock to democracy.

The Chairman expressed satisfaction with the visit by Rumuiebekwe Community Council, describing it as solidarity support to his administration.

Recounting some of his administration's achievements, Ariolu said communities stands to gain more from the Council when the right persons are in the helms of affairs.

Speaking further, he pledged the Council's continued support to improve welfare and wellbeing of communities in the LGA through his administration's programs and policies.

He added that his administration will do more to boost human capacity development and expand the frontiers of economic development in the area.

He expressed optimism that Rumuiebekwe Community will explore the Council's human capacity development efforts such as Vocational Skill Acquisition, Post Graduate and Masters Grants, Charkin Maritime Training, amongst others.

Similarly, he tasked members of Rumuiebekwe Community Council to continue in their cooperation with his administration to bring about the much needed change the LGA yearns for.

He said while the government is doing its best to curtail the menace of insecurity, traditional and community leaders must not allow the use of their space to fan the embers of discord and incitement to violence.

He admonished them to stop the circle of attacks and retributive violence against one another.



Meanwhile, Ariolu has urged them to mobilize members and residents of the community to register for their PVCs in order to vote competent and more credible leaders ahead of 2023 general elections.

He also promised to procure a brand new transformer to improve power supply.

However, he has warned all youth bodies who are yet to identify themselves with State Government to do so or cease to exist, assuring the Rumuiebekwe Community Council that the Council will wade into the youth crisis.

Paramount Ruler of Rumuiebekwe Community, Eze Amb. Sir Ray Elewa KSC, Eze Owhor Nu Ogwu II, who spoke earlier commended Ariolu for his landmark projects in the LGA, congratulating him for his one year in office.

The Paramount Ruler while speaking, appealed to the Council Chairman to intervene in some of the issues in Rumuiebekwe community, including the division amongst youths in the community.

He further called the attention of the Chairman to some dilapidated roads within the community that needs urgent attention as well as demanded for a transformer to improve power supply in the community.
