- The company also highlights its zero tolerance to child labor on the human rights policy available on the company website.

- The company has also been in the forefront in the fight against COVID-19 through carrying out COVID-19 tests in our labs, which saw us receive the ISO15189 accreditation for COVID-19.

A good example is the Hepatitis B vaccine and other health checks like free Covid-19 tests for all staff. During the onset of the COVID-19 pandemic, all members of staff were tested and given clear guidelines on how to keep safe and reduce chances of infections at the workplace. Protective gears were also provided to all members of staff handling patients.
- The company also ensures that all employees and their dependants have a medical cover. The company also have enhanced insurance cover which includes Group Life Assurance (GLA), Work Injury Benefits Act (WIBA) and Group Personal Accident (GPA).
- Manuals have been made available to all staff on our sexual harassment policy which is also available on the intranet, and a clause on sexual harassment is also included on our human rights policy available to all employees.
