

# Description of practical actions 1 Human rights

## 1.1 Assessment, Policy & Goals

NUNNER Logistics respects and actively supports the Universal Declaration of Human Rights. The respect for human rights is integrated in both internal and external operations. On 2014 May 26th NUNNER has published its current company's Code of Conduct that is applicable to all employees of the NUNNER group and must be complied with. This Code of Conduct is also published on the company's website and can be found here:

Concerning human rights it explicitly states that NUNNER respects the opinion of other persons and their personal dignity, privacy and personal rights. NUNNER will not tolerate any type of discrimination, mobbing or harassment. Because in the last year their have been many cases of sexual harassment in some of the countries where NUNNER is active, we have given special attention to this subject and we have encouraged our staff to come forward with eventual cases and have underligned our policy on this.

## 1.2 Implementation

All employees are subject to a detailed year-end-meeting with their manager. If requested, there is also the option to have this meeting with participation or face-to-face with a confidant representative of the Human Resources department.

#### 1.3 Measurement of outcomes

NUNNER Logistics has not received any complaints from employees, suppliers, business partners or customers in relation to any human rights violations, nor has it been involved in any investigation, legal case or incident involving human rights. With the Code of Conduct a specific contact and email address of the Compliance Office has been published. It can be addressed by every employee in case of questions or insecurities regarding the application of the Code of Conduct. Until 12.10.20197 no mails or communication about non-compliance with ethic objectives have been received, even after explicitly encouraging our staff to report on this if applicable.

#### 2 Labour

# 2.1 Assessment, Policy & Goals

All working conditions are defined not only through our detailed Human Resources handbook, but the legal framework is also given, where applicable, through the Dutch logistics union guidebook covering all work related topics like wages, working hours, benefits, workplace health & safety, etc. In addition to that we strive continually to assess our employees' skills, goals and training requirements and to provide guidance or training to support the personal development of each individual. Every single employee of NUNNER Logistics receives a minimum of 80 hours of training per year.

## 2.2. Protection against disease

Since the beginning of 2020, we have been living around the world with COVID-19. It is of the utmost importance to NUNNER Logistics that its employees are safe. Allthough currently no governmental restrictions are in place in the countries where NUNNER is established we keep a close eye on the development and will, in case it is necessary, take our own measures pro-actively. Following measures are in place to keep our employees safe for COVID-19 and other epidemic and pandemic diseases. Some of these measures are to allow employees to work from home wherever possible, to wear masks when moving around the office and the 1.5 meter distance rule is mandatory. Of course in addition to frequent hand disinfection. External and internal meetings are kept to a minimum and where possible replaced by Microsoft Team Meetings. NUNNER Logistics keeps a close eye on international developments and will issue a travel ban for its employees if this is appropriate.

## 2.3 Implementation

Since 2012 every staff member on all levels is trained in the NUNNER Total Performance Academy (warehouse staff, office staff, managers and directors). All office and warehouse employees have completed the course and have reached the level of MBO (Middelbaar Beroeps Onderwijs; "middle level applied education"). Employees that are already qualified for MBO have the opportunity to complete the HBO-level (Hoger Beroeps Onderwijs; "higher professional education") This qualifies them for a professional master program in the Netherlands. The company offers for all employees regularly professional, specific work-related training courses that are held during or right after office hours in the company offices. All employees get updated new causes to stay aware of new developments and knowledge. In autumn 2018 a new training started on the newly implemented agile



scrum structure in the company (see 2.3) New employees are offered the same educational opportunities. In spring 2019 the "NUNNER Learning & Development Centre was launched and repeated at least once a year. This is a new training for all levels of employees on lean working methods, customer service orientation, leadership and many other topics. This new inititiave was very well received by all staff. Moreover we have introduced a KPI on absence because of disease and are working together with our employees on improving their health.

# 2.4 Agile Scrum

NUNNER Logistics HQ works via the agile scrum method. The company is structured in socalled squads, chapters and tribes. The squads are self steering multidiscipline units that are responsible for as well their squad result as the total entities result.

The job satisfaction and the performance are high at NUNNER. In order to improve the efficiency of the squads all staff is trained at least once a year.

NUNNER sees optimization of the company as an ongoing process to keep ahead of the competition and to keep her stakeholders satisfied. The project had a very positive impact on our human resources and lead to an overall high satisfaction of our employees. Via the new initiatiative "NUNNER learning and development centre" the skills are continuously further finetuned.

## 2.5. employees well-being

NUNNER Logistics is growing fast at multiple locations. The well-being of our employees is put central to the design and the interior of our builings. E.g. at our corporate HQ, a ventilation system has been put into use that refreshes the air in the building twice an hour, every employee has space of approximately 30m2 per employee, there is a professional fitness room in the building, a cozy company cafe, a large canteen with terraces etc.

# 2.6. Personal Development Program

To further improve the personal growth of its employees NUNNER Logistics has launched a new improved personal development program that started in 2021. Here employees have multiple moments per year that they sit with their manager and with HR to discuss developments on their jobs and their way of working. The focus of this program is even more on the talent of people and letting employees do what they do best

# 2.8. UNGC Young Professional Program

NUNNER staff has joined the Young Professional Program, which is a one year during program of UNGC Netherlands where a group of young professionals from different companies join their forces to develop a project which will contribute to the 17 Sustainable Development Goals (SDGs). In this program the young professionals develop their own leadership, learn a lot about the SDGs and how they can influence their own working environment to even further implement the SDGs. The project this group has started is in cooperation with the researchers of the stakeholder inclusion investigation, which was presented at the UN Global Compact Leader Summit in June 2021. The research and the project focusses at first al SDG 17, partnership. By making companies aware about how engaging with stakeholders can improve their own businesses but also achieve the SDGs.

# 2.7. Integration of minorities

NUNNER logistics is actively promoting to contract employees from different cultural back grounds. In that respect 15% of the employees in the Netherlands is from Polish origin. To make them feel at home and to show NUNNERs appreciation towards them NUNNER organizes Polish events on a regular basis. On this kind of parties all employees in the Netherlands were invited (not only the Dutch) to promote integration.



#### 2.8 Measurement of outcomes

NUNNER Logistics has not been involved in any investigations or legal cases related to the UN Global Compact Labour principles and it has not been subject to any health and safety statutory notices in the last year. Despite the challenges that logistic companies are facing, the average duration of employment at NUNNER is, despite its relatively young staff, > 10 year, which we regard as a clear sign of workforce stability and mutual trust

## 3 Environment

#### 3.2 ISO 26000

In july 2015, NUNNER Logistics implemented all ISO 26000 guidelines into the organization which lead to a socalled self declaration ISO 26000. This self declation has been approved and registered by NEN (Nederlandse Eenheids Norm) beginning of October 2015. The declaration has been prolonged in April 2019.

## 3.3 Assessment, Policy & Goals

NUNNER Logistics has a detailed environmental policy that is communicated to staff, customers, suppliers and other stakeholders on all levels. Focus on sustainability is a fundamental part of the company's mission and vision. It is lived throughout the company and is present at all levels.

## 3.4 Implementation

NUNNER is member of Green Freight Europe, an initiative of European shippers and transport companies that aims for creating a neutral platform for analyzing and evaluating GHG-emission measure and reduction initiatives. NUNNER is participating in several workgroups and sends delegates to various meetings and exhibitions to be up-to-date about new developments in the logistics market. NUNNER operates a subcontracted fleet of more than 1.500 trucks, of which > 80% isl classified according to the latest lowest emission classes Euro VII. All subcontractors are regularly audited on a regular basis. Moreover all subcontractors mandatorily need to report on the emission classes utilized in their fleet and the fuel consumption based on actual figures. Fuel consumption is reported on a monthly basis and the composition of the subcontractors' fleets biannually. The outcome is captured in a trend graph for all main customers and reported and analyzed in business reviews NUNNER moved one of its X-docks in 2014 to the distribution facility of one of its major customers in a common effort to reduce truck movements between the distribution centre and NUNNERs X-dock. This has led to a tremendous reduction of the carbon footprint for this particular customer. Furthermore NUNNER is actively promoting intermodal solutions. By its rail initiatives between China and Europe v.v. we could actively reduce tonnages of airfreight leading to less carbon footprint.

# 3.5 Fighting climate change by Carbon footprint reduction

In the Netherlands, more than 400,000 m2 of NUNNER buildings are filled with solar panels by the end of 2022. With this, NUNNER in the Netherlands has turned from an energy consumer to a producer of energy. NUNNER produces more energy with its buildings than they consume.

## 3.6. Fighting climate change by supporting the Black Jaguar Foundation.

NUNNER is a huge supporter and sponsor of the Black Jaguar Foundation that plants new native trees in the Araguaia corridor in Brasil restoring the lungs of the earth and restoring biodiversity.



- 3.7. We value the opinion and ideas of our employees. As of 2022 we actively include our staff in our ESG strategy.
- 3.8. this year a socalled zero measurement will be done on our emissions. Based on this we annually will set ambitious but achievable goals

## 3.8 Measurement of outcomes

We promote and support environmentally friendly modes of transport, such as rail, barge and short-sea, and we achieved Co2-emission-savings in several areas and for various customers.

#### 3.9 External audit

At December 19th, 2015 NUNNER Logistics received the a rating of its audit by independend auditor ECOVADIS on the overall Corporate Social Responsibility. The average in the industry is 41,5 points. NUNNER reached a level of 62 (!!) points which ranks us amongst the 5% most corporate social responsible companies. This made us a GOLD rates company, which is a big achievement. In 2022 Nunner Logistics will audited again for Ecovadis, which audits the overall Corporate Social Responsibility score of companies. The current score is 66 points which ranks us again amongst the 5% most corporate social responsible companies. NUNNER has a GOLD rating with this score, which is a great achievement especially within the industry.

# 4 Anti-Corruption

# 4.1 Assessment, Policy & Goals

NUNNER's Code of Conduct makes a clear statement: Bribery and Anti-Corruption "Many countries have bribery and other anti-corruption laws that are intended to prevent companies and individuals from gaining an unfair advantage and from undermining the rule of law. We must never offer or accept bribes or kickbacks, and must not participate in or facilitate corrupt activities of any kind. This prohibition on offering or paying bribes also applies to third parties acting on NUNNER's behalf, such as contractors or consultants. We must never engage a third party who we believe may attempt to offer a bribe to conduct company business."

It addresses detailed guidelines on related topics, such as e.g.:

- Direct and indirect bribery
- Gifts and invitations
- Expenses, donations, charitable benefits and sponsoring
- Money laundering
- Market abuse or manipulation

## 4.2 Implementation

The Compliance Office contact details are applicable for questions concerning any part of the Code of Conduct. As check for appropriateness, NUNNER advises employees to ask themselves the following questions when in doubt:

- Are my actions legally permitted and are they in line with the objectives of NUNNER group?
- Does my "subjective feeling" tell me that my actions are correct?
- Would I be able to justify my actions before the board of NUNNER or before authorities?



Special emphasis is made on business brokers, intermediaries and other third parties who act on behalf of NUNNER Logistics, to ensure that these principles are communicated and applied by them accordingly. This year we have implemented a Code of Conduct for our suppliers that needs to be signed before they are approved.

# 4.3 Measurement of outcomes

NUNNER Logistics has agreed Codes of Conduct with many business partners and customers, that often include clauses about anti-corruption and are always accepted and signed by the management. National rules of anti-corruption are strictly monitored by Dutch tax authorities. NUNNER Logistics has never been involved in any investigations or cases of corruption or bribery. Until now, no suspected breach of rules has been reported to the NUNNER Compliance Office.
