

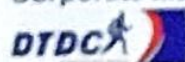

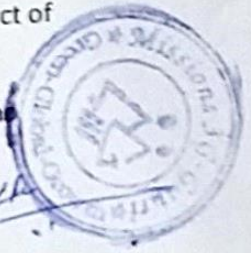
Response:
