Our first production site was developed in India back in 2015, where we benefited (and continue to benefit) from the country's vast coconut reserves. Since then, Bio grow's development has been on a continuous upward scale, with an increase in production capacity and volumes (by 4), the gaining of new markets, and improvements to our entire production process. Our workforce also expanded from a mere 50 employees in 2015, to almost 250 in the high season of 2022. Nevertheless, we are continually searching for new and innovative ways to develop our business while limiting our environmental and social impact. By limiting our energy consumption, promoting responsible farming and a sustainable production model with less fertilizers and pesticides, improving the wellbeing of our employees and local communities, we hope to contribute to the management of more global issues, such as climate change.

This issue is a huge concern for us, as if coconut estates experience decreased productivity or the quality of the raw material deteriorates due to climate change, then there is no doubt that our development opportunities will be directly impacted. If we do not start to address them appropriately, and soon, these issues could well become significant risks in the future.


#### **Constructing Refurbished Staff Area**
