# Description of Actions in 2021

## Human Rights

- We only work with growers/suppliers that share our company values and ethical business practices. This is established by way of auditing prospective suppliers/growers.
- On top of this we have expanded and improved upon our auditing functionality. This year we have also included questions relating to Indigenous touchpoints in our supplier questionnaires.
- We have taken our first steps towards implementing an Australian Reconciliation Action Plan (RAP).
- We have added to our HR policies with a dedicated Anti-Discrimination Policy. While this was previously part of our Bullying and Harassment Policy it is now a standalone policy.
- We have participated in the Global Compact Network Australia (GCNA) Human Rights seminars.
- We have made several revisions to our Covid-19 policy to account for vaccinations (employee and facility visitors), employee travel restrictions.

#### Labour

- Down Under Enterprises maintains ~50% female staff employed.
- We have established labour KPIs for accidents, employee training and employee social benefits. Tracked and reported annually.

#### Environment

- Transitioned from HDPE packaging to Aluminium packaging. 100% of product packaging is now recyclable or reusable. Committed to recycling throughout our business. Communicated this in our newsletters and our blog on website.
- Planted an additional 500 non-production trees at our farm as part of our Koala habitat establishment initiative, now at over 2500 trees in total.
- Conducting R&D on Hydrosols to productise this waste product to prevent it being released into the environment.
- Repurposing waste biomass into a compost-fertilizer for the farm with a vision towards a complete zero waste-stream manufacturing process for our products.
- We have established environmental KPIs for waste, water and energy. Tracked and reported annually.

- Rainwater harvesting and irrigation on our farms.
- 100% renewable energy in our offices and our farms.
- We have implemented electric-lawnmower maintenance at our farm, eliminating this requirement for fossil fuels
- Repurposing waste product (Hydrosol) to prevent it being released into the environment.

### Anti-Corruption

- We manage all our external parties according to our Anti-Corruption Policy.
- Worked with Australian Trusted Trader (Australian Federal Government Border Force) to implement a corrupt practices risk assessment.
