## BAU IN THE TIMES HIGHER EDUCATION



BAU participates in the Times Higher Education (THE) Impact Rankings since 2019. According to the current rankings, BAU belongs to the **601-800 band in the World University Rankings**, the **401-600 band in the Impact Rankings** and the **251-300 band in the Young University Rankings**. Also, BAU is **ranked among the top 5 universities in Türkiye**.

The university continuously increases its standing in categories related to the UN Sustainable Development Goals. As of 2022, BAU holds the following standings in the THE Impact Rankings;

- Ranks between 101-200 in Industry Innovation, Infrastructure
- Ranks between 201-300 in Gender Equality
- Ranks between 301-400 in Reducing Inequalities
- Ranks between 301-400 in Peace, Justice and Strong Institutions
- Ranks between 301-400 in Sustainable Cities and Communities

The University takes the above-mentioned rankings as evaluation criteria for progress regarding its adherence and contribution to the UN Sustainable Development Goals and will continue to report its advancement in the rankings on a yearly basis.

## BAU'S COVID-19 RESPONSE AND BEYOND

In accordance with the Presidential Decree in March 2020, all face-to-face educational activities in universities in Türkiye were halted and online education had started. Following the decree, BAU's Covid-19 Scientific Advisory Committee was established under the chairmanship of the Vice-Rector and with the participation of the members of the BAU Faculty of Medicine. The committee planned and managed all the precautionary measures and immediate actions against Covid-19 within the University.



To ensure the medical and social protection of all BAU members as well as the academic proficiency of our academics and students, the following actions were taken:

- BAU's "Covid-19 Protection Guide" was prepared and shared online with the BAU community (students, the academic and administrative staff).
- A rotational shift working system was adopted starting in April 2020 and gradual back-to-office was implemented in June 2020.
- In order to create the best remote learning environment for BAU students, online training sessions on how to integrate online education and assessment tools into virtual classes were held with the participation of BAU's academic staff.
- To create awareness about the protection measures against Covid-19 among BAU's academic and administrative staff, online training sessions were organized and held, notification posters were posted, and training videos were aired via University's digiboards in all BAU campuses.
- All the physical facilities (classes, offices, common areas, conference halls, labs, etc.) of the University were redesigned in accordance with the social distancing requirements, regular sanitization and disinfection routines were secured, and air-circulation guidelines were implemented.
- In collaboration with the Istanbul Governorship and the District Health Directorate, a vaccination center in the service of BAU students, academic and administrative staff members was opened.

## BAU'S COVID-19 RESPONSE AND BEYOND

- Throughout the pandemic, BAU Psychological Counseling and Guidance Center took an active part in assisting academic & administrative staff and students in motivational and psychological issues.
- In order to inform students on education related issues, campus entries, exams, etc. and direct them to the units in charge, an Instant Support Line was launched.
- The Faculty of Educational Science conducted a comprehensive study on the post-pandemic school adaptation process, the existence and/or efficiency of adaptation programs, the difficulties experienced during this process, and opinions and suggestions for coping with the difficulties. The survey method was implemented, and the questionnaires were answered by 3,625 students, 1,822 teachers, 5,336 parents and 151 school administrators.

# **SUSTAINABILITY at BAU**



## BAU'S SUSTAINABILITY STRATEGY AND VISION

In accordance with its vision, BAU aims to contribute to society in the production of information and technology in the fields of engineering, architecture, social sciences, health and art.

In this direction, the social contribution policy of our University;

- To contribute to society at local, regional, national and international level with its outputs by developing cooperation with its stakeholders in education and research activities,
- To educate students as individuals who can think holistically, have a global perspective, respect cultural and ecological values, and are sensitive to the environment through experiential learning,
- To create economic, social and environmental contribution process that increases its multi-disciplinary programs, creates innovation through national and international collaborations, attaches importance to the fact that graduates are business creators with the potential to change and transform their professional choices in a way that contributes to development, and to ensure continuity by implementing the process.

As of 2022, a Social Impact and Responsibility Commission under the jurisdiction of the BAU Rectorate was established in order to develop sustainability and social responsibility strategies, coordinate and evaluate their implementations within and outside of the University. The Commission's actions will be in line with the goal of "achieving excellence contributing to society" as one of the main pillars of BAU's vision of being both an educational institution and a good corporate citizen. In addition to the representatives from all relevant academic and administrative units of the University, 4 student representatives will also work as commission members. An external stakeholder advisory board is established to address the issue of sustainability from a broader perspective.

Also, the Social Impact and Responsibility Application and Research Center has been activated in 2022 and has started to work in coordination with other relevant units in the process of carrying out activities focused on sustainability and social impact. The Center, will follow the main framework developed by the Social Impact and Responsibility Commission, and CIFAL functions as the main unit responsible for carrying out sustainability and social impact activities.

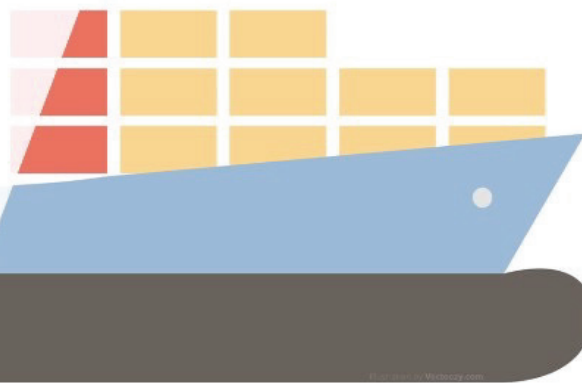

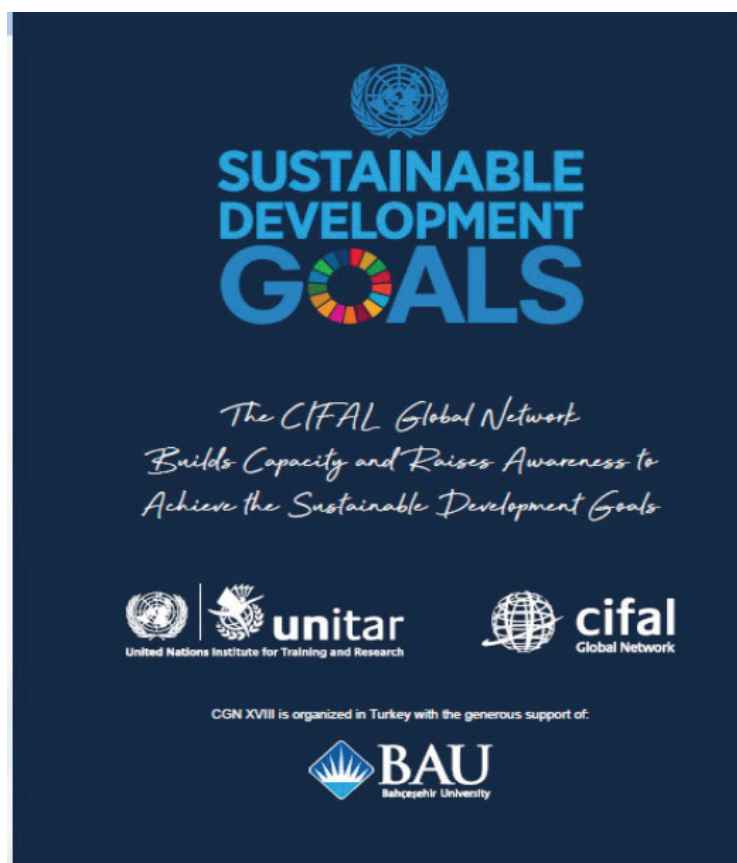

### The Launch of CIFAL Istanbul Youth Platform (7 December 2021)

The objective of the CIFAL “Istanbul Youth Platform” (IGP) is to create awareness about the UN Sustainable Development Goals and to contribute to their adoption and internalization among university students. Members of the Platform will create their own ideas, develop projects and undertake joint actions with the UN. Also, they will be encouraged to apply for internships, education and training programs in the UN organizations, and they will be able to participate in CIFAL Istanbul’s certificate programs on the Sustainable Development Goals (SDGs). All BAU undergraduate and graduate students have the right to be a member of the platform.

IGP has five purposes: (1) To create awareness about and develop a sense of ownership with regards to the United Nations system, its institutional structure and agenda among BAU students, (2) to raise awareness about the UN SDGs among youth, (3) to contribute to the skill development of future mediators and decision makers who empathize with other cultures and societies, are reliable, have credibility, create a sense of trust, are fair and understanding, (5) to support young people to show the courage, patience and balanced attitudes necessary for international cooperation as well as to help them develop a sense of time, harmony, persistence and creativity which are instrumental in designing lasting peace and prosperity for global society and the planet.

## HUMAN RIGHTS

### BAU 2020 DECLARATION OF POLICY-MAKING GOALS

At BAU we are committed to creating productive learning and working environments for all BAU community members, thus serving as a model for society. In order to achieve and maintain such a culture, we prioritize forming a diverse and inclusive environment, free from all kinds of discriminatory and violent behavior. Academic freedom is to be able to provide education without any restriction, to choose freely from research and publishing fields to ensure that ideas are expressed as desired and not to be exposed to censorship by the institution it is affiliated with.

### CENTERS, LABS, COMISSIONS, UNITS & PROGRAMS

#### BAU Commission for Equality and Inclusion Studies (BAUEQUAL)

BAU Commission for Equality and Inclusion Studies (BAUEQUAL) was established in October 2020 with the mission of developing an egalitarian and inclusive approach in all activities and processes carried out by BAU. To date, BAUEQUAL examined local and international models and identified the steps to be taken to create a nonviolent campus life and an egalitarian and inclusive education and work environment. In this respect, panels, in-house training programs, workshops with BAU student clubs and campus wide activities have been planned.

A specific training module by BAUEQUAL had been integrated into the orientation and life skills education program of the first year BAU students. The training module included gender equality and gender studies courses offered by BAU Department of Sociology and BAU General Education Unit. At the academic level, gender equality, gender sensitive course design and inclusivity training are provided for the BAU academic staff.

BAUEQUAL's action plan includes conducting research, developing projects and policies that contribute to BAU's DE&I (Diversity, Equity & Inclusion) agenda within and outside of the University.

#### BAU Sexual Harassment and Assault Support Unit

BAU is dedicated to creating an equal, free, democratic, and safe learning and working environment for its community. To achieve this goal, the University clearly declares its determination to prevent and fight against gender-based discrimination and violence, harassment, and assault within the university. In this context, BAU Sexual Harassment and Assault Support Unit was established in 2022 and its directive and policy statement were publicly shared. The Unit is the designated entity when any individual within the University is subject to or the witness of acts that fall under the definition of gender-based, sexual, and psychological violence and discrimination.

What to expect from BAU Sexual Harassment and Assault Support Unit:

- The prevention of sexual harassment and assault acts that take place in BAU's working and learning environments or that occur outside yet affect the working and educational activities within the University,
- The management of support processes such as informing and guiding the applicants who are exposed to such acts,
- The administration of the follow-up procedures when such actions are the subject of administrative (disciplinary) and/or legal processes.

### BAU Unit for Students with Disability

The mission of the BAU Unit for Students with Disability is to provide students with different disabilities and needs equal access to learning environments as well as academic resources, activities, and programs. The Unit works to ensure that all aspects of student life are welcoming and inclusive for BAU students with visible or invisible disabilities through academic accommodation, assistive technologies, and adapted classroom activities.

### Human Rights and Freedoms Application and Research Center (Faculty of Law)

The Human Rights and Freedoms Application and Research Center aims to carry out societal awareness activities in the field of human rights and fundamental freedoms, to provide expert opinion on human rights related issues, to prepare amicus curiae (court-friendly expertise) in the field of human rights within the scope of the provisions of the relevant legislation, and to contribute to the scientific knowledge both nationally and internationally.

In the upcoming period, the Center will prioritize two areas of action:

1. The social problems faced by immigrants and refugees, which concern both the global and the local agenda.
2. Violence against women, children and different gender identities.

### BAU Gender Law Clinic (Faculty of Law)

BAU Gender Law Clinic's main area of work involves gender and all gender-based discriminations. First in Türkiye, the Clinic carries out activities to prevent gender-based discrimination in all forms by way of deepening students' knowledge on Turkish and international law, organizing educational conferences and panels, conducting research, developing content for public awareness with the active participation of voluntary law students. BAU Gender Law Clinic welcomes applications from top-class law students who have taken the Family Law course as a prerequisite. Students work under the supervision of clinical lawyers to provide representation to individual clients. This clinic also contributes to removing barriers that hinder women's access to civil justice.

- **“Gender of the Law: Gender-Based Violence and Impunity Culture” Seminar (26 October 2021)**

## BAU Center of Migration and Urban Studies (BAUMUS)

BAU Center of Migration and Urban Studies (BAUMUS) began its activities in 2014. The Center has branches in Berlin, Washington, Gaziantep, Antakya and Urfa and a partnership with BAU International Berlin Research Institute. The objective of BAUMUS is to develop research models that use theories and data to suggest realistic proposals in migration and urban studies. Instead of limiting the scope of projects to produce theoretical knowledge, we aim to create applicable suggestions and practical solutions.

BAUMUS holds public talks, conferences and symposiums related to the Center's research to foster progress for individuals and institutions with complementary interests. ### “Migration and Domestic Workers during the Pandemic” Workshop (5 October 2022)

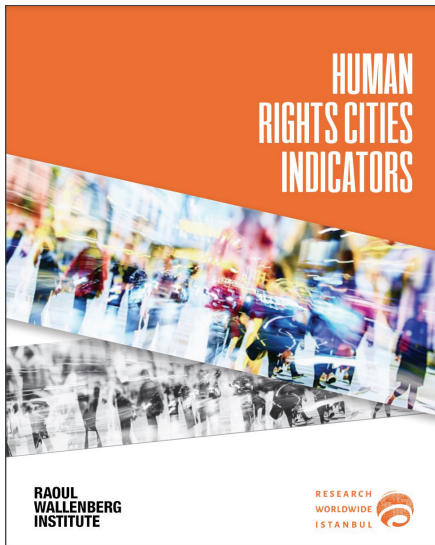

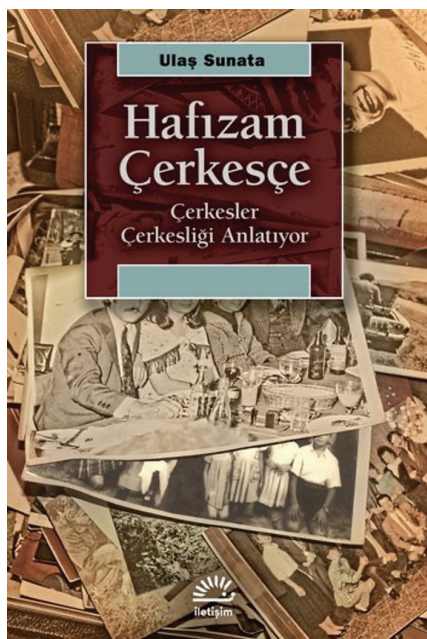


### “Human Rights Cities Indicators” Book (2021)

The “Human Rights Cities Indicators” project was jointly initiated by the Raoul Wallenberg International Institute of Human Rights and Humanitarian Law under the Faculty of Law of Lund University in Sweden and the Union of Turkish World Municipalities and seven pilot municipalities. It was developed within the framework of cooperation with the Union of Municipalities of Türkiye and the Council of Europe. An open-source book has been published in 2021, aiming to present the “Human Rights Cities Indicators” study that was conducted within the scope of the project. The book includes a section on Refugee Indicators written by BAUMUS Founding Director Prof. Ulaş Sunata.

### “My memory is in Circassian: Circassians Narrate about Being A Circassian” Book (2022)

Prof. Ulaş Sunata met with Circassians from different age and gender groups and rural and urban regions with varying political opinions. They reflected upon their personal perceptions of what it is to be a Circassian. “Hafızam Çerkesçe” was born out of the TUBİTAK project that was implemented in 2014 and was based on intense field work and oral history study.

### “Feminization of Refugee: Intersectionality, Solidarity, Resistance” Article (25 February 2022)

The article by the founding director of BAUMUS Prof. Dr. Ulaş Sunata and BAUMUS student assistant Selin Özsoy was published in the International Migration. This study aims to examine a possible change of feminist civil society pertaining to inclusivity with a particular interest in violence. It evaluates state-civil society relations, coping mechanisms with domestic violence and solidarity patterns with female refugees.

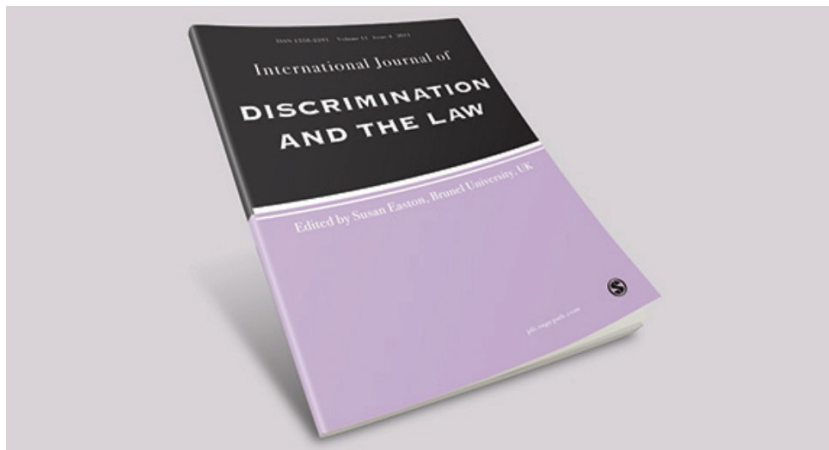

### “Legal Gender Recognition in Turkey” Article (January 29, 2022)

The article by Prof. Ulaş Sunata, Prof. Aslı Makaracı, Assoc. Prof. Dr. Seda Öktem Çevik was published in the International Journal of Discrimination and the Law. The study deals with the regime of legal gender recognition in Türkiye first reveals critical reciprocating historical developments in national legal regulations for affirming trans identities. Then, the recent conditions laid down by the 2017 Constitutional Court judgments stating that transgender people do not require permanent sterilization anymore but require sex reassignment surgery for legal gender change are evaluated. Moreover, this paper explains that while the jurisprudence of the European Court of Human Rights partly reflects the current Turkish legislation, it is not a big step for transgender rights.

## BAU Entrepreneurship Ecosystem & Centers

The University's entrepreneurship ecosystem BAU HUB supports entrepreneurs and startups during their entrepreneurial journey from idea to growth and commercialization stages. BAU HUB consists of five main programs: BAU HUB Incubation, BIZ Lab, BUG Lab Tekmer, EDU Lab, and HUB Belgium.

**BAU Hub Incubation Center:** The incubation program provides one-to-one support to the commercialization processes of technology-based startups and offers office facilities at BAU Kemerburgaz and Beşiktaş campuses. The Center's support strategy entails tailor-made solutions in areas such as project writing, product development, intellectual property rights, sale and marketing, business development and mentoring.

**BIZ Lab:** A pre-incubation program where we accelerate the business model and product development processes of early-stage startups and enable them to become a company.

**BUG Lab Tekmer:** BUG Lab (BAU Game Lab) is the leading gaming structure of BAU in terms of its contribution to the revival and development of an independent game industry in Türkiye. The Lab introduced firsts to Türkiye with its Game Design Master's program (Master BUG) and the Digital Game Design Undergraduate Program (BUG Jr). Under BUG Lab umbrella brand, there are BUG Berlin which is considered as the European game stage and activity center, the game production house BUG Pro, and BUG Kitchen that functions as a pre-incubation center for various game projects.

BUG Lab has a new component called TEKMER (Tech Centre) which is a title given and funded by KOSGEB (Small and Medium Industry Development Organization). BUG Lab TEKMER serves as a gaming-focused tech sandbox running pre-incubation and incubation programs. Studios and initiatives from the gaming ecosystem are supported and offered offices and spaces at BAU Galata Campus.

**EDU Lab:** It is a special program through which BAU and Bahçeşehir Uğur Educational Institutions (BUEK) partner with educational technology initiatives. The Lab supports initiatives as the first customer of innovative technologies and products. Within the program, entrepreneurs' innovative ed-tech products are tested in the field, the Lab provides feedback and development suggestions from the customer's perspective with expert technologists.

**Hub Belgium - Leuven BAU Innovation and Entrepreneurship Center:** The Center is operating at KU Leuven Technoparc in Belgium and serves as the gateway for Turkish entrepreneurs who are actively looking to grow and scale in Europe. It provides one-to-one support and office opportunities to startups that aim to do soft landing in the European market.

### Azerbaijan Agricultural Experience and Knowledge Sharing Mission Meeting (26 October 2021)

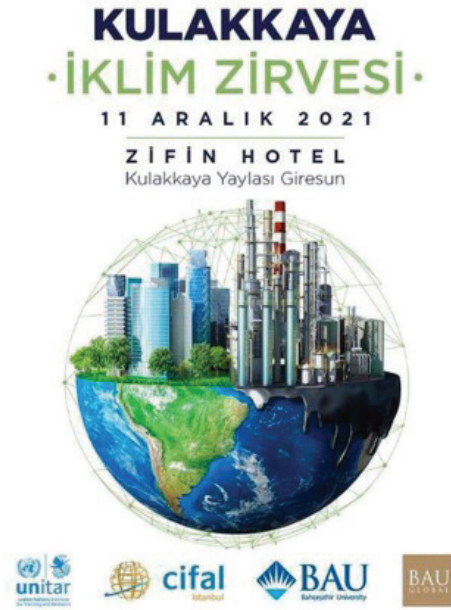

### Events, Projects and Activities by BAU Faculties and Departments Between 2020-2022

#### Animal and Nature Law Lab under the BAU Faculty of Law

Animal and Nature Law Lab examines and researches the legal status of non-humans and works on animal and nature law with the support of voluntary students. Its areas of focus involve animal rights, green constitutional order, climate focus and the right to a healthy environment. The Lab aims to organize reading and discussion meetings as well as debates with students, to search and archive resources, to conduct research and to provide resource support to researchers, to write reports, to compile decisions made in animal and nature-related cases in our country and abroad. The Lab will carry out academic activities such as providing legal support to lawyers, preparing amicus curiae for courts, translating news and academic studies published in foreign languages and publishing them online or in print, organizing various conferences, panels and interviews.



#### “Elazığ Shelter Case” Online Talk (23 January 2022)

The online event was held on Instagram with the participation of the lawyers of the Elazığ Animal Shelter Case. Before the new hearing of the ongoing case, the proceeding process and its content was discussed.

#### “Animal Law” Online Training (30 March 2022)

This online training focused on the problems related to animal rights in Türkiye. Within this context, discussion topics such as violence against animals, systematic torture, industrial animal husbandry, hunting, zoos and dolphin parks were examined. Information was shared on potential and ongoing animal lawsuits.

### “Litigation in Animal Law” Online Training (5 May 2022)

In this online training, participants gained awareness about the procedures of opening a case in Animal Law. Over a case on willful animal murder students discussed and learned about litigation in Animal Law.



### “Sexual Violence Against Animals” Workshop (5 June 2022)

The face-to-face workshop was organized in collaboration with the Association for Struggle Against Sexual Violence and HAKIM. The training module was adopted from the “Change Begins with Me” workshop by the Association for Struggle Against Sexual Violence in order to change sociocultural misconceptions pertaining to sexual violence, to increase the reach of protective-preventive practices, to increase awareness about the individual responsibilities in the fight against sexual violence. The training was conducted by providing participants with detailed information about the types, causes and solutions of sexual violence against animals and included group exercises and presentations.

### Soilless Agriculture Practice by the BAU Gastronomy and Culinary Arts (2021)

BAU Gastronomy and Culinary Arts Program students and academics started to grow seasonal vegetables and plants through soilless agriculture as part of BAU's sustainability agenda. The students will use the products they grow in the soilless agriculture field during their practice-based classes.



### “Save Your Food” Event by the BAU Gastronomy and Culinary Arts (2022)

BAU Department of Gastronomy and Culinary Arts in collaboration with the Beşiktaş District Directorate of Agriculture organized an awareness and skill development activity called “Save Your Food”. The event aimed to create awareness among female mukhtars at the Beşiktaş district regarding different practices of reusing food leftovers and reduce food waste. The activity was also designed to motivate them to share their newly acquired knowledge among their communities.

### “Earth’n Design” Workshop by the BAU Faculty of Architecture and Design (2022)

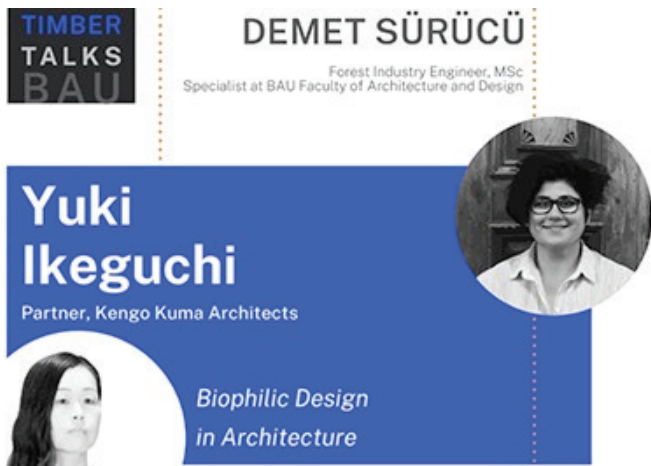

## ANTI-CORRUPTION

### BAU Corruption and Bribery Policy

BAU takes the necessary measures with its policy against forced labor, crime, bribery, and corruption that complies with Article 18 of the Constitution of the Republic of Turkey, which states that “No one shall be forced to work. Forced labor is prohibited.”

BAU, in accordance with the anti-bribery and anti-corruption Turkish Constitution; will never allow committing crimes, corruption, and bribery and will not engage in any of these activities.

- BAU Faculty of Law periodically publishes the journal “Bahçeşehir University Law Review”, which serves as the testament of our university’s principles and commitments on topics like organized crime, corruption & bribery.

### BAU Ethics Committees

BAU has two ethics committees that oversee the quality and ethical standards of research studies conducted by its academic units and members. BAU Publication and Research Ethics Committee and BAU Clinical Research Ethics Committee serve to ensure universally accepted scientific and ethical standards in the design, data collection, execution and reporting phases of the research studies/projects conducted at BAU. Both committees work to preserve the academic integrity of the researchers as well as the rights of the research participants.

### BAU’s Policy on the Protection & Preservation of Personal Data

BAU prioritizes the protection of students’ and employees’ personal data. The university shows utmost sensitivity on the protection and preservation of the collected data in accordance with Personal Data Protection Law No.6689. Within the constraints of the law, BAU decides on how to collect, process and manage personal data, hence acts as “data controller”. In line with such responsibility, the university always informs its students and employees openly and transparently through clarification texts while conducting activities that require processing of personal data.

## ANTI-CORRUPTION

### BAU Cyber Security Application and Research Center

The objective of BAU Cyber Security Application and Research Center is to create awareness nationally on all subjects within the field of cyber security, to provide consultancy to institutions and organizations, to foster skilled labor, and to conduct academic research. In line with its mission, the center carries out the following activities;

- To do research, screening, development and implementation and to establish communication infrastructures and data banks.
- To collaborate with domestic and international research and education institutions.
- To develop certificate programs, workshops, seminars, conferences, congresses on a national and international level.
- To publish solution-oriented white papers, reports, bulletins, books, articles, magazines that present scientific and technical findings of research projects and applications and to inform the public on the research results.
