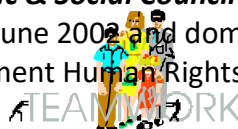

Society for Development & Community Empowerment (SDCE) is a Non-Governmental Organization with a **Special Consultative Status of the Economic & Social Council (UN ECOSOC 2011)** and a **UNFCCC Observer Organization**. SDCE was established in June 2002 and domiciled in Nigeria. Our thematic areas of work include Health, Education, Environment Human Rights, Accountability and Women Empowerment.



Aims and purposes of the organization.

Our vision is to educate, inform, motivate and inspire individuals and society to positive inspiration and aspirations, dispel human ignorance, ensure collective and sustainable global happiness for the betterment of mankind. SDCE mission is to contribute to social and economic well-being and development of families and communities and support the execution of sustainable development goals (SDGs) in Nigeria, Africa and the Globe. We achieve our objectives through constructive, pragmatic and intellectual engagement in Advocacy, Empowerment initiatives, and Public campaigns, making use of Technology as a tool in solving human problems.

Significant changes in the organization.

SDCE interaction with the United Nations has assisted to improve our governance, policy, strategic information, strengthens our management systems, develops business plan for social return, improves cross-cutting issues and build strong leadership and management skills to actualize our objectives. SDCE now has contact offices and members from **Kenya, Canada, South Africa, Switzerland, France, China, Austria and United States of America.**

Contribution of the organization to the work of the United Nations.

- a. SDCE continues to create income generation activities for indigenous women to embark on Cassava processing/ Fish/snail Farming & improve on the level of care and support for their children in Etche, Eleme, Ahoada, Andoni and Obio Akpor Local Government Areas of Rivers State- this is in support of SDGs 1 and 2 (to *"End poverty in all its forms everywhere"*, *"End hunger, achieve food security and improved nutrition, and promote sustainable agriculture"*).
- b. SDCE creates problem-solving and decision- making skills to help women assess their risk for STI/HIV/AIDS,(BCC youth friendly services , condom programming), take protective actions; and create an enlightenment forum for issues of gender discrimination and rights , promote gender equality, combats HIV/AIDS ,Malaria and other diseases-this is in support of SDGs 3 and 5(to *"Ensure healthy lives and promote well-being for all at all ages."*, *"Achieve gender equality and empower all women and girls."*).SDCE empowers women and enable them actively involved in development activities by advocacy and sensitization workshops for community, religious and women representatives and concerned bodies on gender equality, human rights (women's right) and revised family law.

Participation in meetings of the United Nations.

SDCE representatives have continuously attended the following meetings- Annual United Nations Forum on Business and Human Rights in Geneva, High-level Meeting of the United Nations General Assembly (UNGA) in New York. Commission on Narcotic Drugs(CND) and Commission on Crime Prevention and Criminal Justice(CCPCJ)in Vienna among many others from **2011 till date**. SDCE has continuously participated in the activities of the Office of the High Commissioner for Human Rights (**OHCHR**) whose mandate is to ensure universal enjoyment of all human rights, to remove obstacles to their effective implementation, and to enhance coordination and cooperation of human rights-related activities throughout the United Nations system.

Cooperation with United Nations bodies.

SDCE is a member of the United Nations Global Compact since 2013, signed a memorandum of understanding which encourages Deeper Business Engagement at UN Forum on Business and Human Rights and other international meetings. SDCE is a signatory to The Green Industry Platform and the CEO Water Mandate. SDCE promotes the Green Industry Policies and Practices which includes Improving Resource Efficiency, Strengthening Waste Management, Reduce and Eliminate waste Materials, Promote Technology Transfer and Share Best Practice, Green Value Chains and Encourage Green Industries and Jobs in Nigeria). The CEO Water Mandate promotes Innovative Partnerships in Water and Sanitation - (SDGs 6).SDCE was admitted to the **UNFCCC in 2018 and participated in COP24 in Katowice, Poland ; COP25 in Madrid, Spain, from 2 to 13 December 2019 under the presidency of the Chilean government and COP 26 in Scotland in 2021,UK** . SDCE is involved in Climate Change Education Advocacy in Nigeria and Smallholders Agriculture, Environment and Climate Change mitigation in Nigeria(SDGs 13) as well as in dynamics of Biodiversity and Loss. **SDCE** support and collaborate with other organizations on SDGs 15 of the 2030 Agenda for Sustainable Development , to “protect, restore and promote sustainable use of terrestrial ecosystems, sustainably manage forests, combat desertification, and halt and reverse land degradation and halt biodiversity loss”

Initiatives taken by the organization in support of the Sustainable Development Goals(SDGs).

SDCE observes and commemorates “The International Day Against Drug Abuse and Illicit Trafficking on the 26th of June of each year, and the World AIDS Day on 1 December of each year in Port Harcourt , Nigeria. SDCE promotes the Digital Literacy Curriculum (Microsoft) and the E-Learning for Kids Program in Nigeria among schools and in rural communities without internet access. SDCE has been receiving capacity building and Training from UNODC Nigeria on Community Drug Dependence Treatment Services in Nigeria(Response to Drugs and Organised Crime in Nigeria) for 2015 to date. SDCE is committed to

- **Technology** - development of climate-friendly modern solutions, such as electromobility;
- **Man** - solidary and just transition of industrial regions;
- **Nature** – supporting achieving climate neutrality by absorbing CO2 by forests and land, or by water management.

SDCE will establish contact and engage with Global Compact Local Networks in this regard.

SDCE is currently providing access to modern agricultural inputs and technologies (techniques, implements, processing machines, fertiliser, agro-chemicals, improved seedlings, knowledge) to 100 target youth and women farmers in cooperatives, enhance their productivity and increase incomes. The Project will enable the target youth and women farmers improve farming systems through increased local incentives (snail/rabbitry/goat farming/cassava processing inputs and technologies) and benefits to maximize crop/animal yield and improve income. To ensure environmental sustainability in the gas flaring community of Rumuekpe, 30,000 trees will be planted. The project will strengthen agricultural value chain (inputs supply, production efficiency through - knowledge sharing, peer review, mentoring, exchange visits, value addition in processing and product standardization, marketing, transportation - inputs and products, regular weather updates and forecast, advocacy on responsible farming practices. 100 target youth and women farmers will receive agric technologies package, agricultural performance data, strategic communication, literacy, entrepreneur & business development education via the Reorientation & Resource Development Centre (**RRDC**) that is created. 5,000 community children will have access to ICT education via the Resource Centres (**RRDC**). (SDGs 1,2,4 &13). **THE GREEN DELTA PROJECT OF SDCE** —Sensitize stakeholders about climate change and stimulate 30 local youth and 100 farmers to embark on a reforestation programme using Indian Bamboo, rattan Aloe Vera. (Aloe vera) Chrysanthemum. (Chrysanthemum morifolium) in Rumuekpe, Rivers State, Nigeria.
