## Part II. Description of Actions

During the last two years, the Institute engaged in several activities that promoted the UN Global Compact Principles, among them we highlight:

- > We engaged with the local Global Compact Network in different ways, including joining the workshops and regular meetings of the thematic groups.
- > More than once, we contacted the local team of the Global Compact inviting them to collaborate in specific projects we developed and implemented. Unfortunately, we did not have the chance to work closely, but we remain at your disposal whether you understand the convenience of collaborating.
- > Our projects also developed and implemented actions to foster the SDG's comprehension in companies and multinationals, delivering human rights and business trainings to hundreds of leaderships.
- > We invited companies and other relevant actors that are part of the local Global Compact network to take part in specific projects developed and implemented by the Institute, in order to foster collaboration and nourish the network.
- > Partnership with Mackenzie University in Sao Paulo, Brazil, and also with community based projects to deliver education on SDGs and human rights to dozens of youth.
- > Finally, in convenient occasions, we promoted the Global Compact network and encouraged companies that hired our services to take part in the movement.
