- Through the good examples shared in the Sustainability Governance Scorecard, we trigger development by increasing companies' learning from each other.
- With the Sustainability Governance Scorecard, we measure companies' approaches to Sustainable Development Goals and share their progress.
- With our "Good Governance For Children" project, we focus on SDG 4: Quality Education and SDG 11: Sustainable Cities and Communities to contribute to children's behavioral and cultural development.
- Through the activities carried out by our Youth Network, we work on SDG 4: Quality Education and SDG 11: Sustainable Cities and Communities. We mobilize individuals and institutions on a voluntary basis.
- With our Integrated Municipal Governance Model, we contribute to the continuous development, sustainability, and quality of life-oriented activities of local governments.
- With the Metropolitan Municipality Governance Scorecard, we conducted research on how activities are carried out in health, environment, safe living, participation, housing, employment and income, personal development and welfare, social policy, and other issues in 27 metropolitan cities in Türkiye through a unique model that can be used by all municipalities both in Türkiye and worldwide.
