With more than two decade of working towards the cause of socio—economic upliftment of the downtrodden, AROH has marked its presence in 18 states of India, ranging from remotest locations of Meghalaya, to Naxal impacted red corridors in Chhattisgarh and Orissa, to aspirational districts of Sitamarhi, Bihar and has led to the socio-economic alleviation of more than a million people.

- AROH has set up set of policy and protocols, formed vigilance teams of experts to prevent any forced or compulsory labour law violation, child labour, workplace harassment, etc. both at work offices and on field.
- AROH also has set up quick redresser committees, which addresses and acts quickly through online and offline support model.
- Gender disparity is being addressed through pre- assigned women quota for all interventions of Skill
 Trainings, Livelihood Generation, Capacity Building, Awareness or Advocacy for secured, dignified and
 sustainable lives of the female section.

• Ladies and girls are also empowered through workshops on workplace rights, laws and corresponding actions. Adult literacy & Financial & Digital literacy classes are ensured

- AROH has been working extensively towards sustainable development, which ensures a precautionary
 approach towards environmental challenges and promote greater environmental responsibility with
 optimized use of natural resources, eco-friendly technology and inculcating considerate human behavior.
- Promotion of Renewable Energies like Solar is done on a large scale to facilitate basic necessities Water, Cooking, Power and Agriculture.
- AROH has promoted sustainable environment by taking up large scale awareness campaigns on safe water, sanitation, health and hygiene, etc. Solar water pumps, Solar street lights, Individual latrines to eliminate open defecation and awareness on 3 R's (Reduce, Recycle and Reuse) is put in place in the working communities for efficient ways of disposal of waste leading to less environmental damage.
- Revival of natural resources like Pond Rejuvenation for environment & livelihood, promotion of Rain Water
 Harvesting structures and renovation of Check Dams to optimize water usage in arid areas has been major
 highlights of the sustainability mission of AROH.
- Also to reduce carbon emission & deforestation and also to ease out hassles of cooking, logwood chulhas
 are replaced by Bio Mass Chulhas and Bio Gas plants.
- Organic methods of agricultures, fodder and manures are promoted, Organic Nutritional Gardening units
 are set ups, low water consuming techniques like drip irrigation are demonstrated which ensure health,
 hygiene and sustainable eco system.
- Apart from these interventions, extensive awareness drives on health, hygiene, WASH, CLTS and plantation
 drives are conducted so that all physical interventions make actual & sustainable impacts by responsible
 human behaviors too.
