The Union of Mediterranean Confederations of Enterprises (BUSINESSMED) is a regional organization which gathers 25 Confederations of Employers' Organizations from 18 countries of the Northern and Southern shore of the Mediterranean. Created in 2002, BUSINESSMED is the main representative of the private sector of the Euromed region and a privileged platform for multilateral cooperation for the benefit of the employers' confederations and a network of more than 1200,000 public and private affiliated companies, by promoting foreign direct investments and socio-economic integration in the region.

As one of the main Business Support Organization dedicated to intergovernmental cooperation in the Mediterranean, BUSINESSMED seeks multiple objectives and missions such as:

- ncreasing exchanges between the European Union and the MENA Countries.
- Drive of lobbying activities aimed at a wider participation of the private sector to the actions carried out by governmental authorities.
- Animating the main think-tank around the empowerment of women and the actors of civil society and the Euro-Mediterranean Social Partners.
- Undertaking partnership actions between business communities of the region through the participation in institutional and networking events and the high-level working groups.

BUSINESSMED'S POSITION TOWARD GLOBAL COMPACT

BUSINESSMED actively advocates the ten principles of the United Nations Global Compact and the SDGs. As a Euro-Mediterranean organisation of Employers' Confederations. Our mission and activities enable us to make an important contribution to overcoming some of the biggest challenges of our region.

In addition to integrating these principles into our day-to-day operations and culture, we have been making sure that the human rights principles, the environment, fighting corruption and labour standards are respected and tackled during the implementation of our conducted projects, namely:



The Pilot Project for the Promotion of Social Dialogue in the Southern Mediterranean Neighborhood- SOLiD was a three-year project (2016-2018) co-funded by the European Union. It's a pioneer programme whose ultimate goal is to promote a dynamic, inclusive and reinforced social dialogue via the development of the capacity of Trade Unions and their homologues of Employers' Associations and civil society organizations and the promotion of a civic and multipartite dialogue between the social partners in three targeted countries: Tunisia, Jordan and Morocco.

A second phase of the Project started on December 2020 for a period of 4 years.

Algeria, Lebanon and Palestine were added to the targeted countries.



Enhancing Business Support Organisations and Business Networks in the Southern Neighbourhood- EBSOMED is project co-financed by the European Union and coordinated by BUSINESSMED. More than 30 organisations from 26 countries are also affiliated to the project. The ultimate goal of this 4-year project (2018-2022) is to promote the Mediterranean Business Ecosystem by boosting investment and job creation in the region with a view to economic growth. This will be done through the strengthening of the capacity building of Business Support Organisations-BSOs in the Southern Neighbourhood Countries. More specifically, EBSOMED intends to increase the capacity management of BSOs in the Euro-Med region by improving the services offered to SMEs.









The INVESTMED project aims at addressing both economic and environmental challenges in terms of competitiveness, sustainability, internationalization and capacity to innovate, supporting new, sustainable business opportunities for young people and women in three



NATIOONS is a 2 years project financed under Horizon Europe. The project aims to facilitate the deployment of the EU Soil Mission across EU Member States and Associated Countries during most of its first 'induction and pilot' phase (2021-2025). NATIOONS acts as a messenger of the Mission, raising awareness among national and regional stakeholders, providing access to quality-checked capacity-building materials and information, spurring the discussions on the best Living Lab setups to address regional soil needs, and fostering early matchmaking for cross-regional LL clusters.



The BlueMissionMed Coordination and Support Action (CSA) will design, structure and support a well-functioning basin scale innovation ecosystem, ensuring fast progress towards the achievement of Mission "Restore Our Oceans and Waters by 2030" objectives and important impact on the society.

The project builds on, connect and structure existing initiatives and activities to disseminate and upscale solutions and mobilise relevant actors with the specific aim of addressing the Objective of the Mission, namely "prevent and eliminate pollution of our ocean, seas and waters".

BlueMissionMed will engage stakeholders from Policy, Business, Research & Innovation and Civil Society, as well as the so-called Ecosystem Enablers to synergize the actions of the Mission Lighthouse in the Mediterranean basin.









Financed by European union under the ENI-CBC MED program, MED4WASTE (Mediterranean dialogue for waste management governance) is a project which aims to facilitate new governance models for integrated and efficient urban waste management (WM) policies across the Mediterranean, with particular emphasis on organic waste and circular economy (CE).



The CREACT4MED project, which runs from 1st March 2020 to 31st August 2024, aims to enhance businesses and entrepreneurship in the cultural and creative industries (CCIs) of the Southern Neighbourhood of the EU, with a special emphasis on young people and women. The project seeks to strengthen CCIs in the region and support entrepreneurs, start-ups, and small and medium-sized enterprises (SMEs) to attract investment, create jobs, and foster inclusive economic growth. To achieve these objectives, the project aims to boost CCI businesses and entrepreneurship, empower current and potential entrepreneurs through tailored training and financing opportunities, and establish a regional CCI hub to strengthen networking, exchanges and cooperation in the sector across the Mediterranean.



The Business Country Desk is a dynamic online portal, initiated by BUSINESSMED in the framework of the EU-funded project EBSOMED, in order to boost regional economic development in the southern Mediterranean Neighborhood. 






BUSINESSMED was represented at the first edition of the International Women's Forum an event bringing together high-level representatives of the Algerian government, international organizations and financial institutions.












The seminar brought together youth and women, representatives of employers, trade unions and civil society organizations from the six project target countries.


