# Part II.

The Union of entrepreneurs of small, medium and privatized enterprises of Ukraine (hereinafter – the Union) in accordance with the Programme of action of the Council and the Executive Directorate of the Union for the implementation of the Main Directions of its Development, as well as in accordance with the 10 principles of the UN Global Compact, has focused its activities for 2021–2022 on the following aims.

# 1. Human Rights

*Principle 1.* Members of the Union (enterprises, establishments, organizations, entrepreneurs) have been assuring through its actions full support and have been respecting human rights declared by the international community.

To this end the specialists and experts of the Union, the members of the Union were actively engaged in different activities, including the ones in the framework of the projects of the International Labour Organization (ILO):

- ILO Project "Inclusive labour markets for job creation";

- ILO Project "The remuneration in Ukraine: the provision of technical assistance in order to set minimum wage and equal remuneration";

- ILO project "Towards safe, healthy and declared labour in Ukraine";

- ILO project "Approach to decent labour in Ukraine based on market systems";

- ILO project "Rights in the world of labour: Improving Ukraine's Compliance with Basic International Labour Standards."

During 2021 - 2022 the Union was actively engaged in the implementation of its own Strategy concerning the prevention of HIV / AIDS at workplaces. These were different awareness-raising activities (organization of a round table, of trainings, dissemination of information material), advocacy, etc.

In addition, during the specified period, members of the Union were engaged in different activities to expand access to voluntary and confidential HIV counselling and testing, reduce stigma and discrimination in connection with HIV status in the field of labour, reduce violence and harassment in the field of labour and advocacy for the ratification of the ILO Convention No. 190.

During 2021 - 2022 the representatives of the Union served on the tripartite commission on the following issues:

- streamlining the system of calculating the subsistence minimum;

- reviewing the level of the minimum wage in due course;

- concerning the payment of salary arrears (cash benefits), pensions, scholarships and other social benefits.

The representatives of the Union actively participated in the meetings of these commissions, in the discussion on issues placed on the agenda, in the decision-making on these issues.

*Principle 2.* The Union members declare and constantly ensure their own non-participation in human rights violations.

The Administration, the Leadership and the Association Board keep these issues under review on an ongoing basis.

The Union constantly declares and supports the guiding principles of the United Nations on Entrepreneurship in the Human Rights Matters. These principles establish the scope of the authority of companies concerning human rights not only in their own actions but also in relation to power structures, business partners and other stakeholders.

# 2. Labour relations

*Principle 3.* The Council of the Union, entrepreneurs, enterprises, institutions, organizations are members of the Union that constantly support freedom of association and recognize the right to collective bargaining.

Among the members of the Union are not only enterprises, institutions and organizations, but also national and regional level associations, including industry associations: "Ukrpyvo", "Ukroliyaprom", "Association of Styrofoam Manufacturers", Association of Hairdressers of Ukraine, etc.

The Union has been an active participant for many years in the negotiation process between the Government, trade unions and employers.

The Union members took an active part in all events (roundtables, conferences, meetings) during 2021-2022 on the discussion of issues concerning freedom of associations, collective bargaining.

Consequently, during 2021-2022. the following events took place with the participation of members of the Union:

- discussion of the prospects of implementation in Ukraine of the provisions of Chapter XXI of the Ukraine-EU Association Agreement regarding the development of public communications and social dialogue;

- round table meeting on the topic: "Do business associations need additional legislative regulation of their activities?" (May 31, 2021);

- meeting on changing the principles of work of the State Labour Service of Ukraine (State Labour) on the basis of strengthening social dialogue in the field of ensuring safe and declared labour (September 3, 2021);

- annual forum "Dialogue of civil society, business and government", during which parliamentarians and government officials discussed the priorities of institutional and economic reforms with leaders of the business community (October 11, 2021);

- business forum "Dialogue of civil society, business and government: challenges of wartime" (October 21, 2022).

*Principle 4.* The Union members actively advocate the elimination of all forced labour forms.

During 2021 - 2022 the representatives of the Union took an active part in events (roundtables, trainings, conferences, meetings) on labour migration, the elimination of all forced labour forms:

- webinar on the topic: "Come out into the light - declare labour!", presentation of the results of the information campaign in 2020. (February 26, 2021);

- tripartite validation of the "Comprehensive comparative analysis of the legislation of Ukraine in accordance with the provisions of the ILO Convention No. 190 on the Eradication of Violence and Harassment in the Field of Labour, 2019" (May 18, 2021);

- webinar on the topic of the experience of European countries in regulating labour relations (September 1, 2022);

- webinar on the topic: "Labour migration after the war: are we ready for new trends?" (September 15, 2022);

- online consultation on discussing the issue of forced labour and preventing its spread (November 29, 2022);

- a meeting of national and international experts, business representatives, employers' organizations and business associations, dedicated to preventing the use of forced labour in Ukraine (December 13, 2022).

*Principle 5.* During 2021-2022 the Union, its members actively advocated the complete exclusion of such a disgraceful phenomenon as child labour.

To this aim the members of the Union took an active part in events (roundtables, trainings, conferences) on eradication of child labour, loss of use of child labour. Over this period, the members of the Union took part in public events on children's rights protection, maternity protection and protection of childhood. *Principle 6.* The Union, its members actively advocated the elimination of discrimination in employment during 2021–2022.

The Union program of activities till 2024 in the sphere of employment envisages a range of the following measures:

- encouraging employers to preserve jobs and create new jobs;

- activation of the labour market policy with a view to its maximally rapid adaptation to the structural changes in the economy, development of human resources, optimization of labour potential of regions and country as a whole, stimulation of economic activity of the population;

- involvement of women, young people, people with disabilities and those who are dismissed from the military service, unemployed people, rural residents and town dwellers in entrepreneurship;

- encouragement of the actions that are taken by enterprises to improve labour productivity and are accompanied by an appropriate increase in employees' incomes.

During 2021-2022 the members of the Union took an active part in events organized within the framework of the following projects:

### 3. Ecological principles

*Principle 7.* In their activities the members of the Union constantly adhere to a preventive approach to solve environmental problems.

In order to promote the UNIDO and UNEP preventive environmental strategy in relation to the production processes in order to increase the efficiency of production and to reduce risks to humans and the environment, the Union together with its partners has organized a number of the following activities:

- consultation seminar on the topic: "Strategic tools for the implementation of eco-industrial parks in Ukraine" (June 23, 2022);

- extended working meeting of the Program "EU for the Environment: Green Economy" in Ukraine (August 30, 2022);

*Principle 8.* The members of the Union suggest initiatives, take part in activities aimed at introducing resource-efficient and clean production.

*Principle 9.* The Union, its members comprehensively promote the development and dissemination of environmentally sound technologies.

To this aim, the following events were held during 2019–2020 with the participation of the representatives of the Union:

# 4. Anticorruption principle

*Principle 10.* The Union, its members try to eradicate through all their actions any form of corruption, including extortion and bribery.

To this aim, the Union conducts a consistent focused work on reforming the legislation in the field of entrepreneurship, creating the optimal legislative and organizational prerequisites for the establishment and implementation of the entrepreneurial activity, growth and development of small and medium enterprises.

The Union agrees that it is necessary to introduce simple, convenient and comprehensible registration and permissive procedures in Ukraine that will provide favourable conditions for reporting real business and corruption erosion.

During 2021-2022 members of the Union participated in the following activities:

- meeting of the discussion working group to discuss the anti-corruption educational video course project for small and medium-sized businesses within the framework of the Anti-Corruption Collective Action initiative;

- online public presentation of the results of the Public Monitoring of certain aspects of the work of Ukrainian customs (June 16, 2021);

- general meeting of participants of the Public Initiative "For Fair and Transparent Customs" (July 29, 2021);

- online seminar "New criteria for sustainable public procurement (SPP) and ecolabeling standards" (October 12, 2021);

# Part III.

Some of the practical results of the Union activities:
