## COMMUNICATION ON ENGAGEMENT Statement by the President of the International Emergency Management Organization

Since the IEMO Executive Committee agreed to provide every two years the Communication On Engagement (COE) "expressing continued support for the Global Compact and renewing the participant's ongoing commitment to the initiative and its principles" committing the Organization to provide to its Members relevant information on the various modalities of support to the Global Compact in specific areas, identified for its specific organizational type (Public Sector Organization)

For the period ending 2023 The IEMO Executive Committee has updated to report on the following three areas with a measurement of results :

- 1) Join and/or propose partnership projects
- 2) Internalize the Global Compact principles and engage compa

## 1- Join and/or propose partnership projects

Following the IEMO tradition, as far as the main point of "Join and/or propose partnership projects", in the spirit of adherence and commitment to the UNGC 10 principles, the IEMO has chosen to support to a number of project together with the Italian "Conferenza dei Presidenti (Conference of Presidents of Envronmenta Organizatons) focused on *Principle 8*: undertake initiatives to promote greater environmental responsibility and as far as *Principle 9* is concerned: encourage the development and diffusion of environmentally friendly technologies.

This is a hghest priority for IEMO:. In particular it has been established to give highest relevance to the sensitization of Associatons and civil networks by sensitizing them to the fundamental role of environmental responsibility. Qualitative measurement of results: a growing number of Associations as well as Public Entities as Municipalities and Provinces are now aware of the UNGC 10 Principles as a guideline for choosing environmentally–friendly projects and several organizations of public sector and civil society are following with more attention the environmental issue.

## 2) Internalize the Global Compact principles and engage companies

The IEMO Executive Committee has since almost a decade determined to internalize the Global Compact Principles and to engage companies to diligently follow and comply to the 10 principles. In particular, as a Public Sector Organization, IEMO has begun a formal sensitization campaign of more than 3r Italian companies and Associations on the utility to adhere to the GC 10 Principles. Qualitative measurement of results: a growing number of companies cooperating with the IEMO, including private sector as well as public entities would like to approach the Global Compact and eventually to apply for participation in the Global compact, by adhering to the 10 principles and to the SGDs, at Large.

We are proud to support the adoptoon of the 10 UNGC Principles worldwide.

Please be assured that we consider the Global Compact as our common home and its 10 Principles and the SDGs as its leading guidance for all our IEMO choices.
