Biennial Report 2020-23

Charushila (registered charity no 1163253) is an organisation working with youth and children in realising creative projects within the community. It works internationally and in the UK. Charushila is a signatory to the UN Global compact and produces a publicly available Communication Of Engagement, COE, for this purpose every two years. Charushila has no employees or shareholders.

Due to Covid 19 lockdown from 23 March 2020 onwards and illnesses, we were unable to meet face to face or to carry out work in 2020-21. However, we managed to meet online, and onsite with trustees, volunteers, and others. Our trustees attended various webinars on charity finance, fraud prevention and working overseas. We submitted the Communication on Engagement (CoE) for the UN Global Compact to which we are a signatory in 2021. Our founding trustee, Sumita Singha, was recognised in the Queen birthday honours in 2021 with an OBE.

We have been involved in looking at further work in Phase II of the Energy Gardens at Acton Central station, which will involve water harvesting, solar power, and gardening sessions in conjunction with Energy Gardens and station staff. We have applied for further funding for these with a local funding partner. We now have an active group of volunteers working at the Acton Central station garden. The inclement weather during 2023 has meant that the upkeep of plants has been difficult, but the volunteers have done a great job. The project has been visited by researchers on inclusive design and biodiversity.

Catchik Jordan was appointed as a trustee in December 2022 when Nicole became too ill to carry on. He is the youngest ever trustee of Charushila- he has worked with Energy Garden London, one of our partners, and received qualifications for his work. We also have three new advisors on our Board to help direct our work, advise on governance and help to publicise our work.
