All India Management Association (AIMA) is an as apex body of the management profession which was created with active support of the Government of India and Industry in 1957. The association is registered under the Societies Registration Act XXI 1860 as a non-profit organization. Over the last six decades, AIMA has contributed immensely to enhance the management capabilities in the country. AIMA has a broad base of 68 Local Management Associations including two cooperating LMAs abroad, with a membership crossing 38,000 in number. AIMA is a non-lobbying organization, working closely with Industry, Government, Academia, and students to further the cause of the management profession in India. Under its ageis AIMA takes numbers of initiatives in the area of Education, Skill Development Training, Workshops, development of underprivileged students and other related areas to strengthen the country's management resource pool.

Projects Undertaken by AIMA

AIMA in Skill Development & Professional Training:

AIMA offers several training and skills development programme through its specialized pool of resources, not only high-level capacity building and training programs to PSU's, government organizations and big corporate houses, AIMA also offers training to the weaker section of the society through Government funded projects. From last 10 years AIMA is actively involved and has made concerted efforts to provide the Skill development Training to the weaker section of the society to ensure their growth and self-sustenance in the society.



The efforts are being made to impart outcome-based skill training to the individuals and create job opportunities for them. The focus is being given to women empowerment and entrepreneurship as well.

AIMA as a national apex body has also aligned its activities with the vision of Government of India and to promote the schemes like Skill India and Start-up India.

For the period of year 2022-23, AIMA has conducted several capacity development workshops and training progarmmes to harness the capabilities of managers and also organized skill trainings to the youth for their employment generation. The workshops and training programmes were organized on a wide range of topics like Advances in Research Methods and Data Analytics, Cyber Security and ethical hacking, Role of branding in enhancing competitive growth for MSMEs', apart from these contemporary topics, AIMA has also conducted workshops on fundamental management topics like Behavioral Skills, Employability Skills, Presentation Skills, Basic IT Skills etc.

Currently a Skill Development Project under "Recognition of Prior Learning (RPL)" funded by the Ministry of Skill Development and Entrepreneurship, Government of India is going on. Under this project, AIMA is training the on-the-job Office Executives for the next NSQF level.

Women Speak Programme

AIMA Aspire, AIMA's exclusive women's forum, hosted a series of inspiring WomenSpeak sessions, featuring accomplished women achievers and leaders from various fields. These sessions provided a platform for sharing insights, opinions, and experiences on crucial themes. The WomenSpeak sessions covered many useful topics viz. All WomenSpeak sessions garnered an overwhelming response, with close to 700 enthusiastic participants joining each session via Zoom and actively engaging across all AIMA social media platforms. These sessions provided invaluable insights spanning diverse themes, effectively broadening horizons, and inspiring participants by presenting unique viewpoints from various professions.
