#### **STATEMENT BY CHAIRWOMAN**



Reaching the middle of the time we have still available to meet our Sustainable Development Goals 2030 to safeguard our common future, there are new challenges to be considered in each and every continent, country and community.

We have continued and strengthened our efforts to promote the UN Global Compact Principles as a framework for business and particularly SMEs that commit voluntarily to embed corporate

social responsibility and sustainability in their business model. It is for this reason, CSR Hellas developed and launched the National Pact for Sustainable Industry that relates large companies and SMEs in a 3 year-long partnership to work together on specific topics, such as human rights and climate change, corporate governance and sustainability due diligence, which have been identified as relevant and material for the Greek market and keys stakeholders. We have also contributed to the development of pan-European initiative to enable social dialogue for a just transition and collaborated closely with other UNGC Networks, as for example UNGC Bulgaria, sent a letter to the European Commission underlining the importance of measures within E.U and beyond.

In 2022, together with UNGC Network Hellas and the Federation of Greek Industries, contributed to the Greek VNR 2022 (https://www.statistics.gr/documents/20181/13491320/VNR+2022+Greece+Report.pdf/d0b97502-84b4-866f-e32e-2d91dff2538) and continued the implementation of our flagship program with Greek Universities dedicated to the SDGs 2030. The current period, there were two specific SDGs that we have focused, SDG 13 and SDG 17. Looking ahead, we remain committed and focused on two significant priorities, enabling companies to address material issues and taking action to meet SDGs 2030.

#### **CSR Europe**



CSR HELLAS, an active National Partner of CSR Europe, holds the position of Vice Chair of the BoD of CSR Europe. The collaboration of the two organizations aims at shaping the new European Sustainability agenda and informing Greek companies about the new strategy of CSR Europe and the SDGs-related

developments at the EU level. In 2022, CSR HELLAS took an active part in the European Sustainable Development Goals Summit (European SDG Summit), organized by CSR Europe in cooperation with its National Partner Organizations (NPOs). CSR HELLAS co-organized a Roundtable Discussion "Support SMEs for sustainability alignment" (relevant topic to SDG12 and SDG 17) in collaboration with the NPOs from Germany (UPJ and Econsence) and Portugal (Grace). CSR HELLAS also participated and contributed to the Roundtable entitled "Education for Sustainability" (relevant topic to SDG 4).

#### University of Crete & the American College of Greece

In 2022 and 2023, CSR HELLAS collaborated with the University of Crete and ALBA Graduate School, The American College of Greece for the organization of two inspiring virtual Executive Education Programs on Corporate Sustainability and



Responsibility. The CSR School 2022 took place between 30 September-9 December 2022, while the CSR-School 2023 will take place between 13 November – 11 December 2023. The CSR-School aims to provide advanced training regarding the identification of sustainability-related business opportunities and the inclusion of responsibility in the core of one's business strategy,



in order to achieve sustainable value and shape a more resilient organization. Putting the SDGs at the core of the business strategy and fully benefiting from the relevant efficiency gains of corporate responsibility requires a drastic rethinking regarding the identification of business opportunities and business management. Participants in the Program have the opportunity to attend lectures from distinguished academic faculty members, discuss case studies presented by experienced senior professionals and interact with other professionals working in the field of CSR. Businesses, nowadays, are looking for sustainability specialists instead of sustainability generalists. In order to disseminate and extend the knowledge regarding the effective approaches and challenges in meeting social and environmental responsibilities, CSR-School promotes interaction among current and future professionals, researchers and faculty members related to corporate social responsibility and the SDGs. This objective was in line with the fourth, the fifth and the sixth UN Principle for Responsible Management Education.

NPOs had the opportunity to present their work and actions and the contributors (Charitable Foundations, Corporations and Embassies) their strategy, discussing potential partnerships which can help address social inequalities and the needs of vulnerable groups, in 8 categories: Human Rights, Education, Welfare, Economic Development, Environment, Culture, Health & Third Age.

# Research: "Inclusion and Equal Opportunities in the workplace with the gender dimension"

CSR HELLAS, having set SDG #5 (Gender Equality) as a strategic goal, carried out a research study entitled "Inclusion and equal opportunities in the workplace with the gender dimension" in collaboration with a group of experts from the field of HR and the academic community. The purpose of the research was to map and evaluate the level of maturity in the issues of inclusion and equal opportunities in the principles and practices of Greek businesses at the end of 2021, focusing specifically on the gender dimension. The results and conclusions of the research were discussed in the first episode of the CSR Lab Podcast in March 2022 on the topic "Gender Equality and Business: Yes...but".

#### Voluntary National Review 2022 (VNR)

In 2022, CSR HELLAS contributed to the submission of the voluntary national review



focusing on the performance of Greece in the implementation of the SDGs. In this context, CSR HELLAS conducted secondary research to determine the actual presence or absence of SDGs implementation inside the process of value creation for businesses as an integral part of their practices about corporate disclosure. Moreover, CSR HELLAS, in partnership with the University of the Aegean, carried out a study about the adoption of international

reporting standards, one of which are the SDGs, by companies listed in ATHEX.

# **Eco-fashion EU project in partnership with Athens Chamber of Small & Medium Industries**

In co-operation with the Athens Chamber of Small & Medium Industries and in response to the European Commission proposal, CSR HELLAS implements as of



2022, a project for the enhancement of the maturity level of SMEs in the fashion sector. The project aims to reduce the negative impact of the textile and fashion sector by promoting a zero-waste approach and sustainable production models for SMEs in the sector, to support the competitiveness of SMEs in the textile and fashion sector and to raise public awareness of

the impact of current practices in the industry and the need for more conscious



consumption patterns.

implemented a research study on leadership and Corporate Social Responsibility. The research was conducted during 2022-2023, approaching three large target groups, that is, the leadership of companies, their employees and the general public.

#### **Hellenic Pact for Sustainable Industry**

The Hellenic Pact for Sustainable Industry was launched in 2023 aiming to offer a

roadmap towards a sustainable business model to Greek companies regardless of size or sector and SMEs. According to the program structure, the 16 signatory

companies participate in monthly "CSR Ateliers", that is, interactive, educational workshops that focus on different topics such as materiality assessment, supply chain due diligence, ESG ratings, human rights, etc. In its next steps, the participating companies will apply Materiality Assessment Tools and engage their suppliers and clients, as well as sectoral bodies, in order to increase the reach on a larger scale and across the value chains of companies. This first cycle is scheduled to last 3 years in total, from 2023-2025, while a second cycle is being planned to begin in 2024.

#### 8th Student Competition for CSR "Nikos Analytis"



In 2023, CSR HELLAS organized the 8th cycle of the Student Competition for CSR "Nikos Analytis" under the auspices of the European Parliament Liaison Office in Greece. The topic of the competition is "How can business contribute to preventing and addressing material



sustainability issues at national level? Where should they focus? Which material issues do they affect? How will they effectively engage with each other and with other stakeholders and interested parties?

- 1. Employment/Working Conditions
- 2. Poverty/Human Rights
- 3. Climate Change
- 4. Production/Consumption

The competition's subject, focuses on SDG 17, which is a prerequisite for achieving all other goals by 2030, as it involves the partnership (consultation and cooperation) of all stakeholders at global, regional, national and local levels.

#### 7th Student Competition for CSR "Nikos Analytis"

In 2022, CSR HELLAS organized the 7th cycle of the Student Competition for CSR "Nikos Analytis" to foster partnership between businesses, the academic and the student community. The competition's subject focused on SDG#13 on climate action, given that climate change is undeniably an urgent threat to our planet and its impact on the achievement of the other goals is critical.



Each candidate had to analyze their views choosing 1 out of the 4 following topics:

1. What specific policies can be implemented to prevent the adverse social consequences of climate change in the

agricultural sector? What changes would you suggest to be implemented in the agri-food sector to reduce the impact of climate change on the production and consumption of certain products and foods, while minimizing any negative effects on local populations working in the sector?

- 2. In the context of the European Green Deal, Greece will become climate neutral by 2050 at the latest, meaning that emissions from sources and absorptions from sinks of greenhouse gases will be balanced by 2050 at the latest. this is why the energy transition of Greece to clean energy sources is necessary, and the final date for the de-ligniteization of the country's energy mix is set as December 31, 2028. What social effects will the achievement of the above goals have on the local lignite energy production societies and which policies can support a just social transition in the post-lignite era? How can businesses, as well as interested parties at the local level, contribute to minimizing the negative effects of this transition and reducing structural unemployment?
- 3. Tourism is a professional activity for a significant percentage of the country's population, and consequently contributes to the (balanced) economic development



of Greece. How climate change might affect the tourism industry (accommodation, convention, catering, transport, etc.), especially in small island regions that are heavily dependent on tourism, and how businesses and stakeholders can contribute in climate change adaptation and mitigation?

4.Climate change adaptation and mitigation lead to the development and emergence of new professions. New professions also entail new skills, both for new entrants to the labor market and for existing professionals. What is the role of education in developing new skills and cultivating the necessary qualifications required by emerging professions? How can the Greek education system support the labor market and face the effects of the climate crisis in the labor sector?

Also the candidates were asked to design a poster summarizing the conclusions and recommendations of the submitted paper.
