- Governance: We have established a committee that oversees our sustainability strategy and
 activities. The committee consists of the Chairperson and three Board Members and meets
 once in a month to review our progress and challenges. We have also adopted a small
 business good governance code of conduct that guides our members and staff on ethical
 and responsible business practices. The policy is aligned with the UN Global Compact
 principles and is communicated to all our stakeholders.
- Human Rights: We respect and promote human rights within the MSME sector around the
 globe. We have conducted an informal economy survey to identify and address the potential
 human rights risks and impacts on the MSME sector. We have also developed a training or
 awareness program to educate our members and staff on human rights issues and best
 practices. We have also participated in several national, regional, and international events
 to advocate for human rights in our sector and beyond.
- **Labour**: We uphold and advance labour rights and standards within the MSME sector around the globe. We have implemented a global certification system to ensure that our members and affiliates comply with the relevant labour laws and regulations. We have also launched an awareness program to support the well-being and development of the employees and

- workers in the MSME sector. We are also planning to collaborate with other stakeholders or coalitions or networks on improving labour conditions in MSME sector and beyond.
- **Environment**: We protect and enhance the environment within the MSME sector around the world. We have adopted a strategy or plan to reduce our environmental footprint and increase our resource efficiency. We have also implemented a mass awareness program to promote environmental innovation and solutions among our members and affiliates. We have also supported several campaigns and actions to raise awareness and mobilize action on environmental issues in the MSME sector and beyond.
- Anti-Corruption: We prevent and combat corruption within the MSME sector around the
 globe. We have established a mechanism or system to monitor and report any incidents or
 allegations of corruption. We have also provided training as well as tools to equip our
 members, affiliates, and staff with the knowledge and skills to prevent and address
 corruption. We have also engaged in a number of dialogues and partnerships to foster a
 culture of integrity and transparency in the MSME sector and beyond.

We are proud of our achievements and contributions, but we also recognize that we have more work to do. We are committed to continuous improvement and learning, and we welcome any feedback or guidance from the UN Global Compact and its network.

We look forward to our continued engagement with the UN Global Compact and its participants. We appreciate the opportunity to share our COE with you and we hope that it will inspire other industry associations and non-business participants to join and support the UN Global Compact.
