We link these businesses with technical partners and with funders and financers mostly in OECD countries. We provide a carbon finance Programme of Activities (PoA) for eligible businesses.

We champion Global Compact values and the SDGs. Our main focus is on energy access, low carbon fuels, and climate mitigation activities.

We volunteer for sector-enhancing initiatives, such as the Safe Fuel and Energy (SAFE), ISO and ASTM standards setting, Roundtable on Sustainable Biomaterials (RSB), Global Bioenergy Partnership (GBEP), regional trade associations, etc. We presented in 2023 at the GBEP biennial forum in Bangkok, the International Vienna Energy and Climate Forum in Vienna, and the COP28 in the U.A.E.
