

The Outreach Social Care Project contribution to implementing the objectives of the United Nations Global Compact will continue engaging, collaborating and partnering with different stakeholders globally (Global South and Global North), sharing knowledge, expertise and resources to meet our commitment to the 2030 Agenda.

The Outreach Social Care Project has:

- increased public awareness of the Sustainable Development Goals
- supported new partnerships to advance action on environment emergency;
- identified and implemented innovative initiatives to drive progress on the Sustainable Development Goals.

The Outreach Social Care Project has focused on these priorities: SDG 1 (No Poverty), SDG 2 (Zero Hunger), SDG 3 (Good Health and Well-being) SDG 4 (Quality Education), SDG 5 (Gender Equality), SDG 13 (Climate Action), and SDG 17 (Partnerships for the Goals). We believe that Black, migrants, refugees, asylum seekers and 2SLGBTIQ+ community have been historically left behind.

The Outreach Social Care Project has implemented Sustainable Development Goal 3: (Good Health and Well-being) with over 100 Black young people attended our initiative on mental health and subsistence use support through sport and physical activities, raising awareness and support of the 2030 Agenda by addressing inclusion, diversity, equity, access and belonging. Advancing women's leadership and gender equity are critical to delivering the United Nations Sustainable Development Goals by 2030.

The challenges that grass-roots not for profit organizations are facing today are accessing equitable funding, resources and capacity building so that they can eradicate extreme poverty in all its forms, end discrimination and exclusion, and reduce the inequalities and vulnerabilities that leave people behind and undermine the potential of individuals and of humanity as a whole.

To achieve the Sustainable Development Goals by 2030, we need forward thinkers, doers, builders, changers, movers, leaders to engage and collaborate with the Government, the United Nations agencies and all the stakeholders that advancing the 2030 Agenda. Poverty, living costs, housing, mental health and substance use is a huge challenge in South Africa, barriers to sustainable employment, access to clear water among the populations living a rural and remote areas, disproportionately impact Black young people, Indigenous Peoples, disable people and People of Colour.

Fostering and integrating UBUNTU (togetherness) spirit, cultural informed and Indigenous knowledge into all approaches and efforts to achieving the 2030 Agenda. Encourage the language of choice when implementing initiative with Black population and Indigenous community.
