The actions HELB has taken in supporting the Global Compact aspirations and principles include the following:

- The HELB Board and CEO issue annual statements on sustainability, governance reporting, risks related to the business mode. This is done through the HELB annual financial reports.
- 2. The HELB strategic plan has commitments related to Global Compact topics such as human rights, labor rights, environment, and anti-corruption.
- 3. HELB has a code of conduct in place relating to the Global Compact topics.
- 4. HELB has established committees tasked with implementing the sustainability topics, these include the following; Sustainability, Disability Mainstreaming, Gender Mainstreaming, Alcohol & Drug Abuse, Corruption Prevention, Guidance & Counselling
- 5. The organization has risk management measures to address Global Compact topics, through departmental risk register and the Human Resources policy.
- 6. HELB has instituted processes through which the employees can raise concerns about the organization's conduct related to the Global Compact topics. These include disciplinary processes, CEO's roundtable staff engagements, departmental retreats, end year staff engagement forums, staff welfare committee, and stakeholders' consultative forums.

HELB has achieved the following outcomes from the initiatives outlines in Part II above.

- HELB has planted a total of 12,627 trees within the reporting period. This have been
 planted in various high schools and individual staff homes to increase the survival rate
 of the trees.
- HELB has partnered with two organizations, i.e., Kenya Universities and Colleges Central Placement Service (KUCCPS) and Kenya National Qualification Authority (KNQA) in the tree planting initiatives.
- HELB has released four reports relating to sustainability, i.e., Implementation of Presidential Directive on Tree Growing, Status Report on the Implementation of the United Nations General Assembly 2023 Resolutions, HELB FY 2021/2022 Audited Financial Report & HELB Sustainability Report.
- HELB undertook one training by UN Global Compact on the UN Global Compact Principles and SDG Integration for the Sustainability Committee. This was done in February 2023.
